920517 A Resolution Requesting More WEPA Kiosks (Thompson) (Do pass- P&P)

**Nguyen sec Searcey**

Thompson: This is a resolution dealing WEPA. Our last resolution increased awareness, but this resolution is designed to encourage using WEPA to its full extent. We have found that there is a general misunderstanding of WEPA. So we are going to ask for free WEPA kiosks to go into all education buildings on campus. This will ultimately save the university money. The current printing costs are covered by OU IT, and they are running out of money, so we are selecting WEPA to decrease costs to the university. By adding more, we will increase availability to students and will help with the transition to a more economically viable option.

Rowell: Do you know how many WEPA kiosks there currently are?

Thompson: There are some in nine buildings on campus currently.

Aragon: You mention that the student body has expressed concern about not enough, who said that?

Thompson: We had a member express concern about how few there were, and how she didn't want to use them because they were not in her class buildings.

Aragon: You are assuming the whole student body feels this way because of a few people?

Thompson: I think this concern is widespread and this will allow for more accessibility.

Bourland: Would you accept a friendly amendment changing "the conclusion of the University of Oklahoma Winter Break" in Section 3 to "the end of May?"

Thompson: I accept.

#### **Bourland sec Rao**

#### **Nguyen sec Pae**

No time limits based on emergency legislation because all legislation is important. Moved hostile amendments and author's summation to clarify how we actually run our meeting in the legislation section.

Nguyen: When was the last time these were amended?

Aragon: No idea.

Sample: Last version included 1990 Robert's Rules of Order, which we updated to use the 2000 edition of Robert's Rules of Order.

Byron: Where are the Standing Rules accessible?

Aragon: Under resources on the Undergraduate Student Congress Website.

##### **920317 Signatory Update Act of 2014 (Bourland) (No Rec-ConAd)**

#### **Pae sec Nguyen**

Bourland: Decided to try to order food for today, I get the purchase order and can't sign for it! So I amended the code to allow for Vice Chairs to sign and expend funds. We couldn't pay for anything without a Chair signature. This authorizes the Vice Chairs of Congress, GSS, and the Vice President to sign only for the general fund. I can then sign and spend that money. I spoke to Carrie, Alex, Kunal, and all are on board. I can't go crazy; George has to sign for it too. He can be skeptical and question me and refuse to sign. It makes things easier in case the Chairs or President isn't present. This goes to all the other branches.

Crisp: What qualifies for the general fund?

### **Consent w/o objection**

##### **920520 A Resolution requesting that the College of Engineering offer Biomedical Engineering (Rowell) (Do Pass- P&P)**

#### **Nguyen sec Skelton**

Rowell: This legislation asks to send a letter to Boren requesting that Biomedical Engineering as an undergraduate degree. We already have Master's and PhD programs.

Byron: Have you been working behind the scenes?

Rowell: Boren has a six year plan, and it is in the works by the faculty. However, there has been no student led initiative up to this point. That is what this letter is.

Bourland: Your letter says University of Oklahoma College of Engineering. Have you appropriately canvassed the whole college to include them?

Rowell: I have spoken with engineering students, representatives, and Dean Landers.

Searcey: All our representatives agree.

Bourland: Would you be open to changing it to include all representatives in this body instead of the whole college?

Rowell: What would it read?

Bourland: Instead of being signed by the University of Oklahoma College of Engineering it would read "Engineering Representatives, Student Government Association Undergraduate Student Congress."

Rowell: Yes.

Nguyen: This includes professors of the College of Engineering, and we have canvassed organizations such as the Dean's Leadership Counsel to gauge support. We have canvassed.

Morgan: The buildings they plan to build would be solely for this program?

Rowell: The little faculty lot next to Sarkey's will be a building for all engineering labs. A parking garage will be added to replace the parking lost to the addition of this lot.

Morgan: Where would those classes be?

Rowell: It would be here instead of at south campus.

Aragon: Any particular reason why you address Molly Shi Boren as well?

Rowell: No particular reason.

Skelton: Will this add more courses?

Rowell: This will add more faculty and coursework. Four professors are currently working on this. One is the head of Biomedical Engineering under CBME, this would also add a few courses to differentiate between Chemical Engineering, which is what these undergraduates currently take. Ten faculty members will eventually be added.

920602 Fall 2014 Special Elections Act (Petersen) (No Rec- Exec)

### **Hill sec Byron**

Petersen: The University College voting list was incomplete, preventing some students from voting. We think is unfair and will instead hold a Special Election on November 18<sup>th</sup>. We have the correct voter list.

Byron: How do you plan to publicize?

Petersen: We have informed all running candidates, and it is their duty to campaign.

Thompson: Who was excluded from voting before?

Petersen: It was a long list.

Aragon: Have the other elections been verified by Superior Court yet?

Petersen: Not yet.

Byron: Has the list been updated to include those who could not vote before?

Petersen: The list has been fixed.

920707 Emergency Allocation #5 (Cramm) (Do pass-WAM)

### **Skelton sec Byron**

Park: For emergency allocation #5, we interviewed two RSOs. The Community Emergency Response Team attends games and functions to make sure everyone is safe, and we allocated them about \$150. We allocated \$250 for PEA for Architectural Virtuosi, which helps with getting architects licensed. This is solely for registration fees.

McKenzie: Scrivener's error #4 instead of #5.

Byron: The leadership of the Community Emergency Response Team is heavily involved in Congress. How did we guarantee that they did not influence the allocation?

Cramm: Because of my involvement, I was not part of the interview. Kaylee Rains, our Vice Chair was in charge of that interview and meeting, while I was outside.

920708 Emergency Allocation #6 (Cramm) (Do pass-WAM)

**Byron sec Droege**

Cramm: This is emergency funding for SBA. They did not receive subsidiary; they are a government organization. They represent the whole law school, which is a lot of people. Hence the large sum.

Bourland: Is this the first time SBA has messed up?

Cramm: No, they did last year too.

Bourland: Do you believe it is appropriate to fund an organization that doesn't follow the rules?

Cramm: Yes, this is a different mistake than before, and I will thoroughly explain the appropriate procedure for all government organizations in the future.

Bourland: Is this like a mother rewarding her child for not stealing but lying instead?

Cramm: This was a mistake over the rules. Our duty is to fund student organizations, not punish them. The SBA is the only organization that had a valid excuse.

Bourland: So are there others who did not receive subsidiary funding?

Cramm: Yes, and all went through the appeals process and were offered the opportunity to get funding. We ultimately decided not to fund the others.

Byron: To what extent did leadership impact this decision?

Cramm: Very little.

Searcey: Did they give you a list for the office expenses?

Cramm: Scrivener's error. Office expense should be PEA expense.

Searcey: How much did they ask for this year, and how much were they awarded last year?

Cramm: Over \$37,000. Last year they received in this same process \$4,000.

Byron: Scrivener's error title.

AS INTRODUCED

An act amending Title XII of the SGACA, providing for a short title;  
providing for codification; and providing an effective date.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT  
ASSOCIATION:

**Section 1:** This act shall be known and may be cited as the “Fixing Salary Terms Act of 2014”

**Section 2:** The purpose of this act is to amend the terms of SGA Salary/Stipend Positions to reflect current elections.

**Section 3:** AMENDATORY. The following parts are to be amended to Title XII Chapter 5 the SGACA:

**Title XII – Finance**

**Chapter 5- Salaries and Stipends**

**31. Positions Receiving a Salary/Stipend**

Section 1: The following positions shall receive a stipend:

- Campus Activities Council Chair: \$365/month
- Chair of Congress: \$365/month
- Chair of Senate: \$365/month
- Chair of SGA Budgetary Committee: \$265/month
- Secretary of Congress: \$215/month
- Secretary of Senate: \$215/month
- Student Bar Association President: \$290/month
- SGA President: \$450/month
- SGA Vice President: \$365/month
- Vice Chair of Congress: \$265/month
- Vice Chair of Senate: \$265/month

Campus Activities Council Chair, Chair of Congress, Chair of Senate, Secretary of Congress, Secretary of Senate, Student Bar Association President, Vice Chair of Congress, and Vice Chair of Senate shall be compensated monthly with compensation periods beginning August 1<sup>st</sup> and perpetuating monthly until April 30<sup>th</sup>. The SGA President and SGA Vice President shall be compensated monthly with compensation periods beginning December 1<sup>st</sup> and perpetuating monthly until November 30<sup>st</sup>. The Chair of SGA Budgetary Committee shall be compensated monthly with compensation periods beginning the month of their appointment by the SGA Congress and ending

~~April 30<sup>th</sup>. All salaried and stipend positions listed within this section, Section 32, shall be compensated monthly with compensation periods beginning September 1<sup>st</sup> and perpetuating monthly until April 30<sup>th</sup> of the same academic year except for the positions of SGA President, SGA Vice President, Chair of Congress, Chair of Senate, Campus Activities Council Chair, and Housing Center Student Association President, which shall terminate employment and compensation May 31<sup>st</sup> of the same academic year.~~ The SGA President shall be eligible to receive compensation at the aforementioned rate during the summer, which shall consist of the months June, July, and August. The SGA President shall only be eligible to receive such compensation while executing his/her presidential duties in the course of fulfilling his/her office hours.

**Section 8.** This act will become effective at the start of SGA Undergraduate Student Congress Session 94, once passed in accordance with the SGA Constitution.

A Resolution requesting the installation of WEPA printing kiosks in all buildings on campus; and providing for their distribution.

- Whereas: There is a limited distribution of WEPA printing kiosks on the OU Norman campus;
- Whereas: The university intends to transition away from traditional printing towards full use of WEPA printing kiosks; and
- Whereas: The student body has expressed concerns relating to the availability of kiosks and adaptation of kiosks has been slow; and
- Whereas: The installation of said kiosks would allow the University of Oklahoma to save money on traditional printing and eventually allow the OU IT Department to allocate resources towards other on-campus improvements; and
- Whereas: The renting of additional kiosks comes at no additional cost to the university, per unit or otherwise.

NOW, THEREFORE, BE IT RESOLVED BY THE UNDERGRADUATE STUDENT CONGRESS THAT:

- Section 1:** The Undergraduate Student Congress recommends the immediate request and installation of WEPA printing kiosks in all buildings where students have classes on the OU Norman campus where a kiosk is not currently present. We also recommend an additional kiosk in the Oklahoma Memorial Union Food Court.
- Section 2:** The location of said kiosks will be placed at the discretion of the University of Oklahoma Office of Facilities Management and the OU IT Department.
- Section 3:** These units should be rented and installed no later than the conclusion of the University of Oklahoma Winter Break, if possible.

Dear President and Mrs. Molly Shi Boren:

As students at the University of Oklahoma, we come here to learn the skills and gain the education needed to qualify us for our chosen career path. We do this by focusing on a major and course plan that will efficiently teach us what we need to know and prepare us for our careers and challenges ahead. As students of the University of Oklahoma, we have a desire to learn and follow a degree plan that leads us to our desired careers in the best path possible. We believe that our university is sorely lacking in a major option that would greatly benefit and satisfy the needs of many individuals interested in the coursework. We, the students, ask that the University of Oklahoma consider adding Biomedical Engineering as a Bachelor of Science degree option and course plan endorsed by the College of Engineering.

After doing some research about Biomedical Engineering and coursework like it, we have found that OU does offer Chemical Engineering: Biomedical which is indeed similar. The downfall to this option is that it requires students to take courses specified to Chemical Engineering and upon graduation these students have more of a Chemical Engineering education rather than a Biomedical based education. While this option satisfies most graduate level programs and medical schools, it does not offer the type of education the University of Oklahoma has to offer to all other majors. It has been found that similar universities such as Berkley, Georgia Tech, and both Harvard and Yale offer Biomedical Engineering as a Bachelor of Science degree. To be competitive, it is imperative that The University of Oklahoma consider this task.

Biomedical Engineering is one of the forefront majors in engineering. It incorporates traditional engineering concepts such as problem solving and advanced technology with the application and innovation of medical and biological research and advancement. It is a degree of course work that many students would take advantage of and find great success in this path. Upon speaking with various faculty members involved with the idea of creating this new degree plan, we have come to understand that adding Biomedical Engineering as a Bachelor of Science is a project in the works and should be available in 2017. We are urging you to consider implementing this program sooner. However, we understand the limits that may contain and request that advertisement of this new addition be started at the earliest convenience so as not lose the interest of current and future students.

All the engineers and Student Congress hope that you are able to understand our perspective that Biomedical Engineering Bachelor of Science would greatly improve the university experience and educational options for our future Sooners and their families. Thank you for your time and consideration.

CONGRESSIONAL BILL NO. 920602

AS INTRODUCED

An act establishing a Special Election for Fall 2014; providing for codification;  
providing for a short title; and providing for an effective date.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT  
ASSOCIATION:

**Section 1:** TITLE. This act may be known and shall be cited as the “Fall 2014 Special Election” Act

**Section 2:** PURPOSE. To designate polling locations and to establish regulations for the Fall 2014 Special Election of  
the University College Districts (Special Election).

**Section 3:** In accordance with Title VII, Chapter 1, Section 12 of the SGACA, “*The number and location of polling places shall be established by an Act of the Legislative Branch,*” the following polling locations are established for the Fall 2014 Special Election:

- All University Computer Labs

**Section 4:** In accordance with Title VII, Chapter 2, Section 9 of the SGACA, “*Any deadline within this Title may be implicitly suspended by an act or a joint resolution by a 2/3 vote of each House of the Legislative Branch.*” the date for the Fall 2014 Special Election is established as November 18<sup>th</sup>, 2014 between the hours of nine (9) in the morning until six (6) in the afternoon.

**Section 5:** In accordance with Title VII, Chapter 2, Section 9 of the SGACA, “*Any deadline within this Title may be implicitly suspended by an act or a joint resolution by a 2/3 vote of each House of the Legislative Branch.*” all complaints of campaign rules infractions shall be submitted in writing to the Election Board within one hour of the close of polls. The Election Board shall make a ruling in a timely manner. All Appeals of Rulings must be submitted in writing to the SGA Office within one hour of the release of the ruling.

**Section 6:** In accordance with Title VII, Chapter 2, Section 9 of the SGACA, “*Any deadline within this Title may be implicitly suspended by an act or a joint resolution by a 2/3 vote of each House of the Legislative Branch.*” the Election Board shall meet within two hours of the close of polls to certify the unofficial election results. The Election Chair shall also prepare an Official Report within three hours of the close of polls, adhering to the other regulations set forth in Title VII, Chapter 4, Section 31 of the SGACA.



**Section 7:** In accordance with Title VII, Chapter 2, Section 9 of the SGACA, *“Any deadline within this Title may be implicitly suspended by an act or a joint resolution by a 2/3 vote of each House of the Legislative Branch.”* the Superior Court shall meet within four (4) hours of the close of polls to consider the validation of the Election. All other regulations pertaining to Title VII, Chapter 4, Section 33 shall remain in effect.

**Section 8:** This act shall become effective, while in accordance with the SGACA, immediately following passage and approval.
