If you were just elected this past weekend, you will have to file to keep your seat, if you were just appointed an associate you can also run for the representative seat. I will send emails with whether you need to file and what seats are available. I know its confusing but democracy and elections.

Mazietis: How do we go about doing that?

Sample: Once filing opens, you will go to OrgSync

Mazietis: Can you only file for one district?

Sample: Yes must select which seat you would want to run for. If you were a double major you would get to choose which district to file for.

Nguyen: When asking another question, is it best to use Follow Up

Mazietis: What is the last day you will evaluate the number of seats open in certain districts?

Sample: Before filing opens so the 21st. However, if there is a seat already open for election and filing, we were to expel someone or they resign then an additional seat would be on the ballot. For UCol, there will be open seats, if someone resigns in UCol right now, since already 4 seats available I could then open 5, so you are running for any of one of 4 seats. Once filing form opens you can open it on OrgSync, Campus Elections page, the filing form and you do have to be in good standing.

CONGRESSIONAL BILL NO. 950107

AS INTRODUCED

An act amending Rule 4 of the Undergraduate Student Congress Standing Rules of Order, providing for a short title; providing for codification; and providing an effective date.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT ASSOCIATION

- Section 1: This act shall be known and may be cited as the "Quorum Clarification Act of 2016"
- **Section 2:** The purpose of this act is to clarify the relationship between ex-officio members and the method by which committees determine quorum.
- **Section 3:** For the purposes of this legislation, deletions shall be marked with a **Strikethrough**. Additions shall be marked with an **Underline**.
- **Section 4:** AMENDATORY. The following parts are to be amended to Rule 4 of the Undergraduate Student Congress Standing Rules of Order:

RULE 4: General Procedures

Section 1. Quorum

A. If at any time during a meeting, a question shall be raised by any member as to the presence of a quorum, the Presiding Officer shall, without debate, forthwith direct the

secretary to determine the presence or absence of a quorum, and shall announce the result.

B. Whenever it is ascertained that a quorum is not present, the members present may, by

motion adopted by a majority of those voting, direct the Vice-Chair to contact

absent

members and request their presence.

C. Until a quorum is present, only debate and procedural motions may be conducted. Main motions are out of order.

D. If, in accordance with the Undergraduate Student Congress Bylaws, an officer of the Congress serves as an ex-officio member of a Committee, except for the Student Congress Secretary's position in the Congressional Administration Committee, that officer will be counted towards the number of voting members present, but not towards the total number of voting members, when determining quorum.

AS INTRODUCED

An act relating to appropriations; providing for short title; stating purpose; appropriating emergency funding for the 2015-2016 process; stating appropriation guidelines; establishing expiration deadline; directing transfer of unused funds by deadline; and providing an effective date.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION:

- **Section 1:** This act shall be known and may be cited as the "Emergency Allocation #8" Act of 2016.
- **Section 2:** PURPOSE. The purpose of this act is to appropriate the funds of the University of Oklahoma Student Government Association to the organizations mentioned within.
- **Section 3:** APPROPRIATION. The following amounts are hereby allocated to:

Office and General Expenses:\$0Capital Investments:\$0Programs/Events/Activities:\$680Total:\$680

- **Section 4:** All guidelines and provisions in the Comprehensive SGA Financial Responsibilities Act shall apply to all funds appropriated in this act.
- Section 5: This fiscal year for the account listed in these sections shall end May 4, 2016
- **Section 6:** All unspent money remaining in the accounts listed in Section 3 shall revert to the SGA General Account after May 4, 2016, and the remaining appropriations shall be canceled.
- Section 7: This act shall become effective when passed in accordance with the SGA Constitution.
