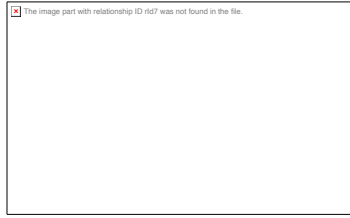

Wesley Causley: I've been to battle with study abroad for 6 months now. They have a system that the dean that makes it obligated to go under study abroad program if involved in study abroad. regardless of scholarships, etc. you are required to go through that program. In my case, I was able to go around that program and got a full ride scholarship, in my lack of information I received I did not enroll, I did not apply, I did not participate in study abroad programs, I have now been charged a study abroad insurance fee and that was in December in January I was charged a study abroad program fee of \$180 fees were charged regardless of me applying to this program. I would like to have an investigation into this program and find out how these fees can be immediately charged to a bursar without their authorization. When you enroll in classes it is contractual agreement with enrolling in classes, but with study abroad no contractual agreement. If you participate in any of their broad control of this program you are as I told obligated to participate in that program. I was able not to participate and save myself \$400 but now fighting to not pay those fees because they have put a hold onto my account. Kelling sec Grunewald

Owings: This is going a concurrent on improving mental health on this campus, state and nation. Three points are what I feel the groups of people who can improve on campus. Mixture of issues we deal with including veteran mental health, budget cuts from state, and national inaction. Requiring work at every governmental level to be done.

Nigh: While I agree with intentions, do you feel it is vague in what urging law makers to do? Essentially tell improving programs and expanding but none listed

Owings: Call to actions just to start the conversation, on campus we have a lot of control but not beyond that

Mazietis: Any mental health resolutions this body has passed?

Sample: not last session, we have discussed these issues at length

Mee: In 4th Whereas clause, in light of current events?

Owings: Specific situation not appropriate to put in bill, suicide of student in cate center was the situation which I did not feel appropriate to put into the bill.

Brown: Are you aware of the steps JD baker has taken with OU mental health service in Goddard?

Owing: good things, talked with Dr Miller to expand it. Issues where his hands are tied with privacy laws or funding. Want to expand but can only get one more doctor

Felt it was not appropriate to discuss past suicide, you said those here would know, but you intend to send to national so they do not know?

Owings: I felt inappropriate

Kelling: Do not want to over publicize this bill. Since trying to send this off campus, maybe amend to say something about suicide on campuses, it is a problem everywhere not just here

Thompson: Given that our last VP of SGA made an imitative to improve mental health on campus and JD Bakers efforts, has their been any consideration of what has been done to discuss

Owings: discussed with Avery last semester with idea to help students brought to Dr Miller but his hands were tied. Discussion on campus did not address the problem

Kelling: discussed at length with JD. We have been told hiring another psychiatrist but nothing has happened.

Mazietis: Friendly amendment under section 3 adding ""

Israel: Friendly amendment to include collegiate statistics on suicide in whereas clause 4?

Nigh: Would accept friendly amendment fourth whereas strike out in light of recent events to the suicide on campus remains a very real problems for colleges across America?

Owings; Change a bit to keep wording with the mental health situation at the university has not improved and suicide on campuses across nation continues to be a very real problem

Owings: An idea to help people with mental health issues that wouldn't need another psychiatrist.. laws and funding held it back. Dr Miller was wanting to do it but it was held back to do since privacy laws and funding

Thompson: What specific purpose Obama, Speaker, etc. serves?

Owings: Discussion needs to be started somewhere. Just with state funding we wont get very far, with national income a way to get more funding and increase discussion

Mazietis: Talked a lot about privacy laws, do you intend for this resolution to overcome privacy laws in general?

Owings: Resolution not to change those, the more pressing issue is lack of funding and lack of programs rather than privacy laws.

Owings: With this I didn't feel most pressing issue was privacy just another example of red tapes holding back programs

Kelling: I'm hearing same sort of questions, we really are tackling funding, reason sending it through entire chain is that where money comes from. Title 9 funding comes from federal government to university to fund these programs. WE have to talk to the people who have money

Salam: did you did research that shows the suicide rates nationally or at OU that shows you are trying to improve something? Anything to show the change that happens or why this is happening?

Owings: Not so much rise in suicide. Just having one is too many, which requires improvement. If even an attempt mental health system has failed. They need help and not getting it we failed

Mee: 9th and 10th whereas. Seeing as 10th related to the 9th did you not consideration make a combo of the two for one whereas clause?

Kelling: I just put it as two, not opposed to combo

Mazietis: In 3rd whereas clause, how can you say in fourth whereas clause has not been addressed?

Considering the effects made by the university, change to not improved to a significant degree?

Owings: I am okay with that wording

Elliott: With all due respect, I have a rough time thinking that this issue is going to start with president Barack Obama, friendly amendment striking that?

Kelling: It is not just we have suicide on campus, if you call Goddard and ask for a counselor you have to wait for a month. Not just suicides it is we do not have adequate mental health care

Owing: actually a cap on the amount of times you can see the psychiatrist, it is 16 times over time at university

Mee: Striking number of 10 and changing number 9 to “”

Kelling: Yes

Elwick: Friendly amendment changing first whereas clause to read “” so it sounds less like all student faculty and staff have mental health problems

CONGRESSIONAL BILL NO. 950112

AS INTRODUCED

An Act of Procedure Expelling Members
of Congressional Session 95 for excessive
absences; providing for a short title;
stating purpose; and providing an effective date.

Section 1: Title. This act shall be known as “An Act Expelling Representatives and Associates”

Section 2: Purpose. The purpose of this act shall be to expel a member for excessive absences. Because Chris Browning, Jaelyn DeSanto, Seoulec Gunvalson, Tave Wise, have accrued excessive unexcused absences and have failed to petition the Executive Committee for an attendance waiver, and as a result have failed to represent their constituents, the membership of the aforementioned is pending expulsion.

Section 3: In accordance with the Section 3.4 subsection 2 of the SGA Undergraduate Student Congress Bylaws, “*Upon accruing a fourth absence, the Student Congress Secretary shall prepare an act of procedure to expel any member or committee officer who has accrued excessive unexcused absences.*”

A Resolution Against Higher Education Funding Cuts; and
providing for distribution.

Whereas: The Oklahoma state budget is currently underfunded by 1.3 Billion for the fiscal year of 2017; and

Whereas: The State of Oklahoma has already proposed a higher education cut of 24.1 million with larger cuts possible; and

Whereas: The State of Oklahoma has cut higher education in the past, making it more difficult for students to attend state funded universities; and

Whereas: The cost usually covered by the state is passed on to the students in the form of higher tuition and fees; and

Whereas: The University of Oklahoma generates \$8.94 of positive economic impact on area income for one dollar in legislative appropriations.

NOW, THEREFORE, BE IT RESOLVED BY THE UNDERGRADUATE STUDENT CONGRESS THAT:

Section 1: The Undergraduate Student Congress, on behalf of the students of the University of Oklahoma, does not support the proposed cuts to higher education.

SENATE RESOLUTION NO. GS16-

AS INTRODUCED

A Concurrent Resolution requesting improvement of
mental health services on campus, in the state of
Oklahoma, and across the United States; and providing for
distribution.

- Whereas: The students, faculty, and staff of the University of Oklahoma are currently, and have always faced mental health challenges; and
- Whereas: The University of Oklahoma has repeatedly expressed their commitment to improving mental health care for students, faculty and staff on campus; and
- Whereas: The University has only had the funding available to hire one new staff member in pursuit of this goal; and
- Whereas: In light of current events, the mental health situation at the University has not improved; and
- Whereas: The University has experienced budget cuts and chronic underfunding from the State of Oklahoma; and
- Whereas: Mental health funding is vital to public health and safety; and
- Whereas: Mental health issues are a nationwide crisis that requires immediate attention and action; and

Whereas: Mental health issues affect millions of Americans on a daily basis, including thousands of Oklahomans; and

Whereas: Mental health issues affect thousands of armed services veterans, causing 22 veterans to commit suicide a day; and

Whereas: The University of Oklahoma has a large veteran population; and

Whereas: Mental health is a multifaceted issue that requires work at all governmental levels to be confronted.

NOW, THEREFORE, BE IT RESOLVED BY THE UNDERGRADUATE STUDENT CONGRESS AND GRADUATE STUDENT SENATE CONCURRING THEREIN THAT:

Section 1: First, the Undergraduate Student Congress, the Graduate Student Senate, and on behalf of the student body of the University of Oklahoma urge the University of Oklahoma Board of Regents and President David Boren to increase funding for mental health programs at the University and to investigate ways to improve mental health on campus.

Section 2: Secondly, the above fore mentioned bodies of the University of Oklahoma Student Government Association, and on behalf of the student body respectfully request Governor Fallin and the Oklahoma Legislature increase funding for the University of Oklahoma's mental health programs and for other statewide mental health initiatives and programs, as well as to take action on the mental health crisis facing Oklahomans every day.

Section 3: Lastly, the governing bodies of the University of Oklahoma Student Government Association, on behalf of the student body of the University of Oklahoma urge President Barack Obama and the United States Congress to take action to immediately improve mental health funding for mental health programs across the country.

CONGRESSIONAL RESOLUTION No. 950405

AS INTRODUCED

A Congressional Resolution Supporting the Collegiate Housing and Infrastructure Act; and directing distribution.

WHEREAS: The Collegiate Housing and Infrastructure Act eliminates a distinction in existing tax law that would result in allowing tax-exempt charitable and educational organizations to make grants to non-University owned not-for-profit student housing entities that provide collegiate student housing; and

WHEREAS: The Collegiate Housing and Infrastructure Act would make college more affordable at no cost to taxpayers by offering a housing alternative less expensive than University housing; and

WHEREAS: The Collegiate Housing and Infrastructure Act results in safer student housing by encouraging charitable contributions to collegiate housing for installation of life saving equipment such as fire sprinklers, smoke detectors, and alarm systems; and

WHEREAS: Approximately 1,400 University of Oklahoma students live in non-University-owned not-for-profit housing during a collegiate year;

NOW, THEREFORE, BE IT RESOLVED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION UNDERGRADUATE STUDENT CONGRESS:

AS INTRODUCED

An Act relating to appropriations; providing for short title; stating purpose; appropriating emergency funding for the 2015-2016 process; stating appropriation guidelines; establishing expiration deadline; directing transfer of unused funds by deadline; and providing an effective date.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION:

Section 1: This act shall be known and may be cited as the “Emergency Allocation #10” Act of 2016.
