Committee Reports-

- Academic Affairs- We saw the Minors bill, 960201, and we gave it a rec of do pass and we'll be seeing it tonight.

There's been a hold up with licensing approval on our designs. Items to Be Considered

960111 Debate Reform Act (Reid) (ConAd- Rec of Do Pass)

Representative Kelling sec Representative Owings

Reid: A lot of what this bill is doing is clarifying the decisions we made a few weeks ago during the debate regarding the budget interviews. I'm open to discussing this and making amendments if we feel they are necessary. Kaylee, Taylor, and I went extensively through the by-laws to make things more clear.

Elwick: Is there anything in here now that was not decided when we were debating? Did things change based on the decisions that you made during the debate?

Reid: There is one thing that's different: the fact that the speaker is only allowed one speech during debate, unless they are an author, in which case they receive their summation as well. You also cannot yield time to someone who has already talked. If a presiding officer steps down from the chairship, they cannot reassume the position until after the final vote. If the next ranking member has already debated, they are skipped over in the line of succession. George also suggested that previous question be moved to a hand vote immediately. If $2/3^{rd}$ of the body agree to move to previous question, we move to previous question.

Williams: In Section 4, Part 13 it says that we follow the line of succession. What is that?

Reid: It goes Chair, Vice-Chair, Secretary, Congressional Administration Chair, Ways and Means Chair, then seniority.

Kelling: Might be scriveners, but can you change Section 4 (part 2) to Section 5.

Reid: Accepted

Owings: Aren't partisan statements derogatory?

Reid: Partisan statements are saying the other side is bad, while direct derogatory statements just kind of cover individual people. Anything that is derogatory is left up to the Chair to decide.

Ahmadi: I'm always confused by someone calling for debate and whether debate is part of procedure. Can you more clearly define Section 4?

Reid: The only reason that we don't move to debate on every bill is a call for consent or a motion for a roll call vote. After questions, we technically move directly into debate and then out of debate. However, we usually move to a roll call vote or call consent. I'm not sure how to make sub-section 1 any more clear because that is where it falls in the standing rules. The second sentence (any member can call for debate) says that you can call debate in the middle of questions. If you have a suggestion on how to make that more clear, I'd love to hear it.

Ahmadi: "Debate is in line following the author's explanation"? Maybe "but" instead of "any"?' *James: Friendly amendment to add "questioning, but" instead of "questioning"?*

Reid: yes

Elwick: On section 10 when it talks about derogatory references, it was kind of vague. Would you mind changing derogatory to personal?

Reid: The problems that we faced in committee was that if I were to reference the "author" it would be personal. Derogatory would be something malicious or something along those lines. Personal statements would mean that we can't discuss things effectively in some ways in terms of referring to an author's argument. Derogatory is left to the decision of the Chair.

Rains: You aren't supposed to refer to a person by name, so that is the rule that we intend to apply here. Kelling: I think that the idea is that if I want to say "the previous speaker said ..." I should be able to say that. However, I shouldn't be derogatory towards them.

Motion to Extend Questioning by Five Minutes Representative Nigh sec Representative Owings Reid: I see where you're coming from and I agree but I think that the word derogatory is the most effective word to use.

Bray: At the debate, which was a lot of fun, one issue that came up was when one of the debaters mentioned someone else's major, which aimed to make a negative argument. Does this solve that issue?

Reid: That would be up to the Chair as to whether or not it was derogatory. You can make anything derogatory even if you don't say something like "they're stupid".

Buxton: Regarding derogatory, we can still call decorum?

Reid: Yes

Rains: Would you accept a friendly amendment adding "derogatory or personal"?

Reid: Yes

Owings: Would you accept a friendly amendment replacing derogatory with "derogatory or personal attacks"?

Reid: No

Owings: If we include personal references, that removes our ability to refer to the previous speaker.

Reid: I don't like the word attacks being in the bill.

Kelling: Would you accept a friendly amendment saying that "it shall not contain derogatory or negative references to any person"?

Reid: Yes

Motion to Extend Questions to the End of the Life Representative Mee sec Representative Pham

Owings: For the friendly amendment, does that contain the second time you say "derogatory reference"? Reid: Yes

Elwick: Is a personal statement referencing a person necessarily?

Rains: As Chair, I feel that it would not be referencing them.

Davis: So regarding forfeiting remaining time, does that mean that the speaker forfeits all banked time or just the time remaining to the speaker?

Reid: The time remaining to the speaker, which is a generally accepted Roberts Rule procedure.

960115 An Act Amending the CA Regarding Survey Legislation (Mazeitis) (ConAd- Rec of Do Pass)

Representative Quick sec Representative Owings

Mazeitis- This bill is very simple. It strikes the sentence of the Code Annotated prohibiting us from editing surveys on the floor. I think that there were some valuable potential changes we could've made last week and I would've preferred to amend it on the floor.

Echols- Did you do any research as to why we do this?

Mazeitis- I asked Kaylee and she said that it also been this way for as long as she has known.

Kelling- Were you referring to the specific bill from last week?

Mazeitis- Yes, the SQ 777 survey.

960201 Minors Survey (Echols) (ConAd- Rec of Do Pass)

Representative Mee sec Representative Nigh

Echols: I am the author solely for the purpose of passing this through the legislative process. David didn't want to be the lead author because of his position in the court system. I agreed because I think that adding minors at no cost is always a good idea.

Monlux: This is a survey bill to gauge interest in minors. The Senate and Administration has expressed some concerns and would like to see it again. I would like it to go to a Joint Committee on Sunday at 5pm between Senate's Academic Affairs Committee and Congress' Congressional Administration Committee.

Motion to Refer this Legislation Back to Committee Representative Williams sec Representative Pham

This bill is now referred to a Joint Committee of the Graduate Student Senate's Academic Affairs Committee and the Undergraduate Student Congress' Congressional Administration Committee. This Joint Committee will meet at 5pm on October 30th on the first floor of the Conoco-Phillips Student Leadership Center.

960511 Auxiliary Funding #4 (Echols) (WAM- Rec of Do Pass)

Representative Owings sec Representative Pham

Echols: We are seeing \$554 for the Undergraduate Mock Trial team to travel to competition, \$400 to Phi Gamma Pi for a membership dinner, \$460 to Students for Liberty so they can buy a flight for the speaker, The Big Event allocations seems large, they had issues with primary funding and we had already allocated the \$8,000 to them for rentals, supplies, etc. , \$6,400 to the Student Bar Association which is on par with previous years because they are administrative organization for the law school, \$100 to the Society of American Archivists for a meet and greet event, \$525 to Health Law Student Association for a speaker event, \$3,500 to the Student Organization Resource Office who need money for damages and software updates, and \$300 to General Council for printing and office supplies. This leaves approximately \$25,000 in the auxiliary fund. Mee: How much did The Big Event ask for?

Echols: \$44,950

Rains: The Student Bar Association isn't an administrative organization, so are they funding groups under them?

Echols: The way that I understand it is that the Code Annotated lays out our organization system, which is not directly related to Student Affairs policies. We funded general office supplies and general rentals for their upcoming Halloween event.

Kelling: Regarding the Student Bar Association, do they need that funding right now?

Echols: Typically, that's kind of how we see it. We assume that because of the way auxiliary works, they need it soon.

Williams: Regarding Undergrad Mock Trial team, is there a scrivener's error?

Echols: Yes. It should total \$564

Kelling: How much money has Student Bar Association been given this year?

Echols: This is their first Auxiliary request. They typically get between \$18,000 and \$20,000 in primary funding
