Monlux: This is based off a survey from 960201 that was passed a while back. My friends in the Senate helped me make my questions better asking if people would be willing to take the minors. Based on the number of people that participated, I was allowed to move with three study-center specific minors, two religious specific minors, and a minor in Oklahoma Studies. This is just a suggestion to administration. These would be by Fall of 2017 at earliest. This also serves as a campaign to help let students know about our great classes. If students have a minor they can pursue, it makes them more likely to take them.

Reid: Have you taken these results to the Dean of the Colleges that the minors would be involved? What did they say, if so?

Monlux: I took these results to IAS with Mitchell Smith who told me there was paperwork in the works. They told me that a student initiative would be helpful. Religious Studies is still up in the air. With OK Studies, I've talked to multiple departments, and 60% of the classes have to meet one departments, which is the reason that I added a number of deans on the list of people to send it to.

Mazeitis: Would you accept a friendly amendment to make the language of the resolved section less forceful?

Monlux: Yes

Mazeitis: Would you consider the incorrect capitalization to be a scrivener's error?

Monlux: Yes

Mazeitis: Considering that most of these numbers represent only 20%-30% of the people that responded to the survey expressed interest, is there sufficient evidence to indicate student interest in these minors? Monlux: The questions was about completion, not about favoring minors. It was asking if you would complete the minor. The Religious Studies minor only has 73 people who have declared that minor, and if anyone declares a minor in a department, with Christian Studies, it is the world's largest religion and the US continues to get itself involved in the Middle East, and I think that we need to understand the customs and the culture of the region, and it would go with international studies and security studies. If those classes fall under a dual multi-purpose rule, those classes might be protected from state legislature's cuts. That's still more people that have minors declared that in religious studies.

Reid: You said that some of the courses you'd need to take to complete an Islamic Studies minor would be in International Security Studies?

Monlux: Those are potential classes. I'm an International Security Studies major and the International and Area Studies Department are pushing those classes.

Davis: These are just resolutions making requests to administration, correct?

Monlux: Administration will do whatever it does, but we can still use this as an awareness campaign.

Reid: With these bills, their results having already been known and taken to these people, what do you think that resolutions by this body are going to do?

Monlux: We are the voice of the students, and I'm sure that students would take it if offered.

Kovach: Am I correct in saying that these classes already exist?

Monlux: Yes, they have been offered at least once since 2014.

Mazeitis: Would you accept a friendly amendment to change the names on the legislation to reflect standard naming practices? Monlux: Yes
