960503 An Act Putting the Game in Game Room (Watts) (Rec of do pass)
Williams sec Chun
Watts: This is an act. In a sec I will ask you to table this for one week. The union names their rooms after people, sometimes when you change that room need to ask those people, the approval will be there by next week. At one point there was a planned renovations for the game room by Crossroads, they were planning on renovating it the Union was but because of budgeting issues it didn't happen. This bill will allocate a portion of the student initiatives funds. Shuffle board, dart board and a foosball table to add to the room i've been in contact with assistant director of the union, union takes care of upkeep, a significant diference in price. Union will make up the difference.
Reid: Just curious why were sending a listing the director before assistant director? Watts: It was who was on mind first.
Reid: Friendly amendment switching the assistant director and director for this pieces of legislation?
Watts: Yes
Bray: how much money spent and how much in initiatives fund?
Watts: Redirect to matt
Cramm: About $\$ 3618$ left in the account
Bray: How much will be spent on this?
Watts: \$3500
Bray: How much will be left over?
Sample: So that depends on based on what request we make for more money in that account and how much wam is going to give us. Only second year we have had this account. This year we have $\$ 4000$. Next year we requested a $\$ 1000$ with expectation that money will be coming out contingency account.
Watts: The total cost is around $\$ 5000$, there is some various delivery costs associated with that but we will only pay $\$ 3500$ and the union will make up the difference.
Kelling: So if I'm understanding the OUMM is going to pick up the balance we do not pay?
Watt: Yes

CONGRESSIONAL BILL NO. 960503
SENATE BILL NO. GS16-XX

AS INTRODUCED
A congressional act authorizing the purchase of games tables with the Student Initiatives Fund, providing for a short title, providing an effective date, and providing for distribution.

## BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT ASSOCIATION:

Section 1: Title: This act shall be known and may be cited as the "Putting the 'Games' in 'Games Room' Act of 2016"

Section 2: Purpose: The purpose of this act shall be to outfit the Henry W. Sr. and Claudine Browne Game Room, located on the first floor of the Oklahoma Memorial Union, with a number of games, including shuffleboard, darts, and foosball. These additional games would add to the atmosphere and appeal of this room, further fostering an atmosphere of fun and recreation for both current and prospective students. The cost breakdown is as follows:
$\$ 3500.00$, to be split between the costs of a shuffleboard table, a dartboard, and a foosball table, with the remainder of the cost to be provided by the Oklahoma Memorial Union.

Total: \$3500.00

Section 3: The Undergraduate Student Congress hereby authorizes the purchase and delivery of a shuffleboard table, a dartboard, and a foosball table to be purchased, at a cost of $\$ 3500.00$ to the Student Initiatives Fund, and to be placed and maintained by the Oklahoma Memorial Union.
