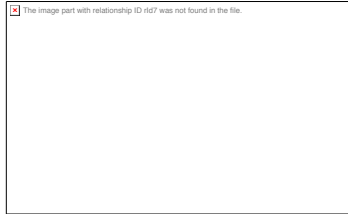

950503 An Act Putting the Games in Game Room (Watts)

Nigh sec Chun

Watts: This is not new legislation, saw this last week. We are in the position to take it off the table and authorize expenditures. We are going to be allocating 3500 toward 5000 project to stock lounge with games. Including darts, shuffle board and foosball table. Purpose of this is to kind of revitalize a project that the union previously took up and we want to make that happen. The point is it make it a more fun atmosphere in the union, makes it more worth staying around it. Good for perspective students touring and current students.

Cox: How are we going to go securing safety in the union with a dartboard?

Watts: They are rubber tip darts so they're safe.

Mee: We aren't allocating this money like we would primary, so where does it come from?

Sample: Currently in our congressional account we have money for congressional student initiatives account. We add 4000 start of the year and did one project so it comes out of there

Mazeitis: If this money is not used now, it won't go back to congress, right?

Sample: It will go towards contingency account. Will be for next year student initiatives

Cox: There was a student concern for more benches that would be one of your congressional student initiatives? So could we do that next session?

Sample: As long as money left for it, that is up to the next chair. Have to wait till end of year to figure out how much we have in contingency account. If passed, this cannot use the funds for it this year.

960102 Office Space Allocation Act (Pae) (Rec of do pass)

Elliott sec Chun

Sample: We set up a meeting, and tell the President what we think best action is. These are the organizations we think are the best for these office spaces and basements spaces. Only group that did apply and are losing their spaces is Rotoract and Connect U because they have only used their office the past 2 weeks. I need a friendly amendment to switch AASA/HASA with the Muslim Student Association's office, they asked earlier to stay in the HASA office.

Reid: Would you accept friendly amendment you stated?

Sample: Yes

Reid: What groups taking offices you were just discussing?

Sample: Habitat For Humanity is taking that office space. All of the groups that are sharing have been notified.

Nguyen: Are these applications how many organizations kept old room?

Sample: Almost all of them only Rotoract and Connect U, HASA and Columbian Student Association used to share but now sharing with AASA. Everyone else is in the same space.

Basements I couldn't tell of top of my head

Kelling: Not to sound bad just wondering why SVA has been trying to get office space for 3 years and wondering why we weren't considered?

Sample: we emailed Facilities Management because we were told SVA would receive office space in the new building, so we felt we could help another group out

Reid: Basement space #17?

Sample: Nation wide service organization, they often pair with boys and girls club

Davis: Which organizations didn't get office spaces?

Sample: Fairly long list, about half that applied were unable to get office space, we helped a bit by grouping together, some that didn't get it. Oklahoma Indian Association, Undergraduate Indian Student Association, the members were very small one of them was 9 members. Pre Med Club and Music is Medicine said they would like office space to store things in we decided to use it as a place for those orgs to gather rather than storage.

960401 A Resolution Supporting the Penny Sales Tax (Kierig)(Rec of do pass)

Reid sec Chun

Kierig: Thank you for having me, I appreciate your formality in here, it is different than in the senate. This is a simple resolution in support of Dbo's resolution to distribute a penny sales tax that will be distributed back to education. OK budget crisis of 1.3 billion dollars, Dbo won't solve all of the problems from cuts we have seen but it is a start. Since 2008 K-12 education been cut by almost 12% percent, in 2015-1026 educating almost 50,000 more students, with farther cuts on per pupil spending. Adjusted for inflation, we are number 1 for cuts to common education. No other state has cut education as much as Oklahoma. No other state has enjoyed the oil boom. University of

Oklahoma, this year will be lucky to get 112 million. Dbo has shown tremendous leadership because we are lucky to have such a great president. My resolution will go to other university systems across Oklahoma, to regents and universities. It will call on their SGAs to pass similar resolution to call for state to pay for education for their students of their state

Mee: Accepting Cosponsors?

Alrawi: Say we pass this, do you think the university will lower tuition again?

Kierig: Idea behind resolution if people of state pass ballot initiative in November the university will see increases which will prevent need for increases in tuition and fee

Alrawi: If 5% increase we got will it go down or preventing future increases?

Kierig: Assuming models are correct, models accounts have done are correct, the university would be able to avoid raising tuition in years to come, situation is state is not giving us enough money to lower tuition and will get worse

Nigh: Does the funding from penny tax solely go to education and teachers or other areas?

Kierig: Above the legislative process because its a constitutional amendment so say you go buy a soda at campus corner, that penny will go to state tax commission and money from penny tax avoids the legislator they cannot take it away and use it for other initiatives. This money go directly to school districts and the language in resolution goes directly in classroom, salaries, education and general budget which is how we pay faculty, for votech goes towards improving votech facilities and improving pre k

Owings: how does this affect the price when we go to the cashier?

Kierig: One percent increase

Kelling: Just wondering you mentioned it is outside legislative process, what's to stop them from cutting us seeing as we got money from this in the future?

Motion to extend questioning by 2 minutes Chun sec Pham

Kierig: The additional language protects current levels of funding. It prevents future legislators from cutting our funds in the future, it is legally protected

Kovach: Since the majority of the tax cuts have come from a progressive income tax why supportive of a regressive sales tax increase as opposed to income tax?

Kierig: I agree as does state house and state delegation, in 1992 we passed the state question 692,, prevents legislator from passing income tax increase with out 75 percent of both houses. Dbo knowing people of state as he does would make it is easy to launch an attack ad about income tax. I would love to see an increase in income or property tax any other way to pay for this. Better ways of paying for this, I have spoken with Dbo about this a couple weeks ago, he would rather see an income tax increase but this is a conservative state, it will hurt me as much as anyone but we have to decide where it comes from.

Reid: Said there was no increase in SAF. So not an increase in organizations?

Cramm: Yes

Reid: Are we funding more organizations than last year or less?

Cramm: I believe less organizations. Last year for primary we had about 15-20 more than this year

Williams: Funding less organization means that those organizations didn't apply?

Cramm: Yes

Williams: money left over?

Cramm: No

Mee: Sooner Paranormal Society with \$500?

Cramm: That money is going for equipment needed for the running of their organization

Mee: Is it ghost catchers?

Cramm: Yeah they go to haunted areas!

Elliott: Could you explain why BSA and international advisory committee received a substantial increase?

Cramm: One of the big things we base funding off of is how received funding previously and this is matching that. Also they both have very large events on campus and large outreach Stompdown and Mazeitis: Sooner Paranomal be hired?

Cramm: Idk

Reid: Did we fund the ghost busters?

Watts: The average allocation done by mean is ___ of that above 35 are above that and others are. Those 35 above are groups focusing on minorities. Similarly if you look at groups not looking at minority groups, only some fall above means. Is there a reason for the disparities?

Cramm: Important to note about these multicultural organization is they all host very large events for student body to attend compared to others who just focus more smaller group. These organizations outreach the community more, so these have historically received more funds, previously funds allocated and is how we do funding

Noble: Just out of curiosity, I looked up BSA received 3 times as much more as HASA. Is that purely just historical funding or size of events?

Cramm: That is historical funding, I found a discrepancy two years, I found HASA only funded 900 so been pushing to increase funding for them every year

Cramm: BSA 83,000. HASA, 67,000

Reid: Just for new members in here, your process of going through this is it not based just on what they are requesting but on past fiscal history?

Pham: So the club geography and environmental sustainability club and assisting club only received

\$75?

Cramm: Fiscal history

Pham: How much did the geography and environmental sustainability club ask for?

Cramm: 855

Grunewald: Are we granted follow-ups?

Sample: No

Grunewald: If organization not to receive funding they requested how did you come to this number?

How do you go through budget and decide what was important?

Cramm: Yes. Over a million in requests and only spent 134000 so outreach, fiscal history determine that

Williams: Does process consider outside funding?

Cramm: Yes

Owings: Some examples of capital investments we have given money?

Cramm: Equipment, Banners, Tablecloths, etc.

Kelling: We requested tent for tailgates, grill, tables, etc. I think we can buy the tables

Cramm: A lot for tablecloths on south oval

Kirkham: Should this get table how longer organization have to appeal?

Cramm: According to bylaws it is has been up for awake. And they've had that time to do it

Sample: We cannot table because has to go to senate and it has to be passed this year

Kelling: I just noticed can you please explain why TOG is getting over 1000 in office expenses?

Brown: Aside from sport organizations do you believe there could be a bias of sports against educational or organizational events?

Owings: People will see the bias regardless.

Kovach: We are in a unique situation where varsity funding, football specifically, is reverse of normal where those teams give us money and help supplement us as a school, they are self funded they allow us students to go to school.

Noble: Is there any particular order in sports?

Owings: Tried to do men's and woman's and then bigger accomplishments.
