Motion to Move In To Committee of the Whole Representative Mazeitis sec Representative Davis

970402- A Resolution Against Higher Education Funding Cuts (Williams/Rubio/Baker)

Representative Quick sec Representative Carson

Williams: This is a resolution against higher education cuts because we're in another deficit (900 million dollars), so it is likely that we are facing cuts. Last year, I proposed a similar version of this bill before HigherEd day. This year, President Baker asked us to have it done before HigherEd Day.

Echols: Could you explain why you decided to send this to two US Senators?

Williams: These are Senators that represent all of Oklahoma, and these are people we look to for policy. I know that if these letters were to go to these Senators and change what they think, it would make OK better. These Representatives listed are those that have proposed cuts to higher education.

Reid: These Senators have no influence over the policy that we are opposing here. I'm wondering what you're hoping will happen by sending it to them?

Williams: As I was talking to other members, I realized that some of our representatives and senators at the state level model their policies after those enacted by the national government and more specifically OK's national lawmakers.

Rains: Can you further explain your intention regarding putting the 7th Whereas Clause?

Williams: A lot of our elected officials see education as a funding blackhole where there is no return on investment. This Whereas clause explains how beneficial higher education is, which is a 9:1 return ratio. This shows our more fiscally conservative representatives that education is financially worthwhile.

Echols: Are you referring to Representative Paul Wesselholf?

Williams: I was not.

Niles: I was wondering why you chose to use some people's first names, and not everyone's full names? Williams: It is just an inconsistency. I apologize.

Swearengin: Based on the Chair's remarks in the Whereas clause, where are you obtaining that information from? What is the area defined as?

Williams: Area is defined as the state of OK's economy. I didn't include the citation but it is from a report released by a representative for this area.

Echols: Would you accept a friendly amendment striking Rep. Wesselhoft?

Williams: Yes

Nigh: Would you accept a friendly amendment striking the Representatives first names?

Williams: Yes

Klima: Would you accept a friendly amendment adding all chairs of the Senate and House committees to Section 3?

Williams: Can I ask why?

Slane: These are all of the people that have proposed higher education cuts, and it was noted that they have no influence, correct?

Williams: That was regarding the national Senators?

Slane: Wouldn't it be salient to send it to all the chairs of the State House and Senate?

Williams: I accept the amendment.

Motion to Move to the End of the List Representative Quick sec Representative Lewis

Carson: Would you be willing to accept a friendly amendment to discuss legislation that you've proposed with other public institutions that are being influenced by this cut, because influence is strong within the media and you have multiple media sources?

Williams: Do you mean sending this to other University papers and other University's SGAs?

Carson: SGA's. Williams: Yes

Ennis: These resolution only applies to people with in-state tuition, correct?

Rubio: The second footnote denotes the budget between 2001-2016, and it does include some numbers for out-of-state students. For this, I just included in-state number, but I'd be happy to include a Whereas clause regarding out-of-state students.

Hedgcorth: Is the author concerned that the friendly amendment proposed by Representative Slane going to dilute the impact of this resolution?

Williams: I'm not worried about that. A decade or two back, we used to not make resolutions regarding high school football. However, due to concerns about high school football, we sent resolutions to all members of Congress and that became a tradition. While I don't want cuts to become a tradition, I do think that it'll make an impact.

Kalvacherla: Is there a reason this isn't being sent to the Department of Education?

Williams: I wanted to focus on the people that were adamant about cutting higher education funding, which I didn't think that the Department would be wanting to cut.

Chism: Would you accept a friendly amendment adding Natalie Shirley, Sec of the DoE in OK to the list?

Williams: Yes

Rains: Are you willing to add co-sponsors?

Representative Buxton sec Representative Carson

Williams: We encourage you to vote yes on this resolution.

Representative Hedgcorth sec Representative Nigh

Echols: I'm having Sam speak on this one. We were in a bit of a rush, so I need to ask for two friendly amendments to strike Mumford Research Group and change LCMSU from office supplies to capital investments.

Quick: On Sunday we met and went through 18 auxiliary requests. IAC requested 2,331.94 for International Prom, their International Bazar and food, American Indian Student Association requested 15,400 for food, the OU Men's Lacrosse Club requested 63,015 for registration and coaching fees, the Oklahoma International Law Society requested 700 for food for meetings, the Roosevelt Institute requested 380 for food, printing and travel, the OU Cycling Club requested 2,715 for registration fees, food, beverage and supplies, the Sooner Air Traffic Control Association requested 690 for food, Intervarsity Christian Fellowship requested 1,263 for food, the Institute of Industrial Engineers requested 500 for food and space rentals, the Association for Women in Science requests 500 for speakers fees, travel, food and supplies, LaFe Latino Fellowship requested 180 for funding to travel to a conference, OU Forum requested 440 to use for printing and PR, the

Powerlifting Club requested 1,100 for registration fees, the OU Men's Ultimate Frisbee Club requested 2,225 for tournament fees and travel expenses, the Informed Citizens Discussion Group requested 600 food for meetings, and the Lutheran Church Missouri Synod University at OU requested 600 for capital expenditures on furniture.

Bishop: Can you explain how some organizations only get about \$100 while the Intervarsity Fellowship gets about \$1000?

Quick: The criteria we use include pass funding history, the amount they asked for, etc. The Latino Fellowship was fully funded... they just didn't ask for much.

Kalvacherla: Why is it that one of these groups is getting \$3,000 for food while others aren't?

Quick: The American Indian Student Association covers a large number of students on campus, (close to 1,000), and it has to do with their past financial history, and they have excellent history. Other organizations only have about 20 or 30 students.

Williams: How much money do we have left in Auxiliary?

Echols: Roughly 108,000

Quick: Will you accept Chair Echols' friendly amendments?

Reid: Yes

Rains: Why did you cut the Mumford Research Group?

Quick: We failed to see they had applied for primary instead of auxiliary, because we were moving so quickly.

Warner: When you are saying "very good" financial history, what do you mean?

Quick: We look at how much organizations have requested and how much they've spent, and our decisions are based, to some extent, on that history.

Reid: Can you explain what the Roosevelt Institute doe?

Chism: According to their budget form, "The Roosevelt Institute strives to encourage critical thinking about policy issues that millennials are invested in. The Roosevelt Institute provides training, resources, and leadership skills to undergraduate students on The University of Oklahoma's campus. Through academic study, stakeholder guidance, and group data collection The Roosevelt Institute analyzes and writes policy to help improve the socio-political well-being of individuals within the state of Oklahoma and the local Norman, OK community."

Motion to Extend Questions by 5 Minutes Representative Reid sec Representative Ryana

Bishop: We know how much they asked for and we know where the allocation is going, but how do you decide which line in their budget you choose to fund?

Quick: There is a section of the application that asks the organizations to prioritize their requests, which is usually what we use. We also exclude anything we can't fund.

Brown: When was the period when organizations could apply for funding?

Echols: It is on a rolling basis... its been open all year and will be open all year.
