980105 – OU/TX Legislation (Baker, Pavlowsky, Rains-Saucedo) (Rec of Do Pass)

Representative Hedgecorth seconded by Representative Ryana

Baker: This is declaring the OU/TX holiday of 2017. It recognizes October 13th as the OU/TX official student holiday. This makes it university policy that that Friday must be recognized as a student holiday. Hedgecorth: SGA is allotted one day to show as a student holiday and this is tradition, but technically we could do it another day?

Baker: Yes.

Hedgecorth: This bill would only mark the 2017 year as the holiday?

Baker: Yes, we do it annually.

Williams: Is it your opinion that Texas sucks?

Baker: The University of Texas is a fine institution despite their athletic program.

Reid: There was concern in the exec committee that professors do not adhere to this and still hold class and take attendance and such. Where could a student go to address these concerns?

Baker: They can bring it to their representative here in Congress, and then it will go to the officers. Or they could submit it to the President's Action Line or Office of the Provost. If they have any issues they can deal with the professor's bosses.

980503 – Auxiliary Funding #1 2017 (Chism) (Rec of No Rec)

Representative Williams seconded by Representative Hedgecorth

Chism: This is the first Aux of the year. QSA and HLSA are on it. QSA is funding their welcome back and HLSA is applying for funding for bonding activities and a lunch and learn among other events.

Williams: Were both these organizations seen during primary?

Chism: QSA yes, but HLSA did not apply for primary.

Cassidy: We talked about this on Sunday, but the HLSA used to be under the Student Bar Association. But, now it is an RSO. How does this affect their fiscal history?

Chism: All law student associations pulled out from under SBA and have applied as new organizations. They have no fiscal history, so I am reaching out to get their info from the SBA President. We want to help these organizations because it is hard to be an established organization, and then have to go back for only \$500-700 we normally allot for primary. I plan on making it known to my committee that these law organizations are special circumstances in funding.

980507 – Auxiliary Funding #2 2017 (Chism) (Rec of No Rec)

Representative Mazeitis seconded by Representative Bishop

Chism: This is Aux 2 and it is the SGA operations budget. This usually goes through in the spring, but we had problems, so we are doing it now. What this does is it keeps SGA running and lets us have supplies printers, etc. We can't function without it.

Mazeitis: What are the capital investments?

Chism: Computer updates.

Williams: What happens if we strike this down? Chism: SGA won't have money to run on. Reid: Wow much did SGA originally ask for?

Chism: This was fully funded.

Mazeitis: Can you explain how this ends up in operations instead of ending in exec branch allocation?

Chism: We consider some events to be Pan-SGA, George can tell you them.

George: Inauguration, State of the SGA, Big 12 Conference.

Williams: How much do we have left in Aux funding?

Chism: If these bills Aux pass, 91,596.79

McClintic: Did we use all of our aux funds last year?

Chism: No.

Bishop: Tt's my understanding that in a primary application process, you are more likely to get more money than in an auxiliary one, right?

Chism: Yes, because the purpose of primary funding is to cover all events planned for the year.

Bishop: Was that taken into account when we fully funded this and did not split funding into fall and spring events?

Chism: Because this is the entire operations budget, we fully funded it. We could have done it in sets, but SGA has good financial history, so we did not split it up

Mazeitis: Would the same consideration been given to another RSO?

Chism: No promises on full-funding, but this happened last year with Big Event. They were still given the money; we didn't hold it back. We do consider special circumstances for things like this.

Lalani: Hey. This is just assigning members to committees for the semester. This cannot be changed right now, but we will pass legislation when we get appointed members where you will get to request a change. However, there is no guarantee you'll be able to change. Just make a request with Kaylee and she will decide on the next legislation.

Mazeitis: Is there a procedural reason this cannot be changed?

Lalani: It can be, but we will not be accepting changes today.

Hedgecorth: What exactly would happen if this failed?

Lalani: We would not have any representatives on any committees, so we couldn't get started on important work.

Buckley: Scrivener's Error: My name is spelled wrong. It is "Gray"

McClintic: There are 2 "Brea Clemons" on the lists.

Lalani: I request a friendly amendment to strike Clemons off PnP.

Williams: Accept that friendly amendment?

Lalani: Yes.

Williams: Why do you think Communications Chair Reid chose to go with no assistants?

Reid: At the moment I just haven't chosen them. The entire reason the chair position is the way it is because a committee was not effective. However, opportunity for 1 or 2 assistant positions will be open at a later point.
