Vice Chair's Report – Hello everyone we have a tabling event this Thursday for recruiting. It will be in the union but when we get back, we will be focusing on districts that chronically have empty seats. In the meantime, please be safe over spring break, we would love to see everyone come back happy, healthy, and safe. I know I said it earlier but if you are struggling with the rape incident that happened last week, I really do encourage you to call OU advocates 405-615-0013. Merchandise will also close soon; I sent the link into the group chat again in case you needed it. Also, if you are interested in running for Vice Chair please let me know!

Secretary's Report – Hey everyone! Please remember to let me know about your consistent service hours. On the off-chance school is canceled and we get an extension on spring break, I will excuse all consistent hours. But as of now they are not excused, and I will be keeping you all updated on that.

Committee Reports-

- Campus Outreach, Safety, and Concerns: All of our major projects are on hold at the moment, but we are still making good progress on the concerns we received from the suggestion box. Filters have been replaced in the Biz, we are making some headway with the various crosswalk concerns.
- Congressional Administration: We did not see any legislation. We are still working on projects.
- External Affairs: We passed CR-103-06 and CR-103-07 with a recommendation of do pass. March 25th, we are doing an event with OK votes. Our Federal and State Budget team are looking at Higher-Ed numbers over the fiscal years. The second Higher-Ed day will either be Monday April 1st or Tuesday 2nd or the 3rd. Campaign job fair is set for early April.

- **Human Diversity:** We saw the BERT Resolution and resolution for International Women's Day and gave them recommendations of Do Pass. We are also talking with the Native community and admin to talk about our mascot bill. If you all have any questions about that please let me know.
- Sustainability: We are reaching out to RAs about sustainability measures. We will also be coprograming with international student association about international students affected by climate change. 29th trash walk. They are doing this community gardening class on Sunday. 29th at the earth cafe
- University Policy: Projects are continuing. There was someone whose project wrapped up but we
 assigned her that new student concern. We also started one issuing trigger warnings for appropriate
 OUPD alerts.
- Ways and Means: We didn't meet. That is on me. So we will see legislation in committee of the whole. My version will go on the agenda. As of right now we will be closing Aux period.

- Campus Activity Council Chair Candidate Introduction

Spigner: Thank you for allowing me to come speak to you. I will be talking about my vision for CAC. I am a junior at OU. I am running for CAC because I never thought I would be able to. I thought that was a leadership roll that was beyond me. But they taught me that anyone would be able to do this. Flourish is my word that I would like to focus on. Assess tradition, having an organization as set as ours, we need to look at what is working versus what is not and we need to grow what is and stop what is not. I want to work with SGA to re-write our constitution to more align with SGA. In regard to cultivating unity, CAC is an umbrella association with 14 events. Most of these events are focused on goals within themselves. But I want to celebrate the differences with each organization in order to create unity. Implement change, we need to not fall for victory blindness. We need to not lose pace. We need to work 10 times harder for 10 times more. I want to have mandatory reports. We need to make sure we are not just meeting people half way. I want to create a constitutional amendment that allows for accessibility. I am very big on having a constant stream of collaboration. My platform is on lafonzoforcac.com. Please reach out to me with any questions.

Chism: You mentioned CAC constitution, that is the only thing that is not included in the Code annotated. How would you feel about moving the appropriate parts?

Spigner: at the end of the day we are a branch in SGA. We are leaning into that belief. But there needs to be more talk and more elaboration.

Merchant: What is your experience?

Spigner: I have been on multiple execs for multiple events. I have not been chair for any of these events. But this is not my first time in the game. I have held numerous leadership experiences on campus. I understand what needs to happen.

Marvin: Can you elaborate on the accessibility you were speaking about?

Spigner: SGA is looking at spaces that are fully accessible to all students but many times we do not think about the able body. We as an organization need to have that at the for-front on our mind.

Farmer: Can you explain some of your vision on growth?

Spigner: I am thinking collaborating in 2 ways, 1 with campus as a whole. I want to create the leadership intake and bring that discussion to all campus programmers. We need to collaborate as a group inside of CAC also. One event often doesn't know what the other events are doing. I want to streamline the organization and help it flow. We need regular event participants and event members to understand how the events run. Many of the general members to not understand what the top exec members do and that is a problem. Chism: What is CAC doing right now to recruit diverse members and what would you change?

Spigner: Selection bias training. We train our vice chairs and chairs to interview students and understand and check the biases they have. My problem is that with reading it, they never explain ways. Personally, students should not be teaching this. We need adults to come in and facilitate this.

Chism: what is your biggest frustration with CAC if you have one?

Spigner: I think that in hitting everything that I want to change, it might sound like I don't think there are things happening right. But I think that with the disjointedness, people aren't understanding the decisions being made on their behalf.

Broadbent: Expand on the OU in population surveys?

Spigner: we send out emails to get more information and data within the org. my problem is, not a lot of people fill them out. We need to be having face to face interactions with these event organizations. The data collection will still get done.

Lange: do you have goals that you feel would be best achieved by the cooperation with SGA?

Spigner: The constitution, the other branches are way more qualified to deal with the constitutional change than we are. We need to learn how to better align our goals.

Grebe: What is your plan for evaluating spark?

Spigner L: they are starting to do more of SGA's program. We have changed Spark every year we have been here. There has made a 5-year plan. But the problem with this is that SGA needs to be a part o this conversation. We need to work together to rewrite the 5-year plan.

Harman: change the disconnect, how?

Spigner: Website mentions this more. Restructure the liaison roll. That roll really is there for the chairs. I want to require them to go to 2 meetings so they can understand what is talked about in these meetings. They will also be educating them on how the exec runs. Equipping all of our members with the organizational understanding is important.

Lee: Hi everyone my name is Louisa Lee, she her hers. I served as a freshman on exec committee. I am currently the vice chair. I have gotten a lot of experiences that not a lot of students on campus have had. My platform is data driven and development. CAC in 3D. I will be leading the charge; we will take feedback and enhance the experience. First, we need to set up standard procedure for data collection, importance of student feedback. Feedback on people who serve on our events. This would mean that every event would be involved in selecting a vice chair. We need to be actively pursuing feedback on students at OU. Before this we have never had a set up way to find out way. Take resumes out of exec committee applications. A resume is a barrier for students. I say that there is a place for people who don't have a lot of experience. Currently, every week we send out an email to all 800 members. External liaisons established to other RSOs open collaborations opportunities. We need to be willing to show that support. I have a lot more on my website. Chism: Currently CAC has own constitution, that is separate, and it is the only branch where all of them are separate?

Lee: great idea, I have no reservations with that. With collaboration with spark it is proven that we work better together.

Marvin: You mentioned opening positions for vice chairs and liaisons, accountable?

Lee: on exec community experience coordinator that hasn't been very defined. Vice chair on every event coordinating outreach and survey external experience but the coordinator would be overseeing them having one on one meetings. What this does is it gives our different events agency.

Marvin: Not in your opinion, and essay and interview would not give more context.

Lee: formal resume does not mean taking out opportunity to get to know applicants on paper. Freshman coming in should not be concerned in getting their resume together that week. We would discuss the alternative. Tell us 10 things you are really proud of or 5 things that would have accomplished.

Grebe: website?

Grebe: What are your plans regarding spark?

Lee: Sit on the 5 year plan meeting. Before this, spark exists in a way for students to join without a application. Students do not know this. We need to figure out a way to advertise this. The other candidate said to work with the other chair to establish this vision instead of starting from scratch.

Sertovic: I don't think I have seen Collab between CAC and IAC. Is there a reason for this? If it isn't an issue is it something that you are willing to work on? We don't have big numbers of attendance.

Lee: Jema has been in contact with them all year. Constant communication is better. Plan for external liaison with other orgs is to create constant communication. They offered us tickets for eve of nations. A group of us went to international prom. We are demonstrating support.

Chism: What is CAC doing to recruit diverse individuals?

Lee: We are going to organization and speaking to them. A lot of them are still not interested. The beginning of last year I created a video. We should not just be expecting people to know. We sent it to other orgs. The problem is that we are really reliant on social media, but this doesn't help. We need to be constantly communicating with other organizations. Constant communication demonstrates we support them.

Marvin: We went to the spring congress. 3 delegates that get to vote. Resolutions and bills to the regents and the state government. We are allowed to send more and proxy vote. We saw 33 pieces of legislations. We got to hear from the community colleges. We both passed resolutions Glasgow: a couple resolutions that passed, creating diversity training for PLC and other leaderships, self-defense classes worth 1 credit, increased awareness for human trafficking, tampons and feminine hygiene products free. We both passed pieces unanimously. Mine was free speech, organizations cannot be banned by speaking on campus.

Marvin: Mine was about ADA accessibility. I called on the regents and the board to make it required to post a report on how accessible their buildings are. Some university have 9 buildings and if they cannot access that building, they cannot go to class. This is calling anyone to change or restructure their buildings but this would hopefully make them embarrassed enough to do something about this. We can send as many people who want to go. You really get to meet a lot of people.

Glasgow: please go to the one in the fall it is really exciting

Buxton: When you go you represent OU?

Marcin: Yes.

CONGRESSIONAL BILL AB-103-08 SENATE BILL NO. GF19-XX

AS INTRODUCED

An act relating to appropriations; providing for short title; stating purpose; appropriating Auxiliary Funding for the 2019-2020 process; stating appropriation guidelines; establishing expiration deadline; directing transfer of unused funds by deadline; and providing an effective date.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION:

Section 1: This act shall be known and may be cited as the "Auxiliary Allocation 18 Act of 2019-2020"

Section 2: PURPOSE. The purpose of this act is to appropriate the funds of the University of Oklahoma Student Government Association to the organizations mentioned within.

Section 3: APPROPRIATION. The following amounts are hereby allocated to

Section 6: All unspent money remaining in the accounts listed in Section 3 shall revert to the SGA General Account after May 8, 2020, and the remaining appropriations shall be canceled.

Oklahoma Regents policy manual section 5.15.

of our University to fulfill their civic obligation to register and vote in their nations

State and Local elections.

of Oklahoma, in places of civic engagement, to consider the importance of a highly
