CB-102-20 Election Board Chair Appointment Act of 2019 (Ridenour/DeAngeli) (Congressional Administration > Do Pass)

CB-102-21 Parliamentary Clarification Amendment of 2019 (Bouch) (ConAd >Do Pass)

Bouch: This is a long bill, but I am going to try to make it simple. There is only a little change. I am making it more in line with Robert's Rules of Order. What used to be tabling to a certain time is now postponing to certain time, does same thing. Tabling indefinitely, is now postponing indefinitely, adding a motion that wasn't in bylaws, this is a general motion to lay something on the table. For clarification to take an item off the agenda until a motion to take off of table. Legislation has to be taken off table in the same body that it was tabled in. Legislation has to be taken off the table in the exact same state as when it was put on the table. But there is no set time or date to take them off the table. This is important because when Congressional Administration is seeing executive appointments, sometimes they do not show up because we aren't going pass a bill with no candidate, but now we can table is until they show up instead of continually guessing. Stack: If something is tabled, doesn't that allow for the legislation to stay in limbo?

Bouch: Theoretically, but that is essentially the same thing as postponing indefinitely. Postponing ends the discussion period for the end of the legislation session. Laying it on the table has the ability to take it off table, but we already have a different motion that does the limbo thing.

Patton: So, this new motion to take off the table, is there a second motion to take it off the table? Bouch: Yes, but the second motion does not need to be clarified.

CB-102-22 An Act Amending Title IX, Chapter 8, the Student Environmental Coalition, of SGA Code Annotated (Werdel) (Sustainability > Do pass) (ConAd > Do pass)

Werdel: Hi, this is a bill to update the Code Annotated. This will allow the code to accurately reflect the Student Environmental Coalition, that way people won't look at the code and think they act incorrectly. I took out the procedures for members elected and selected. I also took out how the organization must abide by the Open meetings act. We do not make decisions in that body. There should not have to be a process for who gets to attend meetings. I also changed officer elections. Our meetings are open, so anyone can attend them. The meetings are always at the same time, defeats purpose with an agenda and minutes. Broadbent: Would you accept a friendly amendment to strike section 47 as a whole?

### Werdel: Yes.

Broadbent: Would you accept a friendly amendment under section 42 officers, stricking "or consensus" from section b and adding "present" after SEC officer will be selected by a majority vote of current SEC members,"?

#### Werdel: Yes.

Broadbent: Would you accept a Friendly Amendment adding co-authors Tess McGee, Julio Rojas, Zoe Douglas?

Werdel: Yes

Tucker: In section b, it states that that SEC responsibilities are transferred, that is pretty vague, so how would these responsibilities get decided?

Werdel: The SEC is fluid, if the officer position were to go vacant someone in the committee would be able to pick how those would be delegated.

Tucker: To clarify, the committee would decide how process would be delegated? Werdel: Yes

Gau: Happy Voter Registration Day! Today, we made telling efforts with drive. This year we partnered with the Carl Albert center and registered over 200 students. We aren't finished. We have a booth in bizz right now. I would like a Friendly Amendment exclaiming our effort with students registered.

Bridwell: Would you accept a Friendly Amendment adding a whereas clause stating "On the 2019 National Voter Registration Day, the Undergraduate Student Congress and the Carl Albert center registered 200+ students to vote at the University of Oklahoma."

Gau: Yes.

CR-102-09 Sit Down (Thompson) (ConAd rec of no rec)

Thompson: I know everyone has been really excited about this bill but hear me out before you all jump to many conclusions. This is a Congressional Resolution to remove the flag salute from the agenda. Section 6.2 of the undergraduate student congress bylaws does not include the flag salute in our agendas. The Pledge of Allegiance was included between 2008-09 and was carried on because it was then tradition. In 1892 Youth's Companion weekly magazine, in honor of Columbus Day, they came up with the idea to instill nationalism in order to sell flags to public schools. The pledge led to sale of 25,000 flags. This was all in celebration of the 400th Anniversary of Columbus Day, ignoring his crimes against the Native American population. Lastly, the "one nation under god" speech conflicts with freedom speech in the 1st amendment.

Broadbent: How many Native American students did consult before writing this bill?

Thompson: I didn't. I have done lots of research, however. Norman does not celebrate Columbus Day because of his crimes against Natives.

South: Would you agree that saying the pledge promotes a sense of nationalism that doesn't belong in student body?

Thompson: Yes, over the years at this University there have been instances of black face and swastikas. There are few countries that have pledges, Nazi Germany is one and so is North Korea.

Ballew: Just to clarify you did not consult native tribes?

Thompson: No but I did a lot of research, the nationalism that this instills in inappropriate.

Gau: Did this resolution idea derive from a constituent complaint or from you?

Thompson: I have been a representative for 4 years. I haven't stood since then; I am a member of my college and all of whom I've talked to have agreed and were astounded that we stood. I did mention this to them, and I think it is the right call.

Gau: Would you say that the majority of your constituents would support this resolution?

Miller: Do you believe there are enough history books out there to make connection from flag to the issue regarding Christopher Columbus?

Thompson: Yes, I don't have to talk to black students at OU to understand that they feel discriminated. Columbus colonized villages and raped indigenous women.

Miller: Isn't it true that because the pledge is not in the bylaws, someone can make bill that formally inserts the pledge in the bylaws?

Thompson: Yes, this is just a resolution. I wanted to bring it to the Chair's that the majority of the body disagrees with the pledge.

Stack: Do you believe fellow SGA members feel ostracized by the pledge?

Thompson: Yes, it is a strange thing. It comes up in other situations. I have received threats of bad will against me for my refusal to stand for pledge.

Lange: So, you cite harms and you make connections to the abuse of the Native American population and you state how this is disrespectful for them and that this pledge instills nationalism, but how does the practice of reciting the pledge induced these harms?

Thompson: To allow the flag salute to continue is to be apathetic, apathy in the face of injustice is not justice. Marvin: ....

# Motion to extend time for questioning by 5 minutes Representative Stack seconded by Representative Mohamoud

Marvin: Would you be willing to do some salute to OU to remind ourselves of why we are here in the body? Thompson: That actually came up during the Congressional Administration committee meeting. Representative Hillis mentioned the alma mater. I would like to remind them that this is a congressional resolution merely asking very nicely for the pledge to be removed, if you want something to be added, feel free to write a bill.

Lissau: A couple colleagues of ours discussed your constituents, did you take a survey of all students? Thompson: I have been on campus for a long time. I am a 6-year senior. I have mentioned this to a lot of students. Some personally do not have any objections to the flag they understand why I am doing it. Spangler-Day: Are you aware of other organization who recite the pledge before their meetings?

Thompson: I would imagine some do but I don't believe that we should as a representative body.

Buckston: Outside of Columbus, how do you make that Italian born connection?

Thompson: The pledge was written in support of Columbus' 400th anniversary of coming to America. Ballew: Has anyone ever tried to force you to stand?

Thompson: No, but I have received declaration of bad thoughts towards me, people have shamed me and made me feel ashamed.

Lange: Who is benefited by disallowing a voluntary practice?

Thompson: I don't think anyone is suffering. The pledge states that there is liberty and justice for everyone but not everyone would agree.

Hillis: Did you know that the graduate student senate does not say the pledge because it is not in their agenda. Thompson: Yes.

Alpert:....

# Motion to extend time for questioning by 5 minutes Representative Gau seconded by Representative Hardt

Alpert: What authority do you have to make that claim equating the Nazi pledge to the American pledge, as a Jew I am concerned.

Thompson: Yes, in Germany, there was a pledge to the flag including a Nazi salute which is the extension of the arm. In Germany 1940s they did a pledge.

Wegersinski: Have you talked to the international students?

Thompson: We do have a lot of international students in the body, Sertovich let me know that this is something that doesn't happen in other counties, but they do not feel okay to pledge to a country that isn't theirs.

Garg: Could you elaborate on the freedom of expression portion of your bill?

Thompson: Yes, the 1st amendment right says we have the right to freedom of religion and to petition the government for grievances. If pledging to the flag stands for justice, we shouldn't have to pledge allegiance to this country because it doesn't always carry out justice.

Lissau: Do you not think it is hypocritical to change the pledge to the alma matter, considering this is the most racist institution in the Midwest?

Thompson: This bill is not in support for adding the alma matter, the flag salute is racist.

Lissau: You are generalizing pledge as racist, is it hypocritical to change it?

Thompson: I'm not asking to change it. That was mentioned, and if they want to change it, they can write a bill.

Broadbent: To reiterate, have you been punished by anyone in authority?

Thompson: No, but I have received death threats, and have been criticized by people who are in supported of it.

Miller: No one made you stand, but don't you think the social implications are enough?

Thompson: Yes, I do believe the social implications are more than enough to warrant this resolution.

# Motion to suspend the rules and extend time for questioning by 5 minutes Representative Spangler-Day seconded by Representative Stack

Thompson: I am a huge advocate for freedom of speech.

Werdel: Is it possible that saying pledge would reflect our desire to expand our reach to better our country? Thompson: That is a thought. I am of the personal belief that the pledge doesn't deserve that credit. I've learned about it in advertising class, that the nationalism behind the pledge is inappropriate.

Heuser: The fact is that it is not in the bylaws is reason enough to remove it?

Thompson: It is not in the bylaws therefore it has no reason to be in the agenda.

Spangler-Day: No one in the body got to vote to include the pledge?

Thom: No body has ever voted; it was simply put into the agenda without legislative action.

Patterson: Isn't it true that the passage of this resolution would not inherently change anything because it is just merely a suggestion to the chair?

Thompson: Yes, this is simply a request, to draw the attention of the executive of the body.

Stack: Doesn't this open door to someone that will make this a bylaw so that we have to say this pledge. That the pledge is tradition to hear it and people are afraid of change?

Thompson: I am inviting and opening the door for people to write this bill. But it needs to be evident in the bill and in the record why we added the pledge.

Hillis: Do you believe that international students in this body would or ever feel marginalized?

Thompson: Would the marginalized international students raise their hands?

Papanicolaou: Even though not everyone receives liberty and justice, isn't reminding ourselves striving for that?

# Motion to extend time for questioning to the end of the list Representative Tucker seconded by Representative Alpert

Thompson: The pledge says liberty and justice for all, but this is not a reminder, but it only instills complacency. It states that we are already a republic built on justice which I believe we are not. I don't think it is reminder.

Merchant: Is your issue with the pledge itself or with the fact that it is not in the bylaws? Thompson: Both.

Gau: Åre you aware that the supreme court stated that the pledge is secular, with no religious anecdote?/ Thompson: Yes, many have decided that it is, if you continue your research. That is why many states do not require this in schools.

Ballew: Given that I am a Cherokee, I'm curious, if everyone has the option not to, why it is important to remove this for the people who want to recite the pledge?

Thompson: It does matter when views are marginalized, ask me one question?

Ballew: Why is this your task without taking into consideration the views of the Native American population? Thompson: There are other Native American members who feel that this is related to Columbus. I have not been the only one who has sat. This is me taking action. This is inappropriate.

Cowley: Could please explain more your experience in this body that has made you feel uncomfortable? Thompson: This body is brand new, so I have had no instances, however bodies in my past, people made me feel uncomfortable and me sitting made them feel uncomfortable. Tucker: Reasonably what kind of change would this make in this environment and with students outside of congress in student concerns?

Thompson: It is honestly jarring to come to a meeting just to have to stand to salute the flag, in my time here, other students, this was a source of discomfort.

Lange: Would you say that history of pledge is common knowledge, that the perception is inclusive of racially sensitive connotation?

Thompson: No, I don't believe that people know the history, we should not turn a blind eye from it.

Something is inappropriate and we make change now.

Werdel: We bring the flag to do the salute?

Thompson: It can stay in the Conoco. For a while, we didn't have a flag, we used a picture on power point. Miller: The most important thing is that the flag doesn't mean the same thing to everyone else and it stands for oppression to some?

Thompson: Yes, it is inappropriate to enforce our interpretation of the flag on them. My mother is Latina and has always been harassed in America because of her accent. She did not receive liberty and justice.

Lissau: My biggest concern is talking to multiple constituents is important, if the resolution were to pass, would your committee survey the student body?

Thompson: It is interesting to mention student body was not addressed when we added the pledge. Write a bill to add the pledge but it was not addressed with the students. Just introduced.

South: If this hasn't been added to the bylaws, how has it remained?

Thompson: Under tradition it has been done before. That mindset of "always been done this way" is a dangerous and slippery slope.

Stack: In addition to the "under god", the Baptist church included that God hates fags.

Thompson: Yes, this language is inappropriate

Hillis: Even if it doesn't pass, wouldn't the chair be in violation because it is not in the bylaws if we keep going.

Thompson: This is a resolution so exec can make decision. It is up to exec to keep it or remove it.

Miller: Everyone wanting to vote against the bill should analyze why they are voting the way they are and try to understand people's point of view?

Thompson: Yes.

Harman: Mentioned early, constituents as a whole, you talked to them outside of you district, what district? Thompson: Humanities and social sciences, I don't know that what major they all fall into, no one was addressed when it was first added.

Spangler-Day: Frankly do the students care either way what we do in our meetings?

Thompson: There were students that sat for the pledge when they did come here. I don't know if they all have invested interest.

Gau: Will the passage of this resolution affect the general body meeting's future agendas? DeAngeli: Yes, we will remove it, if it is passed.

Ballew: It is evident that it is the will of this body and student body if they stood, I think that reflects the mood of the body?

Thompson: For 19-20 years of my life I stood. A lot of them said this before they realized the implications. Ballew: Why is it more important that the choice is removed given its an option?

Thompson: People can sit if they want to be part of the minority, the threats I get are fine because I am not a Person of Color, but if people want to salute the flag, they can do it on their own time.

Papanicolaou: Let's say we take the pledge out, what good is that going to do?

Thompson: The same reason removing Columbus Day from calendar in Norman. We are a more inclusive body. Shows what kind of body that we are.

Marvin: In the 8th whereas, where it says it is incompatible, with the first amendment, under god, it is known you do not have to say this phrase, god hates fag, but Lutheran church loves all, it's important to not generalize?

Thompson: I am LGBTQ and I am not religious. But I believe that there are Christian groups that support my community. While I do not think that under god is explicitly targeting the LGBTQ community, but other members are threaten by churches.

Garg: Does asking to stand gives pressure on the people to stand?

Thompson: Peer pressure is a real thing, not the same for when we are a kid, I sit at the front row of every meeting, I think that I am the only one event though I know I'm not.

## Motion to recess for 5 minutes Spangler-Day seconded by Representative Mohamoud

Sertovich: Pledging represents pledging to the country, this community does not represent the country but the student body, we only represent American student when in reality 10 percent of students are international. Would we bring our own flags and sing our own national anthem would that be appropriate, if it passed? We would pledge allegiance to flag of Oklahoma.

Gau: We are here to represent the student body's interest, when you vote, vote to what the majority of your constituents think about this bill, do they believe we need to get rid of the tradition? The major of my constituents would vote to keep the pledge here. My district along with many other is very representative of the OU community and would disagree with the passage of this resolution.

Merchant: As a woman of color, daughter of immigrant, minority, while you are thinking about bill, keep in mind LGBTQ students, immigrants, international students, women of color. Reflect on yourself and what it means to be a representative. The only reason I stand is cause I'm at the front where people can lose respect if they see me sit. Lauren talked about how we reflect on ourselves. Everyone on the opponency has one thing in common.

Lange: I am not a bible thumping red blooded American, I don't think the pledge offers much to the meeting. I have stood at the meetings. How is it that the practice induces harms it fails to solve them people are suffering? We are just changing a normative experience to a positive, people don't have common perception of author ship. If we are not seeing any harms, and it is not in bylaws, no problems are caused, nothing is solved, the option taken from those who want to. Those who feel ostracized to sit or stand, hold vast in your rebellion.

Tucker: Nowhere in the bylaws does it say that the pledge is to be recited, that doesn't mean that it is prohibited, this body in the past or present has once voted on saying the pledge, it is not something the body decided on. If the body wants to write it into the bylaws, we will see it. If you take away ideology it is simply something not in the bylaws, we as representatives need to reach out and see what our constituents actually want, many people who do feel uncomfortable sitting down.

Broadbent: As an LGBT citizen of the Cherokee nation, my family walked trail of tears into Oklahoma, whose land you are standing on. The author's lack of knowledge in consulting Native Americans and using racism against them to get rid of the pledge. In in certain tribal nations, schools just say the pledge, if you consider the pledge as racism, would you agree that voting is racism because People of Color are disenfranchised by voting, do you not give up power? Slave owners wrote the declaration and the constitution, do we consider this?

South: I am of the Choctaw nation. I have a quote: "Compromise where you can. Where you can't, don't. Even if everyone is telling you that something wrong is something right. Even if the whole world is telling you to move, it is your duty to plant yourself like a tree, look them in the eye, and say 'No, you move"-Captain America, we have to think of the will of the constituents, the majority may not be in favor, simply because they think it's right, it must be right, simply because they may think it is right does not make it right. We need to stand on the side of justice because the arch of history will always stand on the side of justice. Cowley: This is a resolution not a bill. I am standing here as a Cherokee nation citizen so let me discuss my personal experiences. When I was 8, being in the Cherokee nation in youth choir, I learned the pledge in Cherokee and star-spangled banner. We went to the veteran's hospital recite the pledge to them and I want to point out that no matter where something starts, it is about where is is continuing to go. The 400th anniversary doesn't mean what it is now. My great-grandmother was an English immigrant. It's what you do with what you have. Where we are going.

Stormer: This is a quote from Justice Stone in a case about the pledge, the very essence of liberty is what they shall think or say, but being forced or to make necessary creates a false sense of unity. Force compulsion does not create a sense of unity, pluralism is a real celebration of individuality. Saying that is something that you

just do does not justify doing it. I am the only straight right male on this side and have no problems standing but that does not mean I can't relate with my peers.

Marvin: To further clarify the incompatibility with the pledged under god conflicting 1st amendment, it can be argue to make a point to take it away, we are taking away our right to express our beliefs, I have the right to say nation under god just like someone else has the right to not say under god, I will say I do not support anyone calling them out in a negative way and no one should feel ostracized, you should not say anything negative. They should not feel left out because it is still their right. Making a point to take it away infringe of freedom of speech.

Heuser: You could remove every whereas statement after the first one but the resolution will still hold the same weight, just because it isn't in the bylaws doesn't mean it cannot be in the order of business, we have not had the chance to vote. How can we call ourselves a democratic body if we cannot vote. I want a chance to vote.

Lissau: To clarify democratic institution, we serve the people we represent, ignored the fact with the student body and that they would be okay with this. No one on the opponency wants to segregate the person sitting. We are not going to threaten you because that is your right. We want to create an inclusive environment. It is your right to do so and not to do so. We should be passing a resolution condemning what happened two days ago, not this.

Stack: No one voted in favor, we did not ask representative, how many people say this more times a week? I don't know it feels like representatives don't care what we do, what I do here, they don't care, and it is not the biggest concern. Karl Marx once said....

Emini: I am just going to say this to confront the accusation of everything one side has in common. I am a child of 2 immigrants, my parents came to America to have a better life, I am proud to say the pledge because my parents were not able to. If you feel the need to sit because of the pledge that is your right, you should not feel isolated because that is what you believe in. No one else's opinion should matter.

Miller: I am an active member in my tribe, I am also the Human Diversity chair. I talk to many constituents of color; the pledge does make them feel a certain way. It is oppressive. We do important things in 2007 before the pledge and will continue to be important in congress after this meeting. It is not in the bylaws, if you feel passionate in this, write it. This is divided enough as a body and it should not be here.

Papanicolaou: Just to mirror what Emini said, I am a son of family of immigrants, that flag means more to me than stars and stripes, it means hope and freedom, it is a choice to come to this nation, that flag is not just considered racism. It is a reminder of unity and everything else the country stands for.

Mohamoud: It is important to remember that African Americans did not come here by choice. It makes students uncomfortable. When I joined SGA, I felt uncomfortable because it is not welcome to everyone. I come from Somali and I am not a citizen, but it is not important for us to do something that is not required. I have my own freedom to bring my own life here.

Bridwell: Part of getting rid of pledge would be getting rid of the flag, but the flag serves as a symbol of the ideas of America and the men and women who fight for this country. It is important to me and many of us to have that remind of what our country has gone through. We all need to remember this.

Hillis: The pledge is not in bylaws, regardless of nationality, it is in violation of bylaws. It should be taken out just because of that. Do you guys talk to your constituents about auxiliary bills, or the voter registration bill? Just because we haven't talked to them doesn't mean they cannot call for it.

Ballew: I've lost family members in service of the flag, you have a choice, if you don't want to stand, that is what people died for you to have that choice. All I ask is that you give me the option to pay respect. We do not want to make anyone feel like they do not belong here or make them feel uncomfortable. The absence of the pledge would make me feel uncomfortable. I value that choice.

Spangler-Day: The question is not why we shouldn't, but why should we? This was not voted on, we did not consult our constituents 10 years ago when they put this in, why should the obligation be on us. I want to bring up a point about the symbolism of the flag, the beauty of political symbolism it is in the eye of the individual, to some it is nationality, but to others it is a bunch of negative things. The flag doesn't have to leave.

Garg: I am Person of Color from a diverse country, India. Diversity is sometimes respected and sometimes not, I also respect the freedom of expression the country provides, case study of India, 2014 government

made it mandatory for people to stand in the movie theater, but this action led to mob violence, arrests and people throwing them out. The US does allow for sitting but it could go the wrong way. The fact that it is being conducted in congress gives us some kind of pressure.

Schneider: Reiterate that this body doesn't not represent Oklahoma or the government. This body includes international students. We should not make them say the pledge to a country they do not belong to. I grew up in military bases, my family did not serve to be glorified through a flag, but they served for the freedom of expression.

Bouch: I know this has been a long night, I really just ask you to listen to the last two speeches. I want to lay the issues clearly before you, please keep an open mind. I want to start off with issue 1st amendment, supreme court cases when it violates the 1st amendment right, they have decided that everyone in the country has the right to sit. They may exercise that right if they do not wish to say the pledge. I don't think that under god while it may have been written with Christian backgrounds, in a modern context can be implied under Christian background. The pledge means something different to every individual. What the pledge means is entirely up to you. You have your own reasons for doing what you wish. The nature of the pledge has change throughout time, to provide more context to the research the author, the pledge was written by a socialist in a time when socialists were imprisoned, the original text of the pledge of allegiance was written "I pledge allegiance to my flag for which it stand" further, the other nations have pledges, Mexico, India, and Singapore have them. Texas schools are forcing students to say the Mexican pledge. Written by a socialist. 1923 words were changed to "my flag" were changed to "the flag of US" then "of America" added in 1942, after fall of Nazi, we removed the extension of the arm, because that salute did not mean the same thing because that is not what the salute wasn't meant to be. "under god" was put into the pledge because of the rise of socialism and atheism was bad and Christianity was good. The pledge has not been updated but our perception changed over time. Before 9/11 only schools said it. In Oklahoma 2014 it was required to say it once a week. After 9/11 it was seen as a rallying call. Citizens of not just US were killed. We started saying it because there was something bigger than ourselves. I can get up here and say this and that's my view of the pledge and I am willing to fight and die for this meaning. Someone else can say that the pledge and flag is a symbol of people who were never given those right. When you cast your votes remember what it is meant to be is a reminder of what you think liberty for all and justice truly is and when you sit down, that is a reminder of what should change. A lot has been said that it isn't in the bylaws and that is independently, and we should take it out. The mission statement is not in the bylaws that we say that. We shouldn't also say the mission statement because we haven't voted that. Don't say the mission statement and that it should be removed.

Hardt: Everyone is crazy, this isn't the flag, whether is it in the bylaws, not too. This has gone so long, it is 9:30, we are going to be here until 10.

Miller: I'll make this quick, many of the opponency, even though are people of color, they pass as white, which means you don't experience many of the same things other people of color do. The constituents don't care what we do. We are not against the flag, but we are against the pledge. I do also have family members who have served and died for the country. I do not equate the love for my family to the flag, the mission statement is applicable for what we were going. Think of the body, what it means to you does not mean the same to everyone else, but compassion and empathy for other is important enough.

Thompson: Thank you all, this is what I wanted to have I was tired of unanimous voted, we should be acting as such instead of passing things just to pass them. Different countries that have pledges, they are not a democracy and do not stand for freedom in the same way that we say. The Indian pledge was repleaded in 2019 because of mobs and violence. While we do idolize veterans, we should support, and if you look it up, a lot of veterans are against the pledge of allegiance. Silence in the face of unjust is complicity in the face of the oppressor. There is a lot of people who are hurt more than helped with this. If we removed this, why would the cons care? Thank you for contributing.

# BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION:

- Section 1: Title: This act shall be known and may be cited as the "Indigenous Land Acknowledgement Act."
- Section 2: Purpose: The purpose of this act shall be to implement an Indigenous Land Acknowledgement (ILA) statement as campus-wide introduction that shall be recited before designated events in order to honor the Indigenous community on campus as well as the rich American Indian heritage and history of our University and state.
- Section 3: NEW LAW: A new chapter and Title is hereby established in Title XII of the Code Annotated to read as follows:

### Title XII: Tribal Recognition Chapter 1: Indigenous Land Acknowledgement

1. ILA Template

"Before we begin today, The Student Government Association would like to take a moment to honor and recognize the rich heritage and traditions of the land and its peoples on which we are gathered today.

Long before David Ross Boyd envisioned the University of Oklahoma, the land on which we gather today served as a site of meeting and exchange amongst many Indigenous peoples. Tribes such as the Caddo and Wichita and Affiliated tribes called

this land home long before the University of Oklahoma was established. Today, 39 tribal nations dwell within the state of Oklahoma as a result of policies that were designed to assimilate Native people and strip them of their diverse and sacred cultures and traditions.

This land acknowledgment statement is a public expression of gratitude and honor for the people who have been living on and cultivating this land from time immemorial. Today, many Native people represent their families and tribes from across the land as Indigenous students, faculty and staff here at the University of Oklahoma.

The Student Government Association / Campus Activities Council / Undergraduate Student Congress / Graduate Student Senate would like to acknowledge that today...

We are visitors on this land.

We are thankful for the privilege and opportunity to be visitors. We would like to recognize all of our Indigenous people who are present today and honor them for allowing us to gather here with them."

# BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION UNDERGRADUATE STUDENT CONGRESS:

- **Section 1**: Title: This act shall be known and may be cited as the "Parliamentary Clarification Amendment of 2019."
- Section 2: Purpose: The purpose of this act shall be to Amend Section 3.1 Definitions, of the Undergraduate Student Congress Bylaws.
- **Section 3**: All items removed shall be denoted with a strikethrough. All items added shall be denoted with an <u>underline</u>.

For the purpose of the SGA Undergraduate Student Congress meetings, the following definitions shall be regarded as the official definitions for the following items:

1. Amend: Inserting or deleting words or paragraphs or substituting whole paragraphs or resolutions.

2. Appeal Decision of the Chair: Appeal for the assembly to decide- must be made before other

business is resumed. This is not debatable if the motion relates to decorum, violation of rules, or order of business.

Commit to Committee: The Chair will state the committee to receive the act or resolution.
 Committee of the Whole: The assembly as a whole moves into a committee; this

committee may limit number or length of speeches or close debate by other means by a 2/3 vote. Committee of the Whole is often used to see bills that may have been missed in committee but should, for some emergency or specific reason, be seen in that general meeting.

5. Consent: A motion by the body to adopt an act or resolution by unanimous consent. If an objection is heard by a voting member, consent is withdrawn.

6. Dilatory: Tactics used to delay or obstruct business, annoy the deliberative assembly, or delay consideration of a subject. Reasonableness is often used as a criterion deciding whether a motion is dilatory.

7. Divide the Question: Divides a motion into two or more separate motions (these motions must be able to stand alone as motions).

8. Long Title: Description of the legislation's purpose and effects. This may include things such as the short title, providing for an effective date.

9. Main Motion: Brings the next item on the agenda before the assembly. Main motions are made while no other motion is pending.

Section 1:	Title: This act shall be known and may be cited as the "An Act Amending Title IX, Chapter 8, outlining the Student Environmental Coalition."
Section 2:	Purpose: The purpose of this act shall be to amend the Student Government Association Code Annotated regarding the Student Environmental Coalition in order to accurately reflect the operations of the Coalition.
Section 3:	AMENDATORY: Title IX, Chapter 8, is amended as follows. All additions are <u>underlined</u> and all deletions are marked with a strikethrough:

# 40. Delegation Purpose

The SGA Student Environmental Coalition, "SEC," will ensure that various environmental groups communicate well to accomplish goals in the most effective way possible and serve as environmental advisors to the campus at large.

# 41. Membership Requirements and Responsibilities

All students currently enrolled at the University of Oklahoma shall be eligible to submit applications. These applications shall be reviewed and interviews shall be held by the executive members. serve as a representative for any campus environmental initiative, RSO, or non-student organization. Faculty and staff are also eligible to serve on the coalition in order to speak for university-based initiatives. Students must remain in good standing with the University.

# 42. Officers

The officers of the organization shall be Chair, Vice-Chair, Communications Director, and Secretary.

# a. Eligibility

Members of SEC in good academic standing will be eligible to run for office; the chair of SEC must have adequate time to devote towards stewarding the council.

## b. Selection

SEC Officers will be elected by a majority vote or consensus of current SEC members present. Current SEC members shall be defined as members who have attended at least sixty percent of the meetings of the previous semester.

## c. Term Length and Limit

All SEC Officers will be elected for one academic year. With exception of the Chair, officers may serve for more than one academic year.

## d. Responsibilities

The Officers will work closely with the SGA and, most importantly, the various Registered Student Organizations related to Environmental Sustainability to ensure the mission of SEC is actualized.

### e. Vacancies

If a vacancy arises, an ad-hoc election will be held for the corresponding position. Until that election is held, the position immediately subordinate (Descending from Chair to Vice-Chair to Secretary to Director of Communications) will serve as the interim officer; if the Secretary resigns, the Director of Communications will assume those responsibilities. an interim officer will be chosen by the current members of the SEC by majority vote or consensus. The coalition will decide how officer responsibilities will be transferred for the remainder of the academic year.

# f. Officer Removal

The SEC shall have the authority to remove an officer with a simple majority with the advice and consent of the legislature.

# 43. Internal Proceedings

The Student Environmental Coalition shall establish rules of procedure for the internal operations for the organization. These rules shall be published and available to students upon request. Any proposed and adopted rule changes must be sent to the SGA President, Graduate Student Senate Chair, Chair of the Undergraduate Student Congress, and Campus Activities Council Chair.

# 44. Meetings

# a. Meeting Times:

The Chair of the SEC shall establish meeting times for the full academic year <u>academic semester</u> by the third academic week of the fall <u>each</u> semester. The meetings shall be open to the public and are subject to the Oklahoma Open Meetings Act.

## b. Attendance:

Members will be allowed two excused absences (outside of academic obligations) with prior notification to Chair or Vice-Chair. An unexcused absence without notification will count as strike, and after three strikes the membership will be under review.

The SEC shall function as a resource to members. Responsibility to attend shall be strongly advocated for by the officers. SEC members must attend at least sixty percent of the meetings in order to vote in officer elections.

## 45. Power and Authority

The SEC shall be empowered to create any such committees, boards, commissions, or other such entities that it deems are necessary to further its purpose.

## 46. Funding

The SGA Student Environmental Coalition shall be provided financial support through the Executive Branch.

## 47. Student Advisement

The SEC shall report to the SGA Vice President Eaculty Advisor for advisement on major initiatives or changes.

**Section 4:** This act shall become effective when passed in accordance with the SGA Constitution.

## A Congressional Resolution to remove the flag salute from the University of Oklahoma Undergraduate Student Congress Agenda

Whereas:	In Section 6.2 of the Undergraduate Student Congress Bylaws, there is no flag salute in the Order of Business for General Meetings.
Whereas:	The flag salute began being included in USC agendas between 2008-2009 without any legislative action; and since has been carried on simply because it was there before.
Whereas:	The Pledge of Allegiance was first published in the September 8, 1892 issue of a weekly family magazine called the Youth's Companion.
Whereas:	This issue of the Youth's Companion was celebrating the National Public School Celebration of Columbus Day.
Whereas:	James B. Upham, marketing lead for the magazine, came up with this idea to instill a feeling of American nationalism in schools and sell flags to schools.
Whereas:	The Pledge of Allegiance lead to the sale of 25,000 flags to schools and government offices in the U.S.
Whereas:	The Pledge of Allegiance was written for the 400th anniversary of Christopher Columbus' discovery of America, ignoring Columbus' occupation and abuse of natives and their land.
Whereas:	The Pledge of Allegiance is incompatible with the U.S. Constitution's First Amendment as pledging your allegiance to the flag of the United States as one nation under God conflicts to our rights to free exercise of religion, freedom of speech, and to petition the government for redress of grievances.
