- Black History Month Presentation

Paul Robeson was an African-American athlete, bass-baritone, stage and film actor, linguist, political activist, and leader of the Harlem Renaissance. Robeson went to Rutgers University on an athletic scholarship where he was a 2x All-American. He is a College-Football Hall of Famer and was listed as the 2nd best Defensive End by ESPN in 2016. Robeson graduated

from Rutgers as his class valedictorian and went on to receive his LL B from Columbia Law while playing in a small league known as the NFL. Afterward, Robeson began his career in the Fine Arts in plays such as

The Emperor Jones

and

All Gods' Chillun Got Wings.

In his career, Robeson wrote 276 songs spanning over many genres including Americana, popular standards, classical music, European folk songs, political songs, poetry, spoken excerpts from plays, and most famously, his recording of negro spirituals. Robeson

moved his career to Europe and settled in the U.K. for a majority of the 1930s. Robeson was summoned by the King to perform at Buckingham Palace. There he befriended many MPs from the House of Commons. After a continuing successful and ideological awakening,

Robeson refused to perform in European operas because the music had no connection to his own culture. In 1934, Robeson began studying Phonetics, Swahili and multiple other African languages. Robeson went on to tour Europe where he stopped in Berlin and Moscow.

In Berlin, Robeson became enlightened to the racism in Hitler's Germany. However, in Moscow, he became enlightened to the opposite, explaining how the Soviet Union didn't hold the same racial bias as the US.Robeson took a series of roles that gained him international

fame but elucidated to him the stereotypical nature of his performances. Afterward, he became more politically conscious and sacrificed his own career to combat racial stereotypes in American Cinema. In 1936, Robeson sent his son to school in the Soviet Union

to shield him from racial attitudes in the west. Beginning in 1937 Robeson started to support the fight against fascism in the Spanish Civil War. Singing to troops and performing shows Robeson did what he could in the fight against Franco's army and right-wing

extremism taking hold of Europe. He used songs from his past discography and changed the lyrics from those relating to the African American struggle to the struggle against Franco's oppression. "But I keep laffin'/ Instead of cryin'/ I must keep fightin'/

Until I'm dyin'"

Paul Robeson continued to be politically active even after his agent strongly discouraged him from it. His reasoning, "The artist must take sides. He must elect to fight for freedom or slavery. I have made my choice. I had no alternative."

At the outbreak of World War II, Robeson returned home where he became "America's no. 1 entertainer."

However, that title still did not afford him to stay in all but one of Los Angeles' hotels while on tour, only at an extremely high rate and under an assumed name. Therefore, he dedicated two hours a day during his stay to sit in the lobby where he was widely

recognized "to ensure that the next time Black[s] come through, they'll have a place to stay." LA soon lifted its restrictions on people of color staying in their hotels. Finally, after starring in films that were either labeled by the government as communist

propaganda or ones that he hated for stereotyping African-Americans, Robeson retired from the film industry.

After the War Robeson met with President Truman to protest the lynching epidemic in the south with Robeson stating that if he did not enact anti-lynching legislation then ." . Robeson warned there would be a civil uprising if action were not take. Truman refused his pleas, believing it not the right time to address that issue. This spurred Robeson

to start the American Crusade Against Lynching. After receiving support from W.E.B. Du Bois, the organization launched on the 83 anniversary of the Emancipation Proclamation. His political actions came under the question by the Iudiciary Committee. When they

questioned if he was a communist Robeson said, "Some of the most brilliant and distinguished Americans are about to go to jail for the failure to answer that question, and I am going to join them, if necessary." In 1948, Robeson risked his life by going to

the Deep South to campaign for Henry Wallace. Afterward, Robeson had to begin working overseas after the FBI canceled many of his concerts. While there, Robeson gave a speech that condemned American militarism and called for African Americans not to fight

for "those who have oppressed us for generations. This caused him to be blacklisted in America with publications refusing to acknowledge his All-American honors at Rutgers, canceling television appearances and denying him a passport. The FBI orchestrated a

defamation campaign against Robeson in Africa. In '56, after refusing to sign an affidavit denying that he was a communist, Robeson was called to testify to the HUAC. When asked why he had not remained in the Soviet Union because of his affinity with its political

ideology, he replied, "because my father was a slave and my people died to build [the United States and], I am going to stay here, and have a part of it just like you and no fascist-minded people will drive me from it!" later stating, "Whether I am or not

a Communist is irrelevant. The question is whether American citizens, regardless of their political beliefs or sympathies, may enjoy their constitutional rights." While his passport was locked, Robeson would perform to concert halls over the telephone with over 5,000 gathering at one point in London.

Finally, in 1958 Robeson had his passport cleared and resumed his world touring until his retirement in 1963. Robeson enjoyed a long 13-year retirement that ended with his passing on January 23, 1976. Paul Robeson died with a controversial legacy, it was one that did not deserve to be erased from American memory. Although Robeson was a defender of the Soviet Union's authoritarian practices, his contributions to American and global culture shall not be forgotten. His incredible talent, smarts and athletic ability is the gold standard for Americans.

I encourage you all to think about the man you learned of today and implore you to find Robeson's courage within yourself and to think of a quote I have had on my desk in my room, "As an artist I come to sing, but as a citizen, I will always speak for peace, and no one can silence me in this."

CONGRESSIONAL BILL AB-103-06 SENATE BILL NO. GF19-XX

AS INTRODUCED

An act relating to appropriations; providing for short title; stating purpose; appropriating Auxiliary Funding for the 2019-2020 process; stating appropriation guidelines; establishing expiration deadline; directing transfer of unused funds by deadline; and providing an effective date.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION:

Section 1: This act shall be known and may be cited as the "Auxiliary Allocation 16 Act of 2019-2020"

Section 2: PURPOSE. The purpose of this act is to appropriate the funds of the University of Oklahoma Student Government Association to the organizations mentioned within.

Section 3: APPROPRIATION. The following amounts are hereby allocated to

Section 5:	This fiscal year for the account listed in these sections shall end May 8, 2020			
Section 6:	All unspent money remaining in the accounts listed in Section 3 shall revert to the SGA General Account after May 8, 2020, and the remaining appropriations shall be canceled.			
Section 7:	This act shall become effective when passed in accordance with the SGA Constitution.
