## CR-104-14 Pass/No Pass Policy Recommendation of 2020 (South) (Exec, Do Pass)

## **Representative Hillis seconded by Representative Bryant**

South: Good evening everyone, thank you all for being here! As you all know, this is CR-104-14, the Pass/No Pass policy recommendation of 2020. Before I get to the specifics of the resolution, I'd like to make the body aware of what their fellow students are going through this semester. As I'm sure all of you are aware, a petition has been circulating calling for the implementation of a Pass/No Pass grading option for this semester. Nearly 3,400 people have signed this petition, and several have shared their stories in the comments of the petition, and I'd like to read a few of those to you all.

One student said "Most professors and students are not properly equipped for a still-sudden shift to nearly-all online work. Simply because students had a couple months (during a nationwide crisis) to notice that certain classes will be online does not mean they were magically able to be more prepared. Not only has the pandemic worsened, but the strenuous nature of the virus has stretched students thin in terms of their time and in terms of their health. This pandemic is not what I am capable of. This pandemic is an example of what I can do when my mental and physical health is pushed past its limit, NOT what I can do as a healthy and focused student. To ignore the concerns of students and write this off is to essentially let us drown in our own nightmares." Another student was more concise, saying simply "one does not simply learn advanced mathematics on a zoom chat." A senior wrote in saying "I'm a single mom homeschooling a small child, can we not tank my GPA my senior year?"

There are students across this campus who are suffering academic harm through no fault of their own. Personally, I believe that telling students to suck it up deal with hurt GPA's, poor mental health, and a global pandemic is unbelievably cruel. That's why this resolution is here today. This resolution calls for the same policy as last semester to be adopted with an exception. After talking with the faculty senate and studying the plans of other universities that are adopting Pass/No Pass policies, we determined that it could be more harmful to students to allow D's as passing grades, so the threshold this semester would be moved to a C. Other than that, we are advocating for the same policy as last semester.

## Ext 3min Representative Buxton seconded by Representative Harman

South: Finally, I'll need the following friendly amendments: Adding a section after section 3 saying: Students should be aware that in order to qualify for the President's and Dean's Honor rolls, they must retain a minimum of 12 letter graded credit hours. Undergraduate Students should also consider the consequences of opting in to a pass/no pass system with regard to graduate school applications, as some graduate schools will not accept pass/no pass grades and appeal processes to reverse the decision are cumbersome and not guaranteed. Before making a decision, Veteran students and dependents should consult the Veterans Affairs office to determine potential effects on tuition, fees, and housing stipends. FA adding Savanah Patterson as a Co-Author, and adding anyone who wants to be a co-sponsor as a co-sponsor.

Buxton: Thought about adding statements in authors ex into a whereas clause?

South: Not thought about that. Whereas sections already lengthy and already covered in what we said. Privacy reasons as well.

Buxton: FA adding a co-sponsors list to legislation?

South: Yes.

Nath: Does it apply to fall? Or also into intersession?

South: Not intersession, however this has not been a main point of conversation with the Faculty Senate, open to discussion.

Thomas: Giving students to pass a class lowers academic standards?

South: No. Policy last and this semester is designed to help students trying their best in classes but are overwhelmed. More people in that situation will use it. People are still trying their hardest and giving them the option allows them to keep an A.

Thomas: Any other similarly sized universities passed this policy yet?

South: Yes. UC Irvine and University of Southern California have similar policies. Petitions at OSU, Texas A&M.

Buxton: FA adding a section after section 3 with 12 credit hours, grad school, veterans should consult VA office. Also Patterson and Buxton as co-authors.

# <u>CB-104-05 Farewell OrgSync Act of 2020 (Hillis/Halsey-Kraus) (ConAd, Do Pass)</u> **Representative Broadbent seconded by Representative Stormer**

Halsey-Kraus: Over the summer, SGA changed RSO management platforms from OrgSync to ENGAGE. Therefore, the Code needs to be annotated.

Harman: How many times is OrgSync mentioned in the Code?

Hillis: a lot.

CB-104-06 Bye-Bye OrgSync Act of 2020 (Hillis/Nath) (ConAd, Do Pass)

# Representative Douglas seconded by Representative Lynskey

Nath: Halsey-Kraus went over everything. It's the same thing, but this changes the Bylaws. The Bylaws mentioned OrgSync once and that's what we're changing.

Broadbent: Hillis, is OrgSync anywhere in the Constitution?

Hillis: No.

# AB-104-08 Auxiliary Allocation Act 6 of 2020-2021) (Patton) (WAM, Do Pass)

# **Representative Smail seconded by Representative Chenevey**

Patton: Hi. This is aux 6. Only had 1 application we were able to fund. The other asked for t-shirts and we do not fund t-shirts! Only Asian American Student Association and gave them \$2400.

Broadbent: How much did they request?

Patton: We gave them about half. \$4805. That's a \$3000 increase based on last year.

Broadbent: What didn't you fund?

Patton: For a food fair, one event. Funded half of it.

Harman: What's the other organization not funded?

Patton: Pre-Medical Professions Club.

Harman: Were they informed about why?

Patton: Yes, I said we don't fund t-shirts. It's on the application.

Patterson: How many aux applications do we have pending?

Patton: Around 10.

#### Follow-Up Reports Items for Future Agenda Announcements and Comments

Harman: Please send the link Mahak dropped to your RSOs. We only had 3 last I heard. It's a wonderful product drive, we're pairing with the GEC.

Broadbent: Attended Multicultural Programs and Services Retreat over the weekend. One section was advocacy. I'm going to ask kindly to not participate in Big 12 with Baylor participating. Policies against LGBTQ+ individuals, this doesn't represent our values. It should be my job to go to this meeting this weekend. I will not participate in something hosted by Baylor.

Nath: Panel on racism and xenophobia. Students will talk about their experience in academia. October 30<sup>th</sup> from 6-8pm, Zoom option, sending it in the group.

Patterson: Give a round of applause to South who worked so hard for weeks. First person I know of who got a meeting with Faculty Senate, it's super important for students.

Marvin: I went to OSGA in the spring and wrote legislation for OSGA. Last semester, if you're going to OSGA, we want to see it or talk about it in the body. We want a consensus in our own body to represent OU SGA in general. I enjoyed it. OCU and UCO have a huge turnout every year. I'd love for us to get involved in that. I want to support other Oklahoman universities.

South: I appreciate the love. Shoutout to Malachi and Dalton for the help on this. Jamie Archambeau is the one who started the petition, in ROTC with me. Without that we wouldn't be in the place we are now to advocate for this. Has the potential to really do a lot of good for students.

# CONGRESSIONAL RESOLUTION CR-104-14 SENATE RESOLUTION NO. GFXX-XX/GSXX-XX

## AS INTRODUCED

A Concurrent Resolution recommending the University of Oklahoma adopt policy for the Fall 2020 Semester; and providing for distribution.

- Whereas: The ongoing COVID-19 Pandemic poses unique risks and challenges which have significantly altered higher education;
- Whereas: On October 6, 2020 the University of Oklahoma announced a transition to all online classes for the three weeks remaining after Thanksgiving Break;
- Whereas: The University of Oklahoma adopted a policy in Spring 2020 which allowed classes to be graded on a Pass/No Pass basis;
- Whereas: The Pass/No Pass policy for the Spring 2020 Semester was put in place to mitigate academic harms that occurred due to the COVID-19 Pandemic and its ramifications, all of which are entirely out of the direct control of individual students;
- Whereas: Students across all Academic Districts have experienced and continue to experience academic harm due to the COVID-19 Pandemic;
- Whereas: Students have been forced to take on additional non-academic responsibilities, such as childcare, job searches, and working more to meet financial needs;
- Whereas:Students have individually reported poor mental health as a result of the COVID-19Pandemic, consistent with expert expectations regarding mental health;1
- Whereas: The aforementioned challenges, along with an online learning environment which is new to students and faculty alike, have produced a fundamentally altered academic experience;

BE IT RESOLVED BY THE UNIVERSITY OF OKLAHOMA UNDERGRADUATE STUDENT CONGRESS AND THE GRADUATE STUDENT SENATE, CONCURRING THEREIN THAT:

- Section 1: Title: This resolution shall be known and may be cited as the "Pass/No Pass Policy Recommendation of 2020."
- **Section 2:** The University of Oklahoma Student Government Association recommends that the University of Oklahoma adopt a Pass/No Pass grading policy for the Fall 2020 semester.
- **Section 3:** Such a policy ought to be identical to the Spring 2020 Pass/No Pass policy for sake of consistency, with the single exception that at the Undergraduate level, all grades of C or higher be convertible to a Pass, while grades of D or lower be convertible to a No Pass.
- **Section 4:** Students should be aware that in order to qualify for the President's and Dean's Honor rolls, they must retain a minimum of 12 letter graded credit hours. Undergraduate Students should also consider the consequences of opting in to a pass/no pass system with regard to graduate school applications, as some graduate schools will not accept pass/no pass grades and appeal processes to reverse the decision are cumbersome and not guaranteed. Before making a decision, Veteran students and dependents should consult the Veterans Affairs office to determine potential effects on tuition, fees, and housing stipends.

SENATE BILL NO. CB-XXX-XX

#### AS INTRODUCED

A Congressional Act of Legislation to update the platform "OrgSync" in the Code Annotated; providing short title; and providing an effective date.

### BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION UNDERGRADUATE STUDENT CONGRESS:

Section 1: Title: This act shall be known and may be cited as the "Farewell OrgSync Act of 2020"
