## Representative Halsey-Kraus seconded by Representative Hale

**President Farzaneh:** We are appointing Isaac Kabrick to be Election Commissioner. He has experience with the Election Commission. Mr. Kabrick said, and I quote, "I love rules." I truly believe in his ability to serve as Election Commissioner.

**Kabrick:** Hi Everyone! My name is Isaac Kabrick (he/him), and I am a six-year senior studying civil engineering and public and non-profit administration on a pre-law track. Basically, all that means is I like roads and I am bad at graduating. I have served as an Election Staff/Commission member. I worked on elections for other organization such as the Housing Center Student Association and the International Advisory Committee. I like rules.

Kathuria: How will you enforce the rules?

**Kabrick:** I will enforce the rules to the letter of the Code Annotated. I like rules because they help create a better space for democracy to happen. I think we have a good set of rules for elections on

this campus. Informing candidates of the rules is the best to enforce them. Rules are meant to be consulted not memorized.

# Motion to see CB-106-10 Representative Smith seconded by Representative Trautman

**Patton:** This is Auxiliary 2. If you have any questions, please ask. Regarding Auxiliary 1, I was asked about how much money we have to allocate. We have roughly \$500,000 available this year. This amount is a lot more than we usually have due to COVID-19 affecting organizations over the past few years. Last year, we made a COVID-19 impact form which was an opt-in program where organizations could tell us how COVID-19 impacted their funding. My committee is setting our cap at \$175,000 for Auxiliary funding this year. We in talks about what to do with it the remaining amount.

**Kathuria:** Why are the organizations on the bill receiving different amounts of funding? **Patton:** In general, if you see different amounts it has to do with either the amount the organization applied for or their fiscal history. We need organizations to build up fiscal history before giving them larger amount of funding.

**Kathuria:** What is the plan for having fiscal responsibility for the way we are funding organizations? **Patton:** We want the organizations to spend all the money we allocate to them.

#### CONGRESSIONAL BILL AB-106-02 SENATE BILL NO. GF21-XX

#### AS INTRODUCED

An act relating to appropriations; providing for short title; stating purpose; appropriating Auxiliary Funding for the 2021-2022 process; stating appropriation guidelines; establishing expiration deadline; directing transfer of unused funds by deadline; and providing an effective date.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION:

Section 1: This act shall be known and may be cited as the "Auxiliary Allocation 2 Act of 2021-2022"

**Section 2:** PURPOSE. The purpose of this act is to appropriate the funds of the University of Oklahoma Student Government Association to the organizations mentioned within.
