- **Associate Kathuria:** Do you plan on posting on the OU SGA Executive Instagram page with things regarding important legislation being signed.
  - **Appointee Holloway:** I think there is a discrepancy with the students really knowing what is going on in SGA so I think that would be a great way to incorporate our legislations into the Instagram. We can make some story graphics; we can have a signing. There is a lot of room to create a process to do this.
- **Representative A. Perez:** What is your vision of the brand that you have for SGA
  - **Appointee Holloway:** Serving on the communications department last year let me know that there is a lot of room to improve this year. Handing out gear Having more tabling days and raising more awareness about what SGA is.
- **Representative E. Perez:** What are your first three goals if you receive this position?
  - **Appointee Holloway:** One thing President Lissau having a press release template, the tabling initiative, and increasing our social media presence since in the past months it's been stagnant or even declined.
- **Representative A. Perez:** Would you be open to have a suggestion box at these tabling events?
  - **Appointee Holloway:** Yes, of course the whole basis of these tabling events is to interact and have these concerns brought up to us, so that is the whole point of trying to have those tabling events.
- **Representative Griffin:** How do you seek to better work with student congress in the future and create a line of communication?
  - **Appointee Holloway:** Last year we were trying to differentiate the work, one think I'd really like to work on is to create a balance where we each have our own lane but move forward together. I really want to get in touch with the congress PR Department and specifically vice-chair May.

- **Chair Harman:** Will you include Chair Trautman, the Chair of the Cosco committee in conversations regarding tabling, and would you like to take a look at the current congress suggestion box we have?
  - **Appointee Holloway:** No conversations have been made although when I'm confirmed I would love to co program with the PR Committee.
- **Representative Williams:** How do you plan to extend your position to reaching out to students beyond tabling and social media?
  - **Appointee Holloway:** I think tabling is the best way to do student outreach although I would greatly appreciate being invited to any RSO's and having an opportunity to speak and create a dialogue.
- **Representative Nealy:** How do you plan on cultivating an environment where your team wants to thrive in?
  - **Appointee Holloway:** I felt like I had to go find some of the work to do being a member of the Communications Department, I think we can start with properly delegating tasks and working side and side with my committee members. Also, remaining active during the summer since I know SGA Involvement tends to die down.
- **Chair Lynskey:** What do you think the OU Daily's role is and an effective communication strategy between OU Daily and the Student body?
  - **Appointee Holloway:** I just wanted to stress that OU Daily and SGA are their own entities, I have no forward thinking that I will influence what the OUDaily does. I would like to build a better working relationship within our boundaries.

  - **Appointee Holloway:** Reaching out to the people in those marginalized group and the RSO's that represent them, that would be the first step, if said group wants more...

Authors explanation (**President Lissau**): I present to you the nominee Jayke Flaggert, he is studying economics, he was excited and passionate about the department, Jayke has experience within SGA and outside of SGA with experiences that pertain to the duties of the exterior direct. He also understands that importance of collaboration with the External Affairs Committee in Congress. We have structured the department of the Exterior to focus on the 'Who is OU' Initiative but we also really want to focus this on the relationship of the exterior department's relationship with the state and local governments, so that we can ensure that our administration is in constant contact with those who affect Oklahoma students at the external barriers of this university.

1:10 Yielded to Questions

- **Associate Kathuria:** What did you learn from your time serving as the EA Chair in Congress?
  - **Appointee Flaggert:** One of the biggest things I've learned from this position is the benefit of clear and open communication. There are not many problems on campus that we can't solve if we can get people to sit down and openly discuss.
- **Representative Griffin:** What do you think the biggest issue from an external point of view is?

- **Appointee Holloway:** We met as a potential cabinet a bit ago and what we decided was that transparency is our biggest concern. Last year when we were seeing bills on the floor, we were realizing the impact that it made on students a little too late. It was no fault of our own, when the department is watch, federal, state, and local legislation, things tend to fall through the cracks. Being more aware and transparent will help all of our constituents.
- **Representative Broadbent:** I believe that the executive's job is to enforce the law, will you commit to upholding the will of the SGA by advocating for bills and resolutions pertaining to the exterior that have passed in the legislative process?
  - **Appointee Flaggert:** Absolutely, my job is to advocate what is passed by the legislature on behalf of students at the University. When I go up there and put my SGA cap on, there are no other motives or beliefs. What Jayke Flaggert believes isn't what I will discuss when going up to the capital, what will be discussed are items which are in the best interest of the student body.
- **Chair Harman:** Are there any bills currently that you feel would impact students at the university currently?
  - **Appointee Flaggert:** This comes at great timing coming off the tail end of Higher Education Day, the biggest thing that I see is that we are still in committee mode, it would be a little too preemptive to voice any concerns when bills are still being actively changed. Funding and finances are the root of some of the biggest issues we saw when we met as a potential cabinet.

- **Associate Kathuria:** Do you have any relationships that you've built with local and state leaders that could help us lobby for what the SGA Body cares about.
  - **Appointee Flaggert:** I'm Oklahoma born and bred, over time I have developed relationships with people involved in state and local levels, I hope that overtime with my position as the Director of the Exterior, I will be able to build and grow my connections for the benefit of the University.
- **Associate Perry:** Last year, SGA was very prominent with their involvement with BSA, especially with how they handled the Julius Jones case and how they presented it to the government, I'm asking if you'd advocate for brown and black voices, because it is so hard to be heard and seen within SGA.
  - **Appointee Flaggert:** I fully agree, this role is defined to uphold the interests of the University, but more importantly, my email is always open, reach out to me in any capacity to get you and your communities concerns to me and I will take it right up there and advocate it to the best of my ability.

Paige is ready for the interiors tasks as a director, these tasks include reaching out to various groups across campus, to execute this role effectively, the director of interior has to focus on the internal proceedings of the University, and this role suits our appointee Paige Chandler the best since this department is more project based. Her leadership style is empathetic and encouraging which has allowed her to be an effective leader. Through this department, we find that Paige and other members of her department will be focused on the cultivating community series. In her application, she believes in the power of the undergrad, and also the graduate student. She has had many unique positions on campus which would allow her to ensure that every voice is heard. Paige is very eager to get started on her platform points and has many ideas that the executive cabinet is excited for.

- **Chair Harman:** Can you briefly summarize the statement that you presented to ConAd since some of our members haven't had the chance to read it?
  - **Appointee Chandler:** During my statement I explained why I'm passionate about this role, and about being in the executive cabinet, along with the platform pieces of the CARE initiative that I'm very passionate about, and how I'm excited to get started.
  - **Chair Harman (Follow-Up):** Can you detail any of your SGA experience and how it would help within this role?
  - **Appointee Chandler:** This is my first experience with SGA as a whole although I'm very excited and I believe that I can offer a unique perspective with new insight and information that.
- **Chair Halsey Kraus:** In your statement you said that you would like to offer students opinions differently as you would not have the predetermined mindset that many students in SGA have, what predetermined mindset do you believe students within SGA have when taking on a leadership role?
  - **Appointee Chandler:** I'm very excited to offer my unique perspective as a student who attended the university for two whole years without this wonderful experience in SGA.
- **Associate Kathuria:** How has your experience with the CAC prepared you for the role as the Interior Director?
  - **Appointee Chandler:** My CAC involvement has been involved with OUDM, I loved serving on exec for that. I think that CAC has a wonderful passion throughout OU's campus that allows many to be heard and involved, so that was really wonderful. I've also served as Director for both CAC University Sing and Scandals.
- **Chair Lange:** The Princeton review indicated that in 2021, 75% of their entire student's population would consider the university's environmental commitments a deciding factor for whether or not they attended, so my question is whether you have any environmental efforts that will be implemented upon your appointment?
  - **Appointee Chandler:** Furthering initiatives at athletic events and with first-year student living would be a great way to further build habits and a culture where of course we would take input from people who have more experience in that field, all of which I would gladly accept.

11:00 Left for Questions

- **Chair Lewis:** What project ideas or events are you bringing forth that are different from the CARE Platform that you plan on implementing as the Interior Director?
  - **Appointee Chandler:** What initially brought me into applying to this position was the CARE Platform, after learning more about the safety initiatives too, I've decided that advocating for more education regarding safety is what I would like to focus on. Advocating for more safety training and things like that are incredibly important, I know congress has their light walks which has phenomenal results.
  - **Chair Lewis (Follow up):** What other projects, different from the CARE Platform and aside from safety to you plan to implement?
    - **Appointee Chandler:** Wellness Week is coming up, as someone who has worked with multiple mental health awareness organizations during my time at OU, I find mental health awareness to be incredibly important, and a necessary fraction of student life, and making sure that, that is handled with respect and care is incredibly important.
- **Chair Halsey-Kraus:** In your personal statement you talked about your future with the role and how it would help you grow and learn, you mentioned how SGA would help you make more bureaucratic decisions, might you elaborate?
  - **Appointee Chandler:** Using the community around you to make educated and thoughtful decisions, in a way that you think about the world around you to make more well-informed choices.

- **Vice Chair May:** What else do you think makes you stand out as a student and candidate for this position?
  - **Appointee Chandler:** My first leadership position within SGA was in the Freshman Leadership Council, in which we identified issues and making creative solutions. I also served as the philanthropy chair for my social organization and did the exact same thing.
- **Chair Harman:** How do you plan to build on knowledge of SGA internal workings?
  - **Appointee Chandler:** My job is to address on campus issues, while it says, parking, student health & wellness and sustainability. I believe that the role can be much more than that. I think that when an issue arises, it's about handling it in a way that I would want as a student and someone who wants change. Looking at things from a learning perspective.
  - **Chair Harman (Follow-Up):** In doing so, how do you plan on advocating for marginalized groups within those on campus issues?
    - **Appointee Chandler:** It's listening and understanding that your position of leadership has a say and a meaning and a voice for marginalized groups and the betterment of the OU community.
- **Representative Broadbent:** Will you commit to enforcing interior policy that is passed through the SGA Legislative process, and secondly, have you had a chance to look over a recent resolution that I passed through regarding indigenous languages and promoting the addition of advanced classes?
  - **Appointee Chandler:** I was unaware of this bill but from the brief description, it sounds incredibly important, and I think that advocating for indigenous voices is especially important on OU's campus and making sure that all of the university is aware of these changes. I hope that answers part of the question.
- **Representative Nealy:** Would you be open to implementing some self-defense classes on campus?
  - **Appointee Chandler:** I think it's incredibly important to be equipped with that knowledge and I think that is something our university would benefit from.
- **Representative Griffin:** You have highlighted that you are bringing an outside view, you've also said that you've had a lot of experience with CAC which is the 4<sup>th</sup> branch of SGA?
  - **Appointee Chandler:** I apologize, that was a misuse of verbiage, I meant in roles regarding, legislative, judicial, and executive roles.
- **Representative Hale:** Can you give us any concrete examples of goals you have that make you a candidate that can provide?
  - **Appointee Chandler:** Potentially adding an education course through camp crimson for first year students to learn more about how to keep themselves safe on-campus is incredibly important.

Representative Broadbent seconded by Representative Griffin***

- **Representative Nealy:** How do you plan to protect free speech for all students, and how do you plan to keep all of the students' voices heard and protected?
  - **Appointee Chandler:** Free speech is something that is extremely important to us, we fully believe that every opinion has the right to be heard.
- **Chair Halsey-Kraus:** What are your specific plans for the blue light system?
  - **Appointee Chandler:** I know that there is currently a light walk happening to ensure that these systems are operational, and I believe that based on last week's minutes and agenda that only two were down, this is an amazing step in the right direction.
  - **Chair Halsey-Kraus (Follow-Up):** Are you saying that your plans for the blue lights is to continue the work of congress or to collaborate with congress? How would you further the work?
    - **Appointee Chandler:** I believe that it is collaborating with Cosco and reaching out to OUPD and making sure that these are all operational and fully functioning.
- **Chair Harman:** Can you specifically identify the qualifications that set the nominee apart from other who might've had experience with the SGA branches?



- **President Lissau:** As a former intern for the US Senate, a philanthropy director, and involvement with the CAC and as the head director for University Sing. In this role we were looking for somebody who has tangible results in her involvement through innovative ideas. A lot of these challenges that the director of the interior will face are going to be unexpected, we are going to rely on her quickness to address any situation.
- **Chair Harman:** Tonight, we've heard a lot about communication and uplifting other students, how do plan to listen and communicate with students differently than the communications and exterior director?
  - **Appointee Chandler:** I believe that this is going to be a collaborative effort, the branches of SGA will have to join together to make sure that the inner working of our university are working properly, as I said before, I'm always open to suggestions so please contact me.
- **Representative Broadbent:** I've heard a lot about reactive measures regarding violence on campus and preventative measures for victims, but can you talk about measures to stop people from actually committing acts of violence on campus?
  - **Appointee Chandler:** I think this has to do with reaching out to organizations on campus to inform students with consent conversations and making sure that organizations on campus that really promote safety and prevention of those attacks.
- **Chair Halsey-Kraus:** You've told us this evening that you'd like to continue the work of congress to make sure that the blue lights are working, as well as a potential safety clinic for self-defense, can you give me tangible examples of things you want to do during your tenure?
  - **Appointee Chandler:** I believe that my tangible things are fulfilling the CARE Platform and listening to complaints and concerns of people that I listen to, I'm under the executive branch and I believe that the initiatives made all are tangible and things that I care about.
- **Representative Hale:** You mentioned self-defense classes which are reactive measures, but preventative measures bear better results, I was wondering if you believe that SGA should promote reactive measures over preventative or if you had any plans in place to work towards preventing violence rather than reacting to it?
  - **Appointee Chandler:** Until you fix a problem at its source, it's not really going to get solved, I have actually had GEC come and do an additional training with an organization before. Working with those groups and making sure that they have their voices heard and allowing them to use their platform to help prevention is incredibly important.
- **Vice-Chair May:** I'm slightly concerned with a few of the safety ideas that you've bought up since they are already project ideas that we have going on within congress, specifically Chair Trautman's committee. Were you aware that we already have a suggestion box?
  - **Appointee Chandler:** Yes, I was, by suggestions I mean personally emailing or reaching out to me.
- **Vice-Chair May:** Are you aware the blue lights are not within the OU SGA discretions, so on our light walks we don't look at those since other entities maintain them?
  - **Appointee Chandler:** I understand that there is a working relationship between OUPD and OU so I would be willing to reach out to them about this.

**DEBATE**

**Proponency (Associate Kathuria):** I believe that it's very important to Paige Chandler to be confirmed today because I believe she will do a great job fighting for the people and for OU. She plans on doing a lot of work with

me to battle this vaping and nicotine epidemic which includes talking to the OU Athletics department to increase promotion and awareness and to focus on more public health issues. If you care about public health and the health and safety of our campus, please vote yes on this confirmation.

**Opponency (Chair Trautman):** I would just like to state that she doesn't have very much SGA experience which isn't the issue at hand, the issue is that as the COSCO Chair, her points regarding campus safety weren't correct. This isn't okay with me, and it also isn't fair that I wasn't reached out to about the information regarding blue lights which was incorrect, if you're going to speak about things such as blue lights then you need to know what you're talking about in order to stop misinformation. It is a scary and stressful situation to be saying incorrect things, there were also no tangible ideas provided to the body when asked and I don't think that the director of the interior should say that she knows what the suggestion box is only when it's brought to her attention in terms of not knowing what it was.

**Proponency (Representative Nealy):** The appointee has gained over 6,000 community service hours which I think is very notable. She seems like an overall great fit for this position because she does have leadership experience. It's good to know that not everyone is the best with words, she may have misunderstood what some of the questions meant and therefore she was unable to answer them properly.

**Opponency (Representative Griffin):** I think the Lissau Administration put forth many great candidates which we saw today, although a lot of my problems today come from a general lack of knowledge overall. The department of interior is one of the most impactful roles to students and the fact that there wasn't much knowledge on safety concerns and very little knowledge on how we handle sexual assault in terms of asking for reactive and preventative measures, I think that is extremely dangerous. The lack of knowledge regarding the governing body, not regarding the CAC as the 4<sup>th</sup> branch of the SGA, I don't feel like this candidate would be able to fulfill the vast responsibilities necessary.

**Proponency (Representative Cantu):** I think it ultimately come down to being misunderstood, people are uncertain about the certain qualifications that she has brought forth. I want to highlight the fact that she is extremely involved with philanthropy and that the misunderstanding of the situation regarding the blue light system has created some concerns for the opponency.

**Opponency (Chair Harman):** The candidate really didn't give tangible answers to questions a lot of this was circled back to wanting to listen and advocate, that's really great. Although I want to hear your own ideas. Being misunderstood about qualifications, I'm thankful for your philanthropy although I don't see how the funding measures qualify you for a position as the interior director. The safety issue measures all mostly regarding reactive measures conflict with what the GEC focuses on. No clarity was given regarding predetermined roles and how that makes the appointee a better candidate.

**Proponency (Representative Cappleman):** I would like to point out that the Philanthropic experience and her volunteer involvement doesn't necessarily coincide with her situation, but I would just like to preface that she emphasizes that from the 6,000 hours she was able to optimize the roles within whatever organization she volunteered for.

**Opponency (Chair Lange):** I have some very serious concerns that I would like to bring up which I feel has been addressed a lot-with the fresh perspective-as someone who has had positions all across campus mostly in environmentally focused organizations, I have gotten many fresh perspectives from students and members. Although most of the time every time someone comes in with a fresh perspective, it's really just the same things that have been explore before just coming from someone different. The lack of knowledge preceding the current executive cabinet for the appointee ultimately will lead to wasted time for things that won't or can't happen.

**Proponency (Associate Kathuria):** Representative Griffin and Chair Harman, I absolutely agree with you that we should take preventative action to reduce acts of sexual assault and violence on campus. However, I'm very confident that this nominee will work to accommodate that. I'm an associate in congress, and she is the kind of person to say that she would help me with all of my legislative goals within this body. Just hearing her say that means a lot to me personally, I'm somebody who needs help to get things done. She is one of the more caring nominees that I have met.

**Opponency (Chair Trautman):** I would like to reiterate that our issue is not that she has no SGA experience or very little previous experience. I would like to state that if you're worried about the fresh perspective, we have plenty of events coming up where you can reach out to our constituents for that. We don't need to compromise our values for a new perspective.

**Proponency (Representative Nealy):** The candidate went through a grading process in her interviews, and she was graded the highest out of any other candidate that applied for the position. I think that is something that should be mentioned since that shows that she is truly about putting students first. She is truly about the values that SGA holds. Also, when it comes to her involvement, it somewhat is, she has been involved in leadership skills like her sorority and other leadership organizations. It's not something to take lightly when someone has put over 6,000 into community services, and when it comes down to what SGA is about, it is about servicing the students. That is very notable and good that she has put it over 6,000 community service hours. Although she may not have gotten all of the language is correct, she is coming in this with a good heart.

**Opponency (Representative Griffin):** I don't think anyone in the opponency is questioning the character of this candidate, I think that in terms of philanthropy and service she excels, no one doubts that she comes into this with a good heart and intentions. However, this is not an entry level position, this is one of the most important positions and impactful positions in terms of student life and outreach. Every time we bought up any legislation or acts carried out by the legislative branch, she had absolutely no knowledge of it until it was bought up. I think that's extremely concerning.

**Proponency (Associate Felkner):** I think that most of the discussion regarding Paige's involvement has been about community service, which is great, I think that Scandals and Using has been overlooked in terms of her involvement as directors for both of the programs. They are both very difficult jobs which require you to bring diverse students together to work efficiently, while listening and synthesizing their ideas to create something tangible. Those are all skills which will translate very well into her appointment as the Director of the Interior.

**Opponency (Secretary Fawad):** There is one large issue I feel hasn't been addressed by the Proponency, I feel like there is no tangible plan that has been made by the appointee. We have heard of the blue light system and some safety precautions regarding acts of violence. Although one thing that does concern me is that it mostly focuses on defensive measures. I want the culture on campus to be changed, and I don't feel like this is the correct way to approach the issue. I don't feel confident in giving this nominee a vote-albeit I can't vote-I don't feel like there is an actual plan we have at hand other than what the CARE Platform dictates. I do think that we should appoint someone with ideas already in mind.

**Proponency (Associate Kathuria):** One thing that really impressed me was her stance on free speech. She wants to allow people of all political stances to be able to voice their own thoughts.

Authors summation (**President Lissau**): I'd like to speak to this role about what it does and who it works with, it works directly with my office, and with Denzel and myself. We work together on projects, there have been a few ideas thrown around about the legitimacy of her qualifications. There's been this really confusing message, but I would like to send a resound, she is qualified. Paige Chandler is our nominee for this position, as it is our cabinet. It is our role to appoint individuals which we feel like they have the ability to successfully carry out their respective duties and the plans that the electorate has elected us to do, and that is exactly what we are trying to achieve. Paige has spoken very eloquently about the CARE Platform and its ideas. I would like to clarify some things, one about the blue light system, I think that there was some misunderstanding as to whether it was normal lighting or blue lights specifically. I think we can all speak to Paige's sincere understanding and admonishment that these are both very important tools on campus. Paige has spoken about how she only believes on proactive measures, but also reactive measures as well. Bottom line, Paige is a very esteemed member of our community, and she doesn't have SGA experience, as somebody who hasn't been in this realm, it is important to speak to her experience in the CAC, but really, this role is here to solely serve the internal body with the means and methods as our office directs her to do so. I'm more than excited to reach out to those Student organizations and also the departments to find what they need and connecting them with other organizations and resources.
- **Representative Griffin:** The GEC is one of the main organizations on campus that focus on inclusivity, do you have any experience working with the GEC or plans to work with them?
  - **Appointee Schultz:** I emailed the GEC three weeks ago and signed up as a volunteer, I was unable to progress forward, but with my appointment I would be so glad to work with them on a higher level.

  - **Appointee Schultz:** There are 30,000 people attending this University, I sincerely hope that as a cabinet we try to reach out to as many groups as possible and educate them about the effects of actions like these regarding what is racism and how to address it. We have to start somewhere.
