Officer Reports -

- **Chair's Report:** We will be having orientation very soon; Vice-Chair May will be talking about it more in her report. I've been in contact with the chairs of both the Faculty Senate & Staff Senate to discuss more about the Shared governance council and making those plans into a reality. This past week I got a chance to talk to the Title IX Coordinator, she has expressed a willingness to come speak to Congress and GSS, expect her to be a guest speaker sometime soon.
- **Vice Chair's Report:** Hello new members, I'm so excited to see you all. Orientation will be Sunday the 20th, I'm working on the schedule trying to get all the details figure out, there will be updates tomorrow.
- **Secretary's Report:** So excited to see all our new Associates and Representatives!

Committee Reports-

- **Campus Outreach, Safety, and Concerns:** We focus on constituent outreach and ensuring that we hear their concerns regarding general safety and concerns and try to solve them in a multitude of ways. We have a light walk on Sunday, there is a link for that in the GroupMe. Coffee with Congress is coming up, it's going to be an event where we have members of Congress being visited by members of the student body so that they can express any concerns or issues that they have, we will have Coffee and Desserts at the event. COSCO is having a covid informational going out.
- **Congressional Administration:** To all my new members, it's so great to see you again! I'm the chair of the ConAd committee, I also serve as the parliamentarian of congress. ConAd basically serves as the internal affairs of congress, we are the committee you come to when you have procedural and legislation related questions, we also see appointments, speaking of which, we just saw CB-107-04 which we gave a recommendation of do pass. We will be seeing that in items to be considered, ConAd is also responsible for code club, code club is an information presentation we have during

general body meetings. In the upcoming week, ConAd will be going over some election reform. Please feel free and “on parliamentary inquiry” to ask me a question.

- **External Affairs:** In this committee we primarily focus on civic engagement, through voter registration drives, we look at local state and federal elections, currently we are focused on state legislation as Higher Ed day is in a week, we also do infographics for candidates. For new members that can't make it to Higher Ed day we are currently working on an additional lobby day, so if you're interested in possibly setting up another date, please let me know. We are going to try to have a social media takeover for Higher Ed day. We will be having a meeting on Sunday at the Conoco at 6:30pm.
- **Human Diversity:** Our committee is focused on Diversity, Equity, and Inclusion efforts across campus and within SGA. We met officially this weekend, we are switching meeting times to Thursday at 5:30PM, we are going to be on zoom until after spring break. One of our projects this semester is a graduation gown rental, I will try to get that completed in time for the next graduation class. We are also working on special guest speakers, one of which is here tonight, I'm so happy to welcome Dr. Rodney Bates, who is the director for the center of social justice at the WGS Department.
- **Sustainability:** We work to review the policies that come out of congress as well as other parts of SGA, as well as general campus operations and try to optimize the environmental impacts. We met officially this past Sunday for the first time this semester, I've already reached out to most of my committee with action items. We looked at the PAE Bill and give it a recommendation of do pass, which we will be seeing tonight. We are looking at a Trash Walk on Sunday February 27th at 1:00 pm at the Duck Pond.
- **University Policy:** We focus on questions about policy on campus which aren't beneficial to the general body. Upol will be meeting next weekend, our new meeting time will be 4:30pm
- **Ways and Means:** We saw Aux 11 this past weekend, WAM helps allocate the student budget to organizations on campus as we see fit, we fund RSO's through Auxiliary and Primary bills.

Items to Be Considered

AB-107-03 - Auxiliary Allocation 11 Act. (Patton, Papahronis, SGA Budgetary Committee) (Ways & Means, Do Pass)

Motion to see AB-107-03

Representative Williams Seconded by Representative Neaves

Author's Explanation Vice-Chair Papahronis: This is Aux 11, we have 12 different organizations that we all gave funding to, if you have any questions let me know.

Yielded 2:48 to Questions

Representative Nealy: What is this bill about, where is the funding going?

Vice-Chair Papahronis: We allocate it to the organizations; we will go into primary and allocate even more money to these organizations.

Chair Harman: Can you explain a little bit more about the differences between Auxiliary and Primary?

Vice-Chair Papahronis: Aux has a longer time period for submissions from RSO's while Primary is due at a hard deadline which is February 25th at 5:00pm. Once that deadline hits, we start looking at the applications and allocating larger sums of money, Aux fills in for the smaller amounts throughout a schoolyear while Primary is where an organization will get a large portion of their money.

Chair South: Primary funding comes directly from the student activity fee, a portion of the student activity fee, which each student pays, is allocated to the SGA which is subsequently allocated through the Primary Process, our auxiliary funding is money that was not spent which was allocated the previous year, the money that we are allocating tonight is some of the money that organizations didn't spend last year.

Representative Nealy: What are the requirements your organization has set for a RSO to receive funding?

Vice-Chair Papahronis: We have a criterion for which organizations receive funding, we look at financial history, we look at the previous year's numbers, if they have a good fiscal presence and they used all the money we gave them, then we will allocate money again to them again, in general we don't fund t-shirts.

Representative Williams: All these expenditures came from surplus, are all auxiliary bills a result of surplus?

Vice-Chair Papahronis: This is all surplus from last year.

Chair Harman: Can you briefly explain the differences between each category (Programs & Events, Capital Investments, & Office and General Expenses)?

Vice-Chair Papahronis: The first category is usually allocated to organizations for monthly meetings, if they need food, items, rentals, guest speakers. Capital Investments are quite rare, if an organization we'll see it more frequently. Office and General Expenses are for any items that are office related, pencils, pens, papers etc.

Representative Landry: Is it possible for an organization to apply for auxiliary funding if they did not apply for primary?

Vice-Chair Papahronis: Yes, any RSO is eligible to apply for auxiliary funding without having applied for Primary

CB-107-03 - SGA PAE Establishment Act. (Lange) (Sustainability Committee, Do Pass) (Congressional Administration Committee, Do Pass)

Motion to see CB-107-03

Representative E. Perez Seconded by Representative Tesfaselassie

Author's Explanation Chair Lange: This bill establishes the PAE, the bill has been given a rec of do pass from both ConAd and Sustainability. Last spring the director of event management came to me through the student environmental coalition. After preliminary discussions, I determined that the timeline, work required, and the number of stakeholders merited creating an entirely separate workflow from the sustainability committee. This translates to the creation of a new SGA board, which can be regarded as a task force to implement and optimize for these particular objectives.

Associate Kathuria: How do you think OU Athletics has been on the issue of environmentalism?

Chair Lange: They used to have a little better performance, in the recent years it has diminished, they're hoping to correct and improve that as we go forward

Representative E. Perez: Can you specify what the extent of the expansion of the PAE's goals are?

Chair Lange: It all depends on the objectives of OU Athletics, they're the primary stakeholder outside of ourselves, in terms of expansion, it's my understanding that from the conversations we've had so far; that there are games which have no recycling infrastructure at many sports events, we hope to provide them with some data and volunteerism at these events.

Representative E. Perez (Follow-Up): How will the PAE ensure the student body actually does recycle?

Chair Lange: When it comes to athletics events, part of our first objective is to do site visits at these games and events of all scale, to see what the behavior of these fans are as they interact with these facilities, to answer questions regarding the efficiency of recycling bins, the presence of them and whether or not the climate encourages people to recycle. We would like to develop a document expressing the information we find in order to create a playing field for all of the stakeholders. From there we can find out what the issue is and address it in order to strategize what needs to be changed.

Representative Tesfaselassie: You've mentioned how the OU Athletics recycling facilities has diminished over the past years, is the data qualitative or quantitative and where did it come from?

Chair Lange: My information comes from the Director of Refuse and Recycling; I feel he is a trusted source for this information since he oversees all of the operations regarding this issue at OU Athletics.

Representative Tesfaselassie (Follow-up): Is there any way to get quantitative data?

Chair Lange: We will be trying to reach out to Refuse & Recycling or from OU Athletics themselves to get data regarding this from the years past. We may be able to have a student volunteer record observations and gather qualitative/quantitative data for us going forward.

Motion to extend time for questions by 5 minutes

Representative Broadbent seconded by Representative Landry

Representative Broadbent: Why are we not amending the code under the responsibilities of the interior director to reflect this new role, or amending the bylaws of the sustainability committee chair to reflect this new role, just to be consistent with how we have the governing documents written?

Chair Lange: In terms of the extra amendments, those are oversights that I would be very willing to amend to the legislation.

Chair South: There are ex-officio roles, which some members of SGA Exec take up which aren't required under the bylaws, or the code annotated, yet they're still enumerated in those boards and

commissions. It's not essential that the role in the job description is updated, however I wouldn't see a procedural issue with doing so.

Representative Broadbent (Follow-up): Do you think that the OOMA Clause is redundant and that we should strike it out or should we just leave it there. *Directed to the Parliamentarian.*

Parliamentarian Halsey-Kraus: I believe that it's fine to leave it there, having the clause is more of a clerical purpose since there are some boards under the title of the code that don't actively follow it.

Representative Broadbent Seconded by Representative E. Perez

Chair Harman: How long has this partnership been in the works and how much work has already gone into the development of this bill?

Chair Lange: It's taken just under a year, that was when Michael burns reached out to us, we had a couple meetings with him just to discuss the goals and timeline, all of which was conceptual. We've had real meetings where we had the stakeholders listed on the bill, we started to establish the objective that we want to set out to and develop some more concrete goals. We've had another 2 or 3 meetings last fall but we are currently planning out another one for this semester.

CB-107-04 - Spring Appointment Act of 2022. (Halsey-Kraus, Congressional Administration Committee)
(Congressional Administration Committee, Do Pass)

Representative Williams Seconded by Representative Dodd

Author's Explanation Chair Halsey-Kraus: This past weekend the Congressional Administration Subcommittee held interviews for Associates and Representative seats, we also proceeded with a deliberation period in which we have chosen to Appoint 13 new associates and 3 new representatives.

Yielded 2:22 to Questions

Representative Broadbent: How many seats do we have remaining out of the seats that we didn't fill?

Chair Halsey-Kraus: We had 18 open seats and we appointed 3 new representatives.

Representative Broadbent (Follow-up): Are any of the associates in districts that could've filled representative seats?

Chair Halsey-Kraus: Majority of the applicants were University College students and there are currently no openings.

Associate Kathuria: How many people did you interview for the position?

Chair Halsey-Kraus: Out of respect for the candidates who didn't receive positions, I don't feel comfortable giving the exact number.

Chair Harman: How did this year's applications vary from last year, in terms of applicants?

Chair Halsey-Kraus: Congress applicants increased by a margin of 27%, we did have some applicants who received an interview although didn't show up, but in general we did see an increase from last year!

Representative Tesfasseliasie: Whenever the associates are going through the position, is it your policy to push them up to a representative position?

Chair Halsey-Kraus: We have a cap number on associates, associate constituency is the entire OU Student body. We had a lot of our applicants apply for a Representative seat in UCol, but we have no seats

open so they were given associateships and are encourage to run for a representative seat this coming semester.

Final Vote: 23-1-1

Chair Halsey-Kraus: As my job as Parliamentarian, it is my job to inform the body of Roberts Rules of Order, Parliamentary Procedure, and standard rules. An abstention vote should only be used in a small criterion of votes, most notably when you have a moral, financial, or other obligation that would be impacted by your vote. It’s your duty to vote when you have an opinion about a matter being decided and are able to. Abstaining to a vote, especially being a representative or voting member inside this body or outside in another organization that uses Parliamentary Procedure for no obvious reasons is unprofessional and unrepresentative of your constituents.

CONGRESSIONAL BILL AB-107-03
SENATE BILL NO. GF20-XX

AS INTRODUCED

An act relating to appropriations; providing for short title; stating purpose; appropriating Auxiliary Funding for the 2021-2022 process; stating appropriation guidelines; establishing expiration deadline; directing transfer of unused funds by deadline; and providing an effective date.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION:

- Section 1:** This act shall be known and may be cited as the “Auxiliary Allocation 11 Act of 2021-2022”
- Section 2:** PURPOSE. The purpose of this act is to appropriate the funds of the University of Oklahoma Student Government Association to the organizations mentioned within.
- Section 3:** APPROPRIATION. The following amounts are hereby allocated to

Section 5: This fiscal year for the account listed in these sections shall end May 6, 2022

Section 6: All unspent money remaining in the accounts listed in Section 3 shall revert to the SGA General Account after May 6, 2022, and the remaining appropriations shall be canceled.

Section 7: This act shall become effective when passed in accordance with the SGA Constitution.

AS INTRODUCED

An Act of Procedure amending Title IX of the Code Annotated, providing for a short title, providing for codification, and providing an effective date; providing short title; and providing an effective date.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION UNDERGRADUATE STUDENT CONGRESS:

Section 1: Title: This act shall be known and may be cited as the “SGA PAE Establishment Act of 2022.”

Section 2: Purpose: The purpose of this act shall be to establish the SGA Partnership for Athletic Environmentalism (PAE).

Section 3: AMENDATORY: A new chapter shall be added to SGA Code Annotated § Title IX. For the purposes of this bill, all items added shall be denoted with an underline.

1) **Name**

This board shall be called the “SGA Partnership for Athletic Environmentalism.

2) **Purpose**

The purpose of the Partnership for Athletic Environmentalism is to assist in the communication between OU Athletics, Recycling, Energy and Sustainability Services and the Student Government Association. The Partnership will meet with the intention of expanding recycling facilities at OU Athletic events.

3) **Membership**

a) The Chair of the Partnership shall be the Congress Sustainability Committee Chair

b) Membership for the PAE shall be as follows:

- The Chair of the Partnership
- A member of the Congress Sustainability Committee assigned by the Chair of the Partnership
- The Director of the Interior for the Executive Cabinet
- The Director of OU’s Energy and Sustainability Services or their assigned proxy.
- The Supervisor of Refuse and Recycling or their assigned proxy.
- The OU Athletics Director of Event Management or their assigned proxy.

4) **Meetings**

Meetings of the PAE shall be subject to the Oklahoma Open Meetings Act.
The Partnership shall meet at least once per month throughout the academic year.
Meeting dates and times shall be decided upon by a consensus of the Partnership's members.

Section 4: The SGA General Counsel is authorized to renumber any necessary divisions when engrossing this legislation into the SGA Code Annotated.

Section 5: This act shall become effective when passed in accordance with the SGA Constitution.

A Congressional Act of Procedure
Appointing Representatives and Associates for the
107th Session; providing short title; and providing
an effective date.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT
ASSOCIATION UNDERGRADUATE STUDENT CONGRESS:

Section 1: Title: This act shall be known and may be cited as the “Spring Appointment Act of 2022.”

Section 2: Purpose: The purpose of this act shall be to appoint the following Representatives and Associates to the One-Hundred and Seventh (107th) Congressional Session.

Section 3: The following SGA Members shall be appointed to Representative Seats, as follows, in accordance with the SGA Constitution:

Humanities: Megan Neaves

Life Science: Monica Ahedor

Section 4: The following SGA Members shall be appointed to Associateships, as follows, in accordance with the Undergraduate Student Congress Bylaws:

Section 5: This act shall become effective when passed in accordance with the SGA Constitution.
