 - **Kathuria:** How has your experience been being the Vice Chair?

- It's been awesome. I've grown a lot and learned so much about our body and leadership. It is also awesome that I get to spend nearly every Monday and Wednesday with secretary Landry and play pocket cornhole.
- **Kathuria:** You are a member of the life science district. How to you plan on improving the university experience for your constituents?
 - A large part of my role is being in congruence with committee chairs and supporting the executive team. At this time in my role as Vice Chair I would work with the committee at hand such as HD, COSCO, UPol, and just being a team player.
- **Halsey-Kraus:** How did your first orientation go?
 - I think it went really well. Myself and the executive committee worked really hard and stuck to our time schedule and budget. It was well attended, and everyone was placed in committees. I also think mini orientation went well and was well planned. They seemed to have a good time.
- **Robinson:** I'm sure many of us have specific goals when coming into congress either as an individual or for the student body. How do you feel you've achieved these goals or are chasing them?
 - One of my biggest goals as a freshman was to get a textbook swap on campus. We've discussed there is one at the library and now I work with the OU Food Pantry to do textbook swaps with them for individuals who have better access to the pantry than to the library. I still have other goals in terms of creating a more supportive and engaged environment for the body.
- **Kathuria:** What are some of the most important issues pressing OU students?
 - The weird phase we are in between covid and not covid. Following teacher's guidelines, knowing when to mask or not mask, when to come to class and if they will offer zoom. For solutions we need to be keeping students informed and sending legislation to professors and OU to better understand attendance policies.

 - **Kathuria:** What have you enjoyed about being the secretary of Congress?
 - The people I have met in it. Everyone is so dedicated and involved in other RSOs on campus. They generally have giving and altruistic personalities, and I enjoy surrounding myself with those kind of people.
 - **Strickland:** Do you enjoy taking minutes and what is your favorite part about doing it?
 - My favorite part about taking minutes is that I can kind of become a vegetable and just really get in the zone. I don't have to think about what's going on in my life.
 - **Robinson:** Did you have any goals coming into congress and how has this position helped you achieve them?
 - I had some specific goals coming in relating to sustainability and I enjoyed my time being on the sustainability committee before moving up

to become secretary, so in that sense I think I completed my initial goals. Each year I have new goals and continuing to grow my love for this university and my knowledge of how it works is one of those and I definitely thing the position has helped me do that.

- **Kathuria:** You spend a lot of time keeping track of attendance. How do you plan on encouraging all of our representatives to be present?
 - Attendance is an understood requirement of the representative position, I think the best way to encourage people to come is to make the meetings fun and welcoming, and feel like a safe environment. That way people want to be here and not feel like it's a chore or something they have to do.
- **Halsey-Kraus:** Do you enjoy being my secretary?
 - Of course I do.
- **Trautman:** Can you please tell the body how you feel about your office mate?
 - I love my office mate. She keeps me accountable, she's very funny and tells great jokes, and she is objectively better at desktop cornhole.
- **Halsey-Kraus:** How fast can you type?
 - I don't believe words per minute is indicative of being a good secretary. My typing speed has improved being secretary but a lot of it is about organization and doing the prep work before the meeting. I already have most stuff typed out before the meeting even starts and that saves time.
- **Craig:** You didn't exactly answer the question. I think a lot of us would like to know the exact words per minute you hit during your fastest session.

- **Kathuria:** Chair Mullins, you were talking about certain auditing of particularly OU courses, could you elaborate on that?
 - **Mullins:** Lacey was notified that we had a student concern about auditing and so I've been briefed on it. I am looking forward to learning more.

Auditing is where a student can take a class free of charge, and nothing is set in stone.

- **Strickland:** Miss Halsey-Kraus, how do you think your term as ConAd chair has been thus far and how do you think your committee is doing as a whole?
 - **Halsey-Kraus:** When you say my term, I think of it as being about a year. I try to think of it about being what's best for the body and the students. My job is more managerial, and I think that's not very desired because a lot of people would prefer to do the hands-on work of say COSCO or EA but the work I do is extremely valuable. I am proud of my committee. It's been a rocky semester because of projects falling through holes and people not responding to emails but they stuck beside me and we've grown tremendously.

Author's Explanation (Halsey-Kraus): This bill was co-authored by EA chair Weslie Griffin. This bill essentially is just asking for the state legislature to keep all current laws regarding guns on campus in place as they are. We wrote this bill, because there have been numerous laws filed in this legislative session trying to increase the ability to carry on campus. Under current laws it is under the discretion of the President of a university to permit someone to carry a weapon on campus if the president feels it is necessary for that person's safety. Otherwise the carrying of weapons on campus is prohibited. This system has worked as is, and we feel that any loosening of these laws would negatively impact the safety of students. This opinion is also shared by the state regents, who suggested we write this bill, as well as most Oklahomans. If someone feels unsafe on campus they are still able to contact the President as well as OUPD. Bottom line we do not have a need for more guns on campus. The laws we have in place now have been able to prevent potentially dangerous groups from carrying on campus, and have included the proper infrastructure for those who feel they may need to carry for their own safety.

 - **George:** There was never a request from the regents to write this it was being pushed broadly by other student governments as well as the Oklahoma Student Government Association and the Regents for Higher Education. The OU Board of Regents didn't say anything.

Author’s Explanation (Firch): I would like to thank everyone for taking time out of their very eventful Congress meeting today to allow me to speak. The Chief of Staff position has a few key roles, one being to ensure that the platform points of the Firch-Shultz administration are being implemented, secondly to ensure that the executive cabinet remains in compliance with the Code Annotated, to serve as a voice of reason between Congress and the executive cabinet, and lastly to observe a birds-eye-view of campus. Maria de Asis is someone I’ve known for many years and through her previous roles in leadership whether it be as an executive member of AASA, being in PLC, or a counselor at HSLC, she has a diverse background that will provide a unique sight into the Chief of Staff role. Thank you.

- **Kathuria**: What does this potential role mean to you?
 - **De Asis**: I have been involved in several things on campus and am fortunate in that way. But for me SGA is where I can create change. It’s the pillar and foundation for educational institutions. We get to state our opinions and make our voices heard. For example, the OU Food Pantry is something that was initiated by SGA and it’s now popular.
- **Strickland**: I asked you during ConAd how your previous experiences would help you with this role and you responded by wanting to initiate conversations with outside groups. How do you intend to start those conversations?
 - **De Asis**: One of the platform points that started this journey with me and Chris was the “A” in FAR – Amplifying DEI. That means to me is bringing back the campus climate board of advisors. Student leaders in other orgs such as CAC and multicultural groups meet with SGA leaders. It’s imperative for these meetings to happen on a routine basis. This ensures SGA is creating legislation that students want. the campus climate board of advisors will amplify DEI because it gives diverse backgrounds a voice. When I think of SGA I think of initiatives for students by students.
- **Kathuria**: Have you had an opportunity to meet with the former Chief of Staff Lauren Roberts?
 - **De Asis**: I have not, but I did get to meet with the Chief of Staff before her, Cricket Kaya, and have a conversation about the expectations she had and I now have a better understanding of the challenges I might face and the things I might learn.
- **Glasscock**: What are you most excited for if you do become Chief of Staff?
 - **De Asis**: My other positions on campus have offered me a great deal of lessons and given me the chance to initiate change but with SGA I am most excited to be there for Chris and Emilie. Their platform points resonated with me and when I got a call from Chris two months ago for this job I was very excited because when I think of Chief of Staff I think of a safety net for the executive cabinet. I make sure goals are met and any help goes to me. I am excited to see what they work hard for come to life.

I just want to make sure initiatives are followed through with and permanent.
- **Kathuria:** How do you plan on making sure the departments and the directors are doing the best they can?
 - **De Asis:** My job is to be a manager for the entire executive cabinet and we have weekly meetings that I set out. Effective communication and being a familiar face and ensuring clear communication. I plan on during our meetings to check in with them.

AS INTRODUCED

A Concurrent Resolution recommending the
Oklahoma State Government maintain current laws
regarding weapons on campus; and providing for
distribution

Whereas: The Oklahoma State Legislature has introduced approximately 80 bills related to firearms;

Whereas: SB820 and SB664 are two of the several bills that would modify current law to allow students the ability to possess firearms on University and College campuses;

Whereas: A current poll showed that 94% of faculty members in universities and colleges across the United States opposed allowing firearms on university and college campuses¹;

Whereas: A study across several states revealed that 78% of students do not want firearms on campus²; therefore

BE IT RESOLVED BY THE UNIVERSITY OF OKLAHOMA UNDERGRADUATE STUDENT GOVERNMENT ASSOCIATION:

Section 1: Title: This resolution shall be known and may be cited as the “Campus Safety Resolution of 2023.”

Section 2: The University of Oklahoma, Student Government Association, recommends that our state legislators maintain the current law regarding weapons on campus, in which the University President has the discretion to allow individuals to carry weapons on campus when the individual circumstances warrant it. We strongly oppose any changes to state law regarding weapons on college and university campuses.
