Officer Reports -

- O Chair's Report: Good evening. Welcome to all our new members. Traditionally you would be sworn in earlier but we are having some technical difficulties this time around. Congratulations and we are very proud of each of you. My name is Abby Halsey-Kraus and I am the Chair of Congress. You will be sworn in in just a bit. Tonight, we have a lot going on. First, we have nominations for Chair, Vice Chair, and Secretary. As a reminder you do have to be a representative to make that nomination. On the agenda we have several bills and I would ask that all our appointment bills be seen last while we wait on President Firch to arrive. We have both primary bills and I would ask that we table those to see them next week. Out of transparency, myself, President Firch, General Counsel Nick Hazelrigg, and GSS Chair Claire Burch all sat in on general counsel interviews to replace Nick and we will see that appointment along with space allocations next week.
- O Vice Chair's Report: We had orientation on Sunday and I guarantee there were some people that should have been there who wasn't. You should have received an orientation recap from me. If you're not on a committee, I will send out another form so please fill that out. We did not get enough people for merch so everyone should be getting a refund. - O Secretary's Report: Hello everyone! My name is Amelia Landry and I am the Secretary. Welcome to the new members in the body. While I am talking, we are going to put a QR code on the screen for you to join the GroupMe which I will also attach to the minutes email. For the new representatives, your name will normally be called during the roll call

vote. Please do not worry that your name wasn't said at the start of this meeting – it is only because you technically haven't been appointed until we pass the bill. For the newer folks I also wanted to simply reiterate that the attendance policy is every Tuesday general body meeting and committee meetings for representatives, and only the first Tuesday meeting of every month (which just so happens to be today) and committee meetings are required for associates. Committee Reports-

- O Campus Outreach, Safety, and Concerns: COSCO met officially this weekend for orientation! Outside of Hope's legislation thanking EMS and our first responders for their response to our scare, we did not have much more. Welcome to our new members!
- O Congressional Administration: ConAd is a legislation based committee and we focus on the SGA governing documents as well as the other branches. This weekend we saw all of Chris' appointments and they were great. We also have some procedural legislation and an appointment bill for some members.
- o **External Affairs:** EA works with our local, state, federal, and tribal governments. Our job is to represent the interest of the student body to the governments that govern us. We had a very great meeting and met officially after orientation. We conversed about legislation we are seeing next Sunday. We will see Hope's bill regarding EMS and another broader gun violence bill, as well as one regarding a Cherokee Nation delegate.
- Human Diversity: HD focuses on diversity, equity and inclusion on campus. We do both
 projects and legislation. We met officially on Sunday and discussed our drive. Please donate

- Sustainability: Hi everyone, my name is Rylee Houston and I'm the Chair of the Sustainability Committee. We're pretty straightforward—My committee handles issues related to the environmental sustainability on campus, including recycling awareness and accessibility, food insecurity, climate legislation, and our monthly trash walks. We are more project based, but we do have some legislation in the works right now. As for what we're working on now, we met officially on Sunday after Orientation and welcomed our new members. <u>Author's Explanation (Halsey-Kraus)</u>: As per the regent's request SGA is allocated to request one day off every academic year. In the past we have recommended the Friday before OU Texas and we are continuing that tradition by requesting October 6th off. I understand that a lot of people would like to see voting day be the holiday requested off but we have decided as a big exec team to continue advocating that be University mandated holiday as opposed to a SGA mandated holiday.

- o Kathuria: How has that OUTX holiday benefit you as a student at OU?
 - It is a wonderful mental health break. I like to take it not to drive down to Texas but to sleep in. But this year I will be going to OUTX so I will use it differently.
- o **Reynolds:** Why can't we have an additional day in November for voting?
 - We have only been allocated one day to be able to request off. If it were up to me the voting days would also be mandated. It is up to the board of regents.
- o **Reynolds:** Is it possible for them to do it for presidential elections?
 - That would be a question for the next cycle of big exec positions. Hypothetically we could have done election day but we chose to do OUTX because it wasn't a presidential election.
- O **Chiariello:** Last year we had this exact same debate and there were talks about talking with higher ups. How have those conversations gone?
 - Conversations were stalled to my knowledge. I was not involved in them at the time as I wasn't chair.
 - **Griffin:** We talked with the faculty senate and it stalled out because there is a lot of red tape in granting holidays. Our move that would be best is to grant exemptions for those who go out and vote but this year since it's not a major election day, we still felt OUTX was the best way to go.

Author's Explanation (**Firch**): "It's On Us" has been utilized by SGA several years prior. It is a national movement made over a decade ago when people realized the need to raise awareness around gender-based violence and sexual assault. They start chapters at different campuses to talk about things regarding consent and how to be an ally. We wanted to bring it back. Emilie, Maria, and I interviewed multiple candidates and when we interviewed Emily we thought she was great because of the points she made and the passion she brought. 1:38 yielded to questions

- o Halsey-Kraus: Nominee, please introduce yourself!
 - Carr: Hello, my name is Emily Carr and I am a junior double majoring in criminology and social justice on the pre-law track. My pronouns are she/her/hers and I was born here in Norman. Both my parents went to OU but I was raised in Tulsa. I am the last of 3 kids to attend OU.
- o **Mullins:** Since this is a rebirth of the chapter, how do you expect to revamp it?
 - Carr: The last chapter was in 2018 so we don't have a direct predecessor to base our mission on but we are using the national mission of educating, preventing, and attacking the culture that perpetuates sexual violence. We have registered officially with the national board and we have gotten in contact with Amber May at the GEC and we are looking to do general support groups which would be peer lead to alleviate the hesitation victims have in approaching an authority figure. We are looking to cultivate a community of peers and support.
- Kathuria: Right before finals week we witnessed an event on campus corner with a former student stalking multiple women on campus. What are your thoughts on that's situation and stalking more generally?
 - Carr: It is concerning that we have a culture that perpetuates that. I am unfamiliar with that case and would have to take things on a case by case basis but ultimately we would be prioritizing survivor mental and physical health as well as safety.
- **Kathuria:** There is a 24 hour hotline for cases regarding sexual harassment and the like. How do you plan on communicating that resource to our consituents?
 - Carr: The hotline is under OU Advocates where faculty has that phone. We will be under Amber May who has that phone but the data won't be conveyed to us.
- O **Griffin:** Was there any specific events that made you feel the need to bring back this organization?
 - **Firch:** During the campaign formation process we met with the GEC and learned that there is always more work to be done. Unfortunately these situations have not gone away and I am not in a place to speak for people but I think a large problem is lack of education about what consent is. These conversations regarding consent might help.
- o **Griffin:** Can you talk about what is the first action we need to take as a university?

• Carr: When talking with Chris and Emilie about their campaign goals we talked a lot about the culture and I think we will be working closely with panhellenic and fraternal affairs to see how Greek life perpetuates that. But also athletics and the systems that allow the culture to take root. It's not just a random stranger on the street corner. It's your friend at the bar, the nice guy in your class. We need to look at who is actually doing this and how we can help.

Motion to extend time for questions by 5 minutes Representative Strickland seconded by Representative Gilson-Bond

- Kathuria: You mentioned the culture within OU Athletics. You might have been aware of the hiring of offensive coordinator Jeff Lebby and his track record at baylBr with lawsuits covering up sexual assault. How do you believe the "It's On Us" task force should be advocate to prevent people who have violated the law from becoming higher ups at the university?
 - Carr: I was not aware of that and it's disheartening. We can cultivate conversations and ask if they were aware of that when they made the decision. When conversations aren't started there is nowhere for us to go.
- o Reynolds: Will you be working closely with the established unit called Report It?
 - Carr: I am not aware of that group. If it was under the Title 9 office I would work them. We are going to do training with OU Advocates and Goddard.
- **Kathuria:** Do you have any plans to work with Exterior Director Brown to advocate for policies on the state and federal level?
 - Carr: I would be thrilled to work with him. As I mentioned we are at the start up and there are many steps that need to be taken before we get there but I would be more than willing.
- o **Kathuria:** PR is fundamentally important. Do you have any plans to collaborate with the director of PR Becca George and the Director of Communications Jessica Zimmerman to work with multiple outlets like the OU Daily and Nightly?
 - Carr: We are working with them and we have launched an "It's On Us" Instagram page. I worked with Becca to cross promote with SGA.
- o **Landry:** Do you intend to provide educational resources about how to support people who tell you they've been assaulted?
 - Carr: When I mentioned the support group, I am really passionate about not only targeting victims but also second-hand victims because sometimes you may not be affected by sexual assault but someone you know is, statistically. We can do more to start conversation, because it is so stigmatized. We will be working with outside sources to provide potential reporting and therapy.

<u>Author's Explanation (**Firch**</u>): Through the process, myself, Chair Halsey-Kraus, Claire Burch, and Corbin Walls, and as per the code Nick Hazelrigg (although he had a conflict and we had to email him our decision) we chose Eduardo Miranda. We had two applicants and picked him based on his passion for the court and his qualifications.

2:15 yielded to questions

- O **Dunn:** Was there only one vacancy or two?
 - **Firch:** There was one.
- Halsey-Kraus: Nominee if you would like to introduce yourself?
 - Miranda: My name is Eduardo Miranda, he/him, and I am dual degree in international studies and Italian with a minor in Spanish, on the pre-law track. I want to be a lawyer and I like organizations that are career oriented. I didn't realize that was something I was into until I joined O.I.L. and found it interesting. I believe being on Superior Court will be just as fun.
- o **Kathuria:** Have you had any chance to look at any previous Superior Court ruling such as Kathuria v Election Commission?
 - Miranda: I do not know that case by name but I have been able to find cases on the OU SGA website. I have looked over previous rulings especially elections. It is also something I would be able to look up later on if need be.
- o Kathuria: When you are making certain rulings are you going to go of precedence?
 - Miranda; It's not black and white and depends on the situation. If it looks like the case has similar previous precedent then yes but if it's something new then probably not. It is hard to say without seeing a case in front of me.
- o Gilson-Bond: What qualifications did the nominee have that made you choose him?
 - **Firch:** One thing is his ability to learn and grow. Eduardo hasn't been too involved with SGA but that can also be a plus because he brings an outsider perspective. His aspirations to go to law school and his ability to answer the questions during the interview.
- O Cantrell: You mentioned you had experience in the Oklahoma Intercollegiate Legislature. Can you elaborate on what that experience was?
 - Miranda: I realized joining O.I.L. that I like group oriented activities. I am introverted and when I went into it I wasn't expecting much but I was wrong. Seeing everyone getting along and trying to pass something despite their differences is enjoyable. You will deal with people who disagree with you and being able to find a solution. Being able to have practice during sessions has also helped me. I participated in moot court and I enjoy analyzing cases and patterns.
- **Kathuria:** Why do you think it's important for the Superior Court to have a balnce of undergraduate students and graduate students?
 - Firch: You can have cases that significantly impact undergraduates more and vice versa
 - HalseyKraus: I think it's also important to have a mix of views because law school students have a different perspective. Having Eduardo will give us a new perspective.
- **Kathuria:** Have you had a chance to learn the SGA Code Annotated and Constitution?
 - Miranda: I know where those documents are and I have gone over them. I
 don't know everything off the tome of my head but I know where to find
 what I need.

Author's Explanation (Firch): We had 3 applicants and we chose 2. Me and Hannah, the head of the parking appeals board, sat down during those interviews. Unfortuneatly they cannot be here tonight as they both have class, but I will read a paragraph from them each. "Hello everyone! My name is Cade Russell and I am currently a junior majoring in sports business and entrepreneurship. My apologies for not being at the meeting tonight, I look forward to meeting you all in person. I am very excited to begin my position as a parking appeals board member and play a part in representing our university. I feel lucky to go to such a great school and want to serve the community as much as it has served me. I will do my best to uphold the rules and regulations and serve my position well." "Good evening, everyone, I apologize for missing tonight's meeting. I have class that takes place at the same time. My name is Mike, and I am proud to be a nontraditional student here at OU. I am a MIS major and I plan to graduate in May of 2024. I am currently employed full time in the public sector. Working and being a full-time student, I am not able to participate in activities, such as Greek life or the many student associations, as much as I'd like too. I felt that getting active with the SGA would allow me to get involved on campus during my senior year. I wanted to apply for the parking appeals board because I have experience dealing with public matters daily since I work in the public sector, and I am a transfer student from OCCC. While I was there, I spent two years on their grade appeal board. I believe my experience working with the public, combined with working on the grade appeals board gives me a unique opportunity to give back to OU. I hope that my time working with the SGA and the parking appeals board will be a fun and a rewarding one. I am looking forward for my chance to give back to the university and to work with everyone. Thank You!" 1:04 yielded to questions

- **Kathuria:** I was reading the ConAd minutes and Mr. Russell said he would side more with the university. Can you explain why he has that position?
 - I haven't talked to Cade about that specific remark but I can attest to what he said in his interview. He said he wants to value OU's integrity. I think what he meant was to hear students out but still value the rules that are there for a reason. Specifically, one question he was asked on if someone was returning something to the library and they got a ticket, if it was their first or second time getting a ticket he would side with the student. He has realistic solutions.
- O **Griffin:** In your view of the parking appeals board as your administration would like to see it, which approach do you think is better?
 - A lot of it for us is about transparency for the parking appeals board. I have met with the Director of Parking Services Chris Glenn and having conversations with him, the board is still siding with students. I know they are realistic.
- O **Dunn:** I believe you got 6 applications. How many of those scheduled interviews and how did you come to the determination to only appoint two?
 - Only 3 set up interviews with only multiple days notice. With those two it came down to their passion and we appreciated their responses during the situational questions which were logical.
- **Kathuria:** I would like to hear their positions on students who park in spots reserved for disabled people?

- Unfortunately I haven't gotten to discuss that topic with them but I hope you know that based on their other responses that they would be logical and reasonable.
- o **Kathuria:** Are the two nominees aware of instances where people are illegally parked due to a thunderstorm and what is their position for those cases?
 - Like I said, I don't want to speak for them. Both will be at GSS Thursday and hopefully that question can be addressed then.
- o Gilson-Bond: During the interview process what questions did you ask?
 - We had 5-6 questions that were a mix of getting to know them and their experience in addition to situational questions. Both answered that if it was someone's first time getting a ticket that they should let them off and explain to them the rules.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION:

- **Section 1**: Title: This act shall be known and may be cited as the "Judicial Clarification Act."
- **Section 2**: Purpose: The purpose of this act shall be to redact redundancies in the SGACA.
- **Section 3**: AMENDATORY: The University of Oklahoma Student Government Association Code Annotated Title IV, Chapter 2 Section 8 will be amended as follows, with strikethrough indicating a removed section, and <u>underline</u> indicating added sections:

Title IV, Chapter 2 – The Student Superior Court

8. Membership. The judges of the Student Superior Court shall be regularly enrolled students and must have completed two (2) full semesters as a full time student at the University of Oklahoma at the time of this appointment and confirmation.

1. Nomination

- 1. Nominations are to be called for the outgoing Superior Justice, or any other SGA officer, four (4) weeks prior to the expiration of their term in office.
- 2. Nominations must be open for at least one (1) week, and shall comply with all applicable law.

2. Appointment Process

- 1. All applications that comply with the requested formatting and content requirements must be considered.
- 2. Those applicants selected for an interview are to be given a minimum of two (2) days' notice of their interview time and venue. Notice may be given orally or in writing.
- 3. Interviews shall be conducted by a panel comprising the SGA President, the Chair of Graduate Student Senate, the Chair of

- Undergraduate Student Congress, the SGA General Counsel, or their respective designees, and the Chief Justice of the SGA Superior Court.
- 4. Superior Court Justices will be appointed by a majority vote of the panelists, excluding the Chief Justice. The Chief Justice will only vote in the event of a tie.
- 5. Vacancies on the Superior Court shall not exist for longer than thirty (30) days from the occurrence of the vacancy.
- 6. The constitutionality of a justice's appointment should be based solely on whether they met the membership requirements at the time of their appointment.
- 3. Number of Justices. The Legislative Branch shall establish the number of justices sitting on the Student Superior Court. The membership of the Student Superior Court may not be reduced in such a manner as to force the involuntary retirement of justices. The membership maybe increased at such additions shall not become effective within the same presidential term as when the increase has been initiated. The size of the SGA Superior Court shall be set at seven (7) justices.

- **Section 3**: AMENDATORY: The SGA Code Annotated Title 1.3.2(d)(vii) is amended as follows. New additions shall be denoted by an <u>underline</u>, and deletions shall be denoted by a <u>strikethrough</u>.
 - vii. **Signature Sheet** A sheet for collecting student signatures in support of placing a Proposition on the ballot for the student body to vote upon.
 - 1. The Summary of the Proposition shall be printed on the top margin of each Signature Sheet in no smaller than 12-point Times New Roman font.
 - 2. Every signature sheet must have twenty-five (25) separate signature lines to collect a signatory's full name, their signature, and their complete OU identification number.
- **Section 4**: AMENDATORY: The SGA Code Annotated Title 2.1.5(a) is amended as follows. New additions shall be denoted by an <u>underline</u>, and deletions shall be denoted by a <u>strikethrough</u>.
 - a. **Joint Committee**. Joint committees shall be composed of the Chairs of each House, the Chairs and Vice Chairs of the Committee with jurisdiction over the Act of Legislation, and the Vice Chair or representative of the House in which it originated. The Chair of the House in which the Act was first moved shall preside over the Joint Committee and vote only in case of a tie. The resulting Act approved by the Joint Committee shall be referred to each House for consideration. If the Act passes each House by majority vote, then it must be presented to the SGA President in accordance with Title II, Chapter 1, Sec. 5.3. Title II, Chapter 1, Sec. 5(b). If the Act reported out of the Joint Committee is not upheld by each House, the Act fails.

- **Section 5**: AMENDATORY: The SGA Code Annotated Title 2.3.7(a) is amended as follows. New additions shall be denoted by an <u>underline</u>, and deletions shall be denoted by a <u>strikethrough</u>.
 - a. **Voting by Proxy**. An absent Senator may assign his their vote to a proxy. That proxy must be in attendance when the voting occurs and cannot assign the vote to another member of the Senate. If the Chief Justice is unavailable to administer the oath, the Chief Justice shall select another person to do so. After the oath has been administered the President will give an inaugural address.

CONGRESSIONAL BILL AB-109-07 SENATE BILL NO. GS22-23

AS INTRODUCED

An act relating to appropriations; providing for short title; stating purpose; appropriating Primary Funding for the 2023-2024 process; stating appropriation guidelines; establishing expiration deadline; directing transfer of unused funds by deadline; and providing an effective date.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION:

- **Section 1:** This act shall be known and may be cited as the "Primary Funding Act of 2023 for Governmental Organizations"
- **Section 2:** PURPOSE. The purpose of this act is to appropriate the funds of the University of Oklahoma Student Government Association to the organizations mentioned within.
