On a motion to see CB-110-20 Gilson-Bond seconded by Harris

- CB-110-20 “October 2023 Superior Court Appointments Act” (ConAd, Do Pass) (Firch, Birch, Halsey-Kraus, Taylor)

Authors Explanation:

Hello, my name is Chris Firch, SGA President. We had interviews last week with Chair AHK, General Counsel, and myself. Chief Justice Walls agreed with the nominees. They had good interviews and good understanding of governing docs. We asked how they’d interpret things, and they had good answers. They both really respect precedent.

- Rhoades: Would you mind introducing yourselves?
 - Grace: Alumna of OU, first year law student. I love OU and I benefitted from SGA so I respect all that you do. I’ve had legal internships and involvements around law during undergrad. My career ambition is to become a judge. I’m excited for the opportunity.
 - Hepburn: Political Science pre-law student. I was Director of Inclusivity and ran for Vice President of SGA. Also, in CAC and the BSA, leadership scholars. I have completed multiple legal internships.
- Strickland: How did you find out about the Superior Court application?
 - Hepburn: I was notified by Chief Justice Walls
 - Grace: GC Maddy Taylor told me.

On a motion to divide the question Kathuria Seconded by Reynolds

On the question as it pertains to Nominee Grace, 5:00 for questions

- Kathuria: Why do you believe it’s important to maintain precedent?
 - I think at our level there’s room to evolve but I think the constitution and precedent are thorough, good, and solid.
- Kathuria: Which previous questions have you read?
 - All 3 cases
- Cantrell: There is a possibility that we’ll have to update the constitution in the future. To what extent are you familiar with governing docs?
 - Grace: I have read them fully.

- Duncan: What questions did you ask and what were her good answers.
 - Grace: Why they applied, their understanding of governing docs, when it's justified to overturn elections. I think they were reasonable and respectful.
- Gilson-Bond: Author, how long were applications open?
 - A week.
- Kathuria: Nominee, when would it be appropriate to overturn precedent?
 - Grace: Every situation is different, but it would require something very serious and it's important to get others' opinions.
- Kathuria: Nominee, how do you plan on using your role to uphold the integrity of the Superior Court?
 - Transparency is important. Making sure we put our full thoughts into the text of those previous cases.

On the bill as it pertains to nominee Hepburn, 5:00 for questions:

- Robinson: Nominee, to clear controversy, did you attempt to disqualify the opposing ticket in 2021?
 - No
- Kathuria: What was it like speaking in front of the Superior Court in 2021?
 - It was a good opportunity to voice my concerns.
- Cantrell: Nominee, would you say your experience arguing before the Superior Court led you to wanting this position?
 - I would say no. My reasoning is that I want to give back to OU and SGA.
- Kathuria: Nominee, in Hepburn v. SGA, you made an argument that professional service should be defined in a way that is obtained for a candidate's benefit. Do you stand by that definition?
 - I stand by the Superior Court decision.
- Kathuria: What specifically was the precedent set?
 - It was that in an election budget, specialized services should be taken into consideration if a person does them in return for monetary gain. Those should be listed on financial reports.
- Kathuria: Nominee, in Hepburn v. SGA, you made an argument that you didn't assert that the Lissau campaign's video unfairly influenced the vote count. Do you stand by that?
 - There's no way to know how it influenced the vote count.
- Gulam: In Hepburn v. SGA, a lot of people criticize it as wanting to overturn an election. It did require you to stand up when others disagreed, and you had reasons. You'll experience the same thing in the Superior Court. How will you deal with that in the future?
 - I'm a believer in making sure things are done the right way and sometimes that requires making hard decisions without bias. Using transparency and fairness.

Motion to extend time by 5:00 minutes Kathuria seconded by Reynolds

- Kathuria: Nominee, in Hepburn v. SGA Election Commission, you could've argued about points subjecting Lissau-Akuffo to disqualification. Do you still hold that position at the moment.
 - If they went above their campaign budget, they were in violation of the SGACA. Repercussions that came from that are fair. I didn't believe they should be disqualified.
- Kathuria: Nominee, in regard to the video, do you stand by the position that there's no way to determine the real cost of the Lissau-Akuffo video actually was.
 - The decision of the Superior Court set a good precedent. In terms of the video specifically, I had no way of saying whether or not I could give a direct value, but the person who recorded it was not able to make it to court so we could not determine.
- Rhoades: Nominee, do you think that having been before the Superior Court before will help you serve as a Justice?
 - I feel like being on both sides is a unique experience and knowing that process will let me think differently than other justices.

AS INTRODUCED

An act relating to appropriations; providing for short title; stating purpose; appropriating Auxiliary Funding for the 2023-2024 process; stating appropriation guidelines; establishing expiration deadline; directing transfer of unused funds by deadline; and providing an effective date.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION:

Section 1: This act shall be known and may be cited as the “Auxiliary Allocation 9 Act of 2023-2024”

Section 2: PURPOSE. The purpose of this act is to appropriate the funds of the University of Oklahoma Student Government Association to the organizations mentioned within.

AS INTRODUCED

A Concurrent Resolution Recognizing November 11th as
Veterans Day; and providing for distribution.

- Whereas: In 1954, Congress passed a bill that President Eisenhower signed, proclaiming November 11th as Veterans Day; and,
- Whereas: Veterans Day celebrates the service of all U.S. military veterans, whether during times of peace or war; and,
- Whereas: Last year, there were 244,334 veterans living in the state of Oklahoma¹; and,
- Whereas: Out of those 244,334 veterans, approximately 104,000 have some form of service-connected disability²; and,
- Whereas: The approximate number of enrolled veterans at the University of Oklahoma, Norman campus, and the University of Oklahoma, Tulsa campus, equals 1,600; and,
- Whereas: The University of Oklahoma offers resources to veteran's on campus such as Veteran Student Services, which provides financial help, counseling, healthcare resources, and more; and,

AS INTRODUCED

A Concurrent Resolution recognizing the month of
November as Native American Heritage Month and
providing for distribution.

- Whereas: Native American Heritage Month is celebrated during the month of November; and,
- Whereas: Native American Heritage Month is used to promote the identities and culture of Indigenous Peoples³; and,
- Whereas: Native American Heritage Month is also used to educate the general public on the challenges Native peoples have faced throughout history and today; and,
- Whereas: Native American Heritage Month was first recognized by the United States federal government in 1990⁴; and,
- Whereas: 9.5% of the State of Oklahoma’s population identifies as American Indian and Alaskan Native; and,
- Whereas: 6.7% of the State of Oklahoma’s population identifies with Two or more races which may include American Indian and Alaskan Native; and,
- Whereas: Native Hawaiian or Pacific Islander makes up 0.3% of Oklahoma’s state population⁵; and,
- Whereas: As of Fall 2023, The University of Oklahoma had about 29,166 students enrolled across all campuses; and,
- Whereas: 1,107 of those students identified as American Indian or Alaskan Native; and,

Whereas: 2,649 students identified as biracial which does include any American Indian students who identify as such⁶; and,

Whereas: 30 students identify as Hawaiian Native/Pacific Islander at the University of Oklahoma; and,

Whereas: Some people of Native heritage do not specify their race when asked, and as a result, these percentages may be inaccurate; and,

Whereas: The University of Oklahoma currently resides on the traditional home of the Caddo and Wichita nations. As well as once being a part of the Muscogee Creek and Seminole nations⁷; and,

Whereas: Suppression, assimilation, and removal of Native Peoples and their culture were official policies by early state and federal settlement laws⁸; therefore

BE IT RESOLVED BY THE UNIVERSITY OF OKLAHOMA UNDERGRADUATE STUDENT CONGRESS AND THE GRADUATE STUDENT SENATE, CONCURRING THEREIN THAT:

- Section 1:** Title: This resolution shall be known and may be cited as the “Native American Heritage Month Recognition Resolution of 2023.”
- Section 2:** The University of Oklahoma Student Government Association shall recognize the month of November as Native American Heritage Month.
- Section 3:** The University of Oklahoma Student Government Association shall recognize and honor the Native American students at The University of Oklahoma in addition to their culture and heritage.
- Section 4:** The University of Oklahoma Student Government Association shall recognize that the University of Oklahoma resides on traditional Native American land.
- Section 5:** The University of Oklahoma Student Government Association shall condemn any laws and policies that have or currently suppressed, harmed, and/or denounced any Native peoples, as well as their culture and heritage.
