On a motion to approve the minutes Aslam seconded by Coats Officer Reports -

- o Chair's Report: Please join the GroupMe. We have had a lot of legislation written by members of the body. I would prefer that all legislation is viewed by myself and the committee chairs. Let's keep everyone in the loop.
- O Vice Chair's Report: Everyone should have a nametag and we have snacks up here. If there is any spelling or anything incorrect on the nametag, please let me know. New members should have received an email about new member orientation, Sunday 11-3. It is in the Scholar's room of the Union. The dress code is business casual. I will be taking your headshot. If you are an older member and would like a headshot, please stop by the Conoco around three. If you have a dietary restriction, please let me know as soon as possible. This is for anyone who will be appointed tonight or anyone who has not attended an orientation. February constituent service points will be happening this month. I will send out an email tomorrow with the link to the form and the spreadsheet to see if you have been marked off. To the new members, follow our Instagram @oucongress. I will take photos tonight. If you do not want to be posted, please tell me. For old members, please sign up for our Big Event April 6th 10-2. The link is in an email I sent out along with the link to sign up for the Food Pantry volunteering which is April 19th 2-4pm at the OU Food Pantry. We have our November member of the month: Kendall Cousins!
- Secretary's Report: I am so happy to see everyone today! Since we have some new
 people here, I will explain the attendance rules again. Representatives must be at all
 General Body Meetings unless they email me, and Associates must be at the first meeting

of the month unless they email me. Both Representatives and Associates must be at all your specific committee meetings unless you tell your committee secretary. Everyone gets four unexcused absences. Based on my records, we have quite a few associates who are gaining unexcused absences quickly due to not going to committee meetings. It is so important that you participate in Congress no matter your position. Here is the link for the associate attendance.

Committee Reports-

- Campus Outreach, Safety, and Concerns: Hi, my name is Hudson Haskins, he/him, I'm the local funny guy. Sorry, that was funnier in my head. What else do I need to say? I've got two out of the four. Oh, my committee, right. I'm representing Campus Outreach, Safety, and Concerns, or COSCO. We deal with campus outreach, safety, and concerns. For outreach, that looks like spreading awareness of Congress to the student body through tabling events like our upcoming Valentine's tabling to pass out sexual health and wellness items on Monday. Outreach and safety also look like taking student concerns. Say, I recently had a student reach out to me about free masks on campus. I found out that Health Promotions has free masks for students and got that information back to them. Safety also includes our monthly light walks, where we meet up, take note of lights off across campus, and let facilities management know. It's a great time, a great opportunity to meet other members, and our light walk will be this weekend, Sunday, at 6 pm. Just a couple of hours after orientation. Is there anything else? Oh, right. I'm a dad. That's why I'm wearing my shirt around my waist. She's cute. You'll see her sometime. Actually, you might have already seen her. She's in GroupMe. Yeah. Thank you.
- Congressional Administration: CONAD is the "internal affairs" of Congress, and we deal with admitting new members to the body, work with appointing executive offices, and handle the governing documents of SGA. CONAD did not meet this week, but Secretary Berggren, Vice Chair Landry and I conducted GenApp interviews! We have some awesome new members, and we will be seeing their appointment bill in committee of the whole. I hope you all are having a wonderful week.
- o External Affairs: Hi all my name is Marilou Bento and I serve as the chair of External Affairs. External Affairs serves as the committee that addresses issues concerning tribal, local, state, and federal government as well as global issues and how they affect OU and our students at large. One of the goals of the committee is to continue to improve the relationships with our representatives across all the different levels of Government. We are in charge of organizing different events like National Voting Day in the fall where we get to do a tabling event for Voter Registration, and Higher Education Day where we get to go to the capitol and speak to our representatives advocating for more higher education funding just to name our two big ones. EA met officially on Sunday. We got to talk about higher education day and the protocols surrounding the day and generally what to expect. We also saw our Higher Education Day Resolution, which we will see tonight as well. We also covered our other projects briefly; with a Resolution recognizing Black History Month coming up next! If you are RSVPed for Higher Ed Day the master schedule for higher education day should be sent out by tomorrow, so everyone please watch your email for that. The schedule will tell everyone who they will be meeting with throughout the day.
- o **Human Diversity:** My name is Hope and my pronouns are she/her/hers. Any issues on campus that relate to Human Diversity or any projects we focus on. We are currently

- working on a drive for a LGBTQ+ youth. We will be collecting toothbrushes and other items like that. We in the past have written anti-Jewish hate bills.
- Sustainability: My name is Rylee my pronouns are she/her/hers. We focus on issues, projects, and awareness relating to sustainability on campus. We will be having our first trash walk on February 18th at 1pm. We will walk around campus and pick up trash. We did not meet this week. We are seeing our first bill in like two years about raising awareness on littering.
- O University Policy: Hey, all! My name is Caleb Robinson, and I am the University Policy Committee Chairman, colloquially known as UPOL. We are heavily project-oriented in UPOL, but there is always room for flexibility if you are interested in pursuing legislation along with a project. We focus on university policy, programs, and initiatives or the lack thereof. One of the most pressing issues we have recently taken up is our bill supporting DEI in the State of Oklahoma, which has had a lot of input from members throughout Congress, the Graduate Student Senate and the executive branch. We recently completed two projects, one focusing on enhancing the transfer student process and providing more resources to make that transition as smooth as possible. The other project is focused on advocating for changes to our enrollment system since we have heard that students are having issues understanding their schedule when they first enroll. We get the opportunity to be some of the first people to test pilot programs that include the changes to this system. We are working on increasing benefits for student employees and advocating for open educational resources, among other things. Finally, we did meet officially this weekend and worked on sending out emails and assigning new projects.
- Ways and Means: My name is Izza and my pronouns are she/hers. We allocate funding to all student organizations on campus. Aux funding is what we do week to week. WAM met last week and saw Aux 11. Authors Explanation:

This has statistics about how the University helps Oklahoma and how Oklahoma has been funding us broadly. We talk about what is going to be needed in our workforce in the upcoming years, and talk about the importance of that.

- Halsey-Kraus: Will you explain what Higher Education Day is?
 - We go to the Capital and speak to Representatives one on one and speak about why university funding is important to us. We talk about why funding is important to us and why it matters to students at OU and other Universities.
- Halsey-Kraus: When is Higher Education Day?
 - o This Thursday.
- Halsey-Kraus: Are you excited?
 - o I am hyped.
- Anand: What is the role of DEI in universities funding and why do you think it's important to mention it in this bill?
 - We find it important to mention this bill due to the Executive Order made by Kevin Stitt. DEI is important to support under-supported students. This is for students who did not receive enough support prior to coming to college that would get support at the University level. This program helps those students to succeed.
- Kathuria: What is the strategy for Higher Education Day this Thursday regarding approaching saving and preserving DEI?
 - We will be talking generally about our experiences and how the programs have affected us students. It's a one-on-one meeting so we can share our personal experiences. We will talk a lot about how these programs have supported us and given us possibilities to be here.
- Keupen: Would you accept an amendment to the 11th whereas clause that reads "Whereas: The Governor's Executive Order 2023-31, which requires state agencies and institutes for higher education to initiate a review of DEI positions, departments,

activities, procedures, and programs, and mandates the restructuring and/or elimination of DEI initiatives."

- o Yes.
- Schonfield: What inspired you to write this bill more than anything else?
 - It is important that we tell everyone publicly as the University of Oklahoma what we want as students, which is more education, support in our programs, and eyes on our efforts to make Oklahoma better.
- Anand: Let's say this bill doesn't pass or that it's not effective, what would you do in that case regarding DEI?
 - We would try to find workarounds and find ways to have programs that are adjacent to DEI but not explicitly DEI. Also, we can share how DEI has helped us while still complying with the Executive Order.
- Kathuria: Regarding your concerns regarding lack of higher ed funding, do you plan on bringing up issues such as outdated building, increased tuition, and expensive course materials when speaking to legislators on Thursday?
 - Yes. All those factors affect students directly. We all bring up our personal experiences along with statistics.

On a motion to extend time for questions for five minutes Anand seconded by Kathuria

- Anand: You mention the programs of DEI help those who did not receive support before college, can you give an example of a population that might not have received support and how existing DEI programs can support them?
 - o For example, I am in a DEI program for engineering. They are they to support those who are represented in the engineering department, so in that case its women, LQBTQ+, people of color, and religious minorities. Anyone that does not have a lot of community here at OU or does not have a coalition would be included.
- Anand: Would the Executive Order change the way the programs are being run?
 - o It could be affected. We are not quite sure yet.
- Coats: Would you accept a friendly amendment changing Section 2 to read "Section 2: OU SGA Undergraduate Student Congress encourages the protection and promotion of DEI programs, and for state funding to be protected for DEI programs."
 - o Yes.
- Strickland: What are you most looking forward to on Thursday?
 - o Hanging out with everyone who wanted to spend their day going to the Capital. It fills my heart. I am excited to build connections and talk to Representatives.

On a call for debate Anand

Pro:

• Kathuria: My name is Shrey Kathuria (he/him/hims). I am here to talk about why we need to pass this bill. This bill is essential. It has something that is essential to who I am: diversity, equity, and inclusion. We must have a plan to protect and preserve DEI. My constituents are very concerned and have a lot of fear and anxiety about the attack on DEI. They are concerned about what is going to happen to ADRC funding, The Trio Center, Project Threshold, and The Campus Climate Response Team. These programs need to be protected. We need to make sure we tell state legislators that we care about these programs because they help students no matter their race, sexual orientation, or their gender identity. We need to stay true to these principles. Every person in this room

has something that is very powerful about themselves. DEI must be our top priority. If not, there would be many students being harmed. That would not be ok with me. Vote yes to this bill and stay true to our values.

Opposition:

• Anand: I do not know what to think about this bill. There are some objections that I have. The bill has two parts, regarding the one about increasing funding, I think there is a lot we could use funding for. The second part is regarding DEI that ties into the Executive Order. I want to say I really care about diversity, equity, and inclusion. I think that these principles are very important to strive for. I think the university will be a better place if it is diverse and includes all people. Also, I want to point out that some DEI programs can be helpful, but some can harm populations by not properly supporting them or excluding them. There are some things in the Executive Order that I want you to consider. One thing my colleague pointed out is that people don't know how it will affect the ADRC. But this bill does not apply to those with disabilities or alternate abilities. It does not stop all diversity, equity, and inclusion activities, it only restricts certain types of activities.

Pro:

- Robinson: If you have any issues with the DEI portion of this bill, that is only a small portion of the bill. We have an 8-page bill coming next week all about DEI, so if you have concerns about DEI and how we are addressing it, I recommend that you wait until the bill next week that is all about DEI and our support of it.
- Baggett: When we are talking about ADRC and disabilities or accessibility and all things like that, I think what was pointed out were concerns regarding how it would affect them, not specifically how the Executive Order was going to affect them. I think the concern is that people are so afraid that we are going down the path of legislation, so we should be putting out a statement to alleviate those concerns. We cannot override an executive order because we are a student congress. We are not putting anything into legislation, we are just stating what we support. This is a resolution. I think it's more important to put that out than pick it apart and scrutinize certain portions that do not align with your personal beliefs. It is valid.

Opposition:

• Anand: It would be a good idea to raise these concerns to legislators. We should talk to them about what their plans for legislation are in the future. I know it was mentioned that they might restrict more groups in the future, so talking to them would be good. I would want some clarification on what portions of DEI would be affected and get their thoughts. It is good that we can look at the issue of DEI more closely with the upcoming bill. I will bring other concerns about the DEI programs next week, but I think for now these were all good ways to address the scenario.

Authors Summation:

This bill is not a response to the Executive Order. It is only a bill that deals with us going to Higher Education Day and asking for more funding. That covers a wide variety of topics and that is why there are not many specifics about DEI. It is very broad.

AS INTRODUCED

AS INTRODUCED

An act relating to appropriations; providing for short title; stating purpose; appropriating Auxiliary Funding for the 2023-2024 process; stating appropriation guidelines; establishing expiration deadline; directing transfer of unused funds by deadline; and providing an effective date.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION:

Section 1: This act shall be known and may be cited as the "Auxiliary Allocation 11 Act of 2023-2024"

Section 2: PURPOSE. The purpose of this act is to appropriate the funds of the University of Oklahoma Student Government Association to the organizations mentioned within.

CONGRESSIONAL RESOLUTION CR-111-01

AS INTRODUCED

A Congressional Resolution requesting support for increasing funds for higher education resources distributed by the State Government of Oklahoma; and providing for distribution.

Whereas: The fiscal year 2020 appropriation for higher education by the State of Oklahoma

was \$1,003,794,375¹; and

Whereas: By 2025, 70 percent of jobs in Oklahoma will require some college, a long-term

certificate, or a college degree²; and

Whereas: 96% of Oklahomans who graduate from a state system college or university remain

and work in the state one year after graduation³; and

Whereas: For every dollar of state appropriations invested, the State System of Higher

Education generates \$9.40 in economic output4; and

Whereas: Oklahoma's higher education system supported \$8.21 billion in total economic

output in FY20165; and

Whereas: Research findings continue to point toward increased education as an underlying

source of economic growth, both in the U.S. and internationally, reinforcing the existence of a strong empirical link between education and economic growth at the

state level; and

Whereas: The University of Oklahoma Health Sciences Center supported the greatest amount

of local economic activity among all institutions and constituent agencies; and

Whereas: The facility supports approximately \$1.85 billion in total economic activity, 10,700

jobs, and \$1.1 billion in employee compensation in the Oklahoma City region; and

Whereas: In Fiscal Year 2023, the regents complied with the request and submitted a report

that showed less than 1% of state and federal funding supports DEI; and

Whereas: They estimated \$10.2 million in DEI spending for the 2023-2024 fiscal year, with

\$3.4 million of that amount coming from state appropriations⁶; and

Whereas: The Governor's Executive Order 2023-31, which requires state agencies and

institutes for higher education to initiate a review of DEI positions, departments, activities, procedures, and programs, and mandates the restructuring and/or

elimination of DEI initiatives.

Whereas: This executive order puts at risk the DEI programs at the University of Oklahoma;

and

Whereas: The order could put federal funding or accreditation at risk, as many colleges depend

on millions of dollars in grant funding, and several grants are tied to DEI support;

and

Whereas: DEI programs give necessary support to underrepresented minorities⁷.

NOW, THEREFORE, BE IT RESOLVED BY THE UNDERGRADUATE STUDENT CONGRESS THAT:

Section 1: Title: This resolution shall be known and may be cited as the "The Higher Education

Day Resolution of 2024."

Section 2: OU SGA Undergraduate Student Congress encourages the protection and

promotion of DEI programs, and for state funding to be protected for DEI

programs

Section 3: OU SGA Undergraduate Student Congress encourages federal entities to

appropriate more funds to Oklahoma for use in education.
