- Campus Outreach, Safety, and Concerns: Hey everyone, great to see you all! COSCO met officially this past Sunday. We discussed project updates and next steps. Almost done interviewing everyone who is interested in being COSCO Secretary or Vice-Chair. I just have one more person to interview so those positions will likely be filled by our next general body meeting. I also have an update regarding our Light Walks. Those will generally be held the fourth Sunday of each month at 8:30 pm. Thank you!
- O Congressional Administration: ConAd met officially on Sunday! We saw CB-112-11, we gave it a rec of no rec and CB-112-12 and we gave it a rec of due pass. Today we are going to talk about a standing rules update we did this week in ConAd and Exec! If you are interested in tabling for SGA elections, there is a sign-up genius link that will be attached to the minutes of today's meeting! I will also send it in our announcement group me! We are tabling on the 29th and the 30th and we will need lots of help! Please send any relevant links for SGA elections in student org group chats!
- O External Affairs: EA met officially this Sunday and we saw a piece of legislation; The Medical Marijuana Survey of 2024 and we gave it a recommendation of due pass. We will be seeing that shortly. We also discussed our other projects including our Free Speech Week Legislation which we can expect to see in the body in 2 weeks. We also discussed another upcoming piece of legislation, our Voting Day legislation, that will recommend faculty to give an excused absence for Voting Day. I will be talking about the legislative at the next Faculty Senate meeting to gather some feedback from professors in preparation for it. The other two central projects we discussed 1. was our project related to getting a permanent shelter established in Norman for the unhoused, we have been in communication with Food and Shelter and we have decided to petition on behalf of the opening of the shelter, collecting signatures from Norman Residents. We will also be in contact with Darrel Pyle, the Norman City manager, to facilitate this project going forward. We also discussed our Public Education project; members of EA will be reaching out to various research groups around Oklahoma to develop a clearer plan on how we will support Public Education going forward.
- O **Human Diversity:** HD met officially Friday, we were just continuing discussing our projects that I talked about last time, we realized some of the programs and organization that we wanted to set up may have been already in place last semester with some policy changes.

• CB-112-10 "OU Medical Marijuana Survey Act of 2024." (Rec of Due Pass) (Harris)

Authors Explanation:

Howdy y'all so basically, I will give you a brief introduction as to why this popped in to our mind and why we decided to write this. I will give you a brief description to how this survey works and how we address questions. so basically, marijuana is currently under schedule one federally meaning that there is no accepted medical use for it. The Department of Justice has recently submitted a recommendation to change that from schedule one to schedule 3 and this allows for a lot of changes marijuana laws are enacted on the federal level, including the Directory School Zones and communities Act. So this can change our, generally the OU policy now is that we don't talk about it, it doesn't exist, its better illegal, but that can change in the recent future. So we kind of wrote this survey to gain perspective and insight in case some of the changes do happen we can make accurate legislation. So I will go ahead and give you a brief description, basically this is the introduction this is what you are going to see it states the purpose of the survey what it is that you are going to do. It is also very important participation confidentiality, we are collecting zero personal information, there is nothing going to be collected about email, phone number, there is zero identifying information. All information will be quantitative metrics, not a name, not a phone number, no way to associate you whatsoever. So we get some brief demographics, all of these are optional by the way and we will do a brief of awareness for everyone to get a general understanding of where are people are coming from. The confusing part of the survey is this, the decision tree. At this point you get three different surveys they are all going to be very similar questions but structured differently to accommodate the different setup. If you look at never have a license you are going to have look at do you know someone who has used marijuana for medical purpose. A lot of these open field type responses are also completely optional just so we can get some more qualitative information about what students

want. One that's probably going to pop up is when it says schedule one to schedule three, we really made sure to include a link to the actual VDA drug scheduling thing. 5:05 remaining for questions

- Estrada- Will the results of the survey be published to the students?
 - O Yes my plan is to wait around three to four weeks to collect the conference of data and then we're going to release a research paper based off of our findings and this will be sent to the Congress Chair and to the Committee it will probably be posted on the SGA website. Any information we get from this will be public information that will be given while doing a research paper style.
- Carter- How do you believe that this survey will benefit OU students?
 - O I will say that because of current states of OU's policy. We really don't have an understanding of what students want from us and what students want in this area. So the way that this can benefit is if we understand what the students want, we will be able to give them what they want in policy, we as lawmakers do not create laws that we want, we create laws that our constituents want us to make. We want to be able to know what they want and them we'll be able to execute an action plan to implement those decision later on if possible.
- Kathuria- Would you like to finish your presentation?
 - o I just wanted to explain the scale of it real quick, so basically we use something called a the Likert scale, so you can see, definitely yes, probably yes, might or might not, probably not, definitely not. It is going to be all of those style of questions depending on the question, so this is known as the Likert scale is it very commonly cited in survey instruments, it allows you to get a range of data and allows you to break it down on much different levels. For instance, if 80% of people say definitely yes that would indicate a very strong definitely yes vote, but if we are looking at a 50/30 yes vote then not as strong, basically it is just the scale that we use.
- Bento- Can you explain why we are seeing this survey as a bill instead of how we do it in the past?
 - This is the first of its kind not the last, we are changing the way that we are doing surveys. Initially we kind of just gave them ran them through George, he said yes or no sent out through the OUMM system under the SGA moniker. We have noticed that there are a lot of emails going out, a lot of people asking for surveys and we as an SGA want to make sure that we are only giving out what us as a general body feel what's likely need to get out so from now on most surveys that are going to be released in this exact format, so this mock legislation will be used for future surveys.
- N. Coats- In section 4, how do you plan to make sure students will fill out the form?
 - O With the number of questions we have we are hoping for about what will give us true correlation qualitative turnout values would be about 200 responses so that is out goal if we get under that, it doesn't mean that the survey was a failure by any means, its still important qualitative data that we can bring to the table. We are striving for that 200 mark ideally we know that not many people are going to fill out based off of the mass mailing system, so one of my main plans for the tasks is to target professors to show in class and RSO's. So messaging RSO's using the actual general body to be able to get this survey out and using all of y'all to help me would make it so we can hit that mark and get more people.

CB-112-11 "Appointing Parking Appeals Judges Act of Fall 2024." (Rec of No Rec) (Glasscock/Ousley/Wolthuis)

Authors Explanation:

Hi everyone, my name is Caden Glasscock I am your SGA president and so one of these abilities that I have being the SGA President is appointing people to multiple committees including parking appeals and that is what we're doing right now. Hey y'all If you don't know me my name is Ellie Wolthuis, I am the Chief of Staff and to talk a little bit about the process, we received a ton of applications for parking appeals just for transparency not everyone meant to apply for parking appeals. So I went through all these applications and decided who had a good application clearly they meant to apply for parking appeals, we're going to push them through to an interview and all of these nominees standing before you today is because they had a phenomenal application and then a fantastic interview. Yeah, so myself and the Chief Justice of parking appeals, we did interviews with all of these fantastic people and we ultimately determined that we believed that they would be great in this position. The parking appeals currently only has one person and the Chief Justice and by adding these people we believe that this will be more productive and allow for us to continue get these appeals out in a more timely fashion, but now I am going to let these people introduce themselves just quickly say you name and major. I'm Makhenzie Hutcherson and philosophy. I am AbdulMalik Shodunke and I am computer science. I'm Colby Marlow and I'm business administration and pre-law major. I'm Dax McReynolds, I am a business management major and on the pre-law track. Hi, I am Daisy I am an English writing major, and I am also on the pre-law track. Hi I am Reeve Holliday, I am a biology major on the pre-med track. Hey y'all my name is Payton Premo and I am a criminology major. Hi I am Cody, I double in political science and economics. I am Ben Keupen my major is political science on a pre-law track. 6:10 remaining for questions

- Coats, Noah- What specifically made you interested in this position?
 - Hutcherson- I was interested in this position because a like a lot of OU students I feel very passionately about the parking situation, and I felt that this was the best that I could do to do my part to help with it.
 - Shodunke- I was interested because while I don't actually need parking on campus, everyone I know is very passionate about parking and how frustrating parking tickets are so when I saw this position I thought it would be a good way to understand the challenge and how people are actually doing something about it.
 - Marlow- I would say because I am on the pre-law track I think it will help me gain experience and kind of gain knowledge toward procedure and policy so that can help me with my major.
 - McReynolds- I am really going to bounce off of Colby's answer being on the pre-law track, it just seemed incredibly interesting to me sitting on a board and gaining experience is great from this type of position.
 - Barrett- I actually heard about it whenever I got a parking ticket for the first time my freshman year, I wasn't too happy about it, but it got waived and then I heard that it was a student government position and I am also pre-law so I just thought it was right up my alley and I wanted to return the favor and help bring order to the chaos.
 - o Holliday- Just bouncing off the same answer, a lot of people are fed up with the parking situation as you have heard before, and I think this is a great opportunity not only to be a part of a great organization that would be huge but just help out and do my part in the community.

- O Premo- I chose to be part of this board because I want to eventually be a law enforcement officer when I do graduate. So, something like this was a good way to get my foot in the door and be able to hear other people's stories in their perspectives and just start to see how people think and I just think it would be very good for my career.
- Walker- I heard that there weren't a lot of people on the parking appeals board, and I just thought that I could help out.
- O Keupen- I heard that they needed people on the parking appeals board, and I thought that as my role as COSCO chair dealing with university infrastructure, sort of tied in very well with that not only because I am a poli-sci major interested in law, it would give me experience educating policies and procedures.
- Kathuria- What do you believe are the important qualities that make up a great parking appeals judge?
 - O Glasscock- When we went through the interview process, it wasn't necessarily qualities, but something that we wanted to incorporate was just making sure that people had their own opinion and in order to speak on that opinion we did a bunch of different questions where it is like what would you do in this situation and with all nine of these applicants we saw not only are they able to form a different opinion just because it is the right thing that they want to do, but also just they're able to come to an opinion which is really all we are trying to do with this and all of these people have amazing leadership qualities that we're looking for when we are looking for the parking appeals board.
- Gilson-Bond- What are you going to do for the OU students and not for yourself?
 - OU students for getting the fairest outcome that they could possibly get for those that did pay for a parking pass and those that didn't. So it is just getting the most fair response for all OU students.
 - O Shodunke- During the interview we explained the role of the parking appeals board which is basically looking at tickets and the appeals they make. I basically think that our job is to, maybe people who have a valid reason and deserve the wave, so we can help them not to have a parking ticket on their record.
 - O Marlow-Personally, two things that I believe in especially with OU students being here is empathy and responsibility at the same time. So personally, what I am going to do that will best benefit the students is provide that empathy, so sometimes there are times that you are late to class for a reason so you make a decision to park in a space that you know you might get a ticket. So I think in times like that you are already dealing with a lot of stress you could be dealing with a test so I think that is the best thing that I could bring to the table.

On a motion to extend time for questions by 10 minutes Kathuria seconded by Robinson

o McReynolds- Bouncing off of Colby's answer, I think that each individual parking instance is a unique situation, like you said if you are late to a test it can be stressful, you don't want to miss your test so you might park where you are not supposed to park and me personally being on the pre-law track and being interested in this position I am interested in justice, that's why I want to go into law and I think there is an element of justice in this position. So I think it is important to me to make sure that everyone's case is heard in a fair manner and to make sure to take into account the different details that might be for every individual case.

- O Barrett- What I think is important is to keep fairness in mind and be aware notice patterns. If a bunch of students are getting a ticket at the same parking place, maybe you could look at the sign, see if it's not super clear, if it is not we will need to get that situated, but also everything is a case by case situation if somebody did make an honest mistake, if it was their first ticket, I think it is important to hear them out and be fair to them and just make sure that we are making the right decision for them because a lot of our student are under a lot of stress, especially financially so if we can help a few students that are struggling with that, save \$30-\$40, if it's right and it is fair then that's the thing to do.
- O Holliday- I personally think that when you are looking at the job it is not about yourself at all. A bunch of individual cases are coming in everyday with just parking appeals board and when you are looking at the case, its not thinking about yourself it and what that person believes and what that person thinks and what is right and wrong and I think when you come to this decision it's really not based off of what you're thinking but based off of on what you see in viewing the facts
- O Premo- So I feel like one thing that I bring to the table, that's different from how everyone else thinks, but yes empathy is important I believe that, but I also feel that rules are set in place to be followed and not broken and I also feel that with my unique perspective on this, I will urge OU students to improve their time management skills, for example yes you could be late to a test, but say you slept in. That's obviously your fault so I am going to empathic to people who deserve it, but also there could be repeat offenders and people like that who keep trying to use time as an excuse, which I feel like I will be really good at holding people accountable but also giving empathy to those who need it.
- Walker- The parking appeals board is understaffed, and it is annoying when you are doing an appeal, and it takes a bunch of weeks possibly a couple of months to get a response back. I hope that by adding people on the board will cut the time by a significant number. I know that we can just save the people's time by having more people.
- O Keupen- For me I would say it is pretty clear that I have served the students here through being on SGA, just through the three years I have been at OU and now I am COSCO Chair and something that is pretty clear to me is that although it is a student directed board, we are also there to represent the interests of the parking services, so it is really just about balancing the interests of students and parking and coming up with a logical conclusion that is a compromise for everyone involved.
- Finley- Can you describe the process of a person getting a ticket and then going through the appeals court?
 - O Glasscock- Yeah so what happens is lets say that you are in Dale parking lot and you don't have a parking pass, so you get a ticket so what happens then is once you get that ticket you have the opportunity to appeal it, and so right away that will go to the parking appeals board and what happens is they will look at the ticket and lets say it is your first offense ever they could decide to waive it. If it's your fourth they're probably not going to waive it and so after you get that ticket, it just goes to them and they kind of decide your fate at that point.
- Robinson- How you guys intend to strike a balance between advocating for the University and the student's interests?

O Premo- I feel like in order for me to advocate for OU as a whole, one thing that I want to push is eliminate freshman parking. I know I am a freshman so it would benefit me too, but I feel with the upcoming class and my class of 2028 being the biggest classes OU has ever had. I feel like that takes a lot of parking and I feel like as a freshman you are supposed to be integrated into the community as well join clubs not just be held up in your dorm all the time and I feel like if you have a car you have the ability to just go and do your own thing and not be able to integrate yourself and be a part of OU and then on the contrary of being an advocate for the students, I think a student board is really good because we understand the struggles that students have and being able to hear people out is really important.

On a motion to divide the question for nominee Payton Premo Kathuria seconded by Oler Objection Gilson-Bond seconded by Oler

- Aslam- What is your reasoning for having an even number of judges given that you are adding nine to an already one existing judge?
 - O There are two so it is eleven. It is the chief justice and then him.
- Aslam- Is the Chief Justice's vote given a higher priority? What makes them a chief?
 - o Glasscock- No it is all the same.
 - O Martin- So whenever there is an appeal it goes straight to the staff of the parking people. They create a docket of who gives a statement for an appeal, so we are not looking at every single parking ticket that we have on campus we are just looking at appeals that are submitted. Then the docket is sent to the Chief Justice and the Chief Justice then decides when we have our meetings, and we decide on the case.

- Fisher- Were there any other major parameters that you used when considering the applicants?
 - O Glasscock- First of all, when it comes to the general application that is open to every single person so people who wanted to get involved in parking appeals were people who applied and this general application was pushed out to every single student on campus. When we did the interview process we took a bias training and so there were no biases involved and we pushed this out to every student on campus
 - Wolthuis- We were looking for diversity of opinions and that is absolutely what we got.
- Savage- What would happen if there were an even number of chief justices?
 - O Martin-Typically how it goes is we have a discussion and we have three options. we can void, we can reduce the penalty, or we can keep it how it is. So that is usually how we have discussion we figure out which way is best forward and we usually try to get it down to two options and if comes even then we have discussion again.
- Awoyemi- What would you all find as a viable reason to void a parking ticket?
 - O Barrett- So I think a good reason to waive someone's ticket would be lets say that they had purchased a parking pass, but they just forget to put it up. They have already paid for parking, you've just made a simple mistake or maybe somebody forgot to register their disability parking pass and they get a ticket and fine for that I feel like that is not fair and if someone has a reason like maybe financial obstacles

that they expressed, I will take a look at that as well especially if it is there first or second offence.

- o I would also appeal it if it was their first offense.
- Cantrell- How many applicants did you receive?
 - o Wolthuis- Technically we received 160 applications, unfortunately not all 160 wanted to a part of parking appeals so we went through all the applications
 - O Glasscock- We filtered through all 160 of those applications and then based off of that we had to go and reach out to every single one of these people and then only a few of those people applied and actually did the interview and now we are here so about 160 applicants.
 - Wolthuis- Yes incredibly competitive if you are looking at it like that, but yes these applicants all expressed great interest in being a part and just by them being super communicative and showing up and answering y'all's questions show that they are here, they want to be here for the students.

• CB-112-12 "Disassembling the PAE Act." (Rec of Due Pass) (Gilson-Bond)

- Wilson- Has it just been you reaching out to OU athletics or have you brought your team in?
 - O Vice Chair Houston- The PAE started when I was the Vice chair of SUSTY which I'm old so that was a long time ago and a few months after it was created, athletics completely ghosted us, and we have never been able to get back in contact with them despite people reaching out. So this has been an ongoing thing where we created this with them and then they stopped showing up to the meetings. This is not like a we stopped reaching out it is more of athletics stopped wanting to partner with us.
- Wilson- Not you as Chair or you as a Committee?
 - I am going to be honest with you I did not know that this was a thing until literally last week. It has never been brought up because as Vice Chair Houston said athletics essentially ghosted us. Now the way I want to make campus green athletically wise is working with other avenues so I haven't actually want and talked to athletics per say, but I want to explain why. The reason why is because I want to work with people like Sarah who I think I can get a lot more done with, with other environmentally friendly RSO's. I just don't want to be forced to have a meeting with athletics all the time because that is just one small part of what we are as a campus. I have no problem working with athletics, but having it as a mandatory part in the code annotated is unnecessary.

AS INTRODUCED

An Act of Procedure amending the SGA Undergraduate Student Congress Code Annotated to dissolve the SGA Partnership for Athletic Environmentalism.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION UNDERGRADUATE STUDENT CONGRESS:

- **Section 1**: Title: This act shall be known and may be cited as the "Disassembling the PAE Act."
- Section 2: Purpose: The purpose of this act shall be to modify the Undergraduate Student Congress code annotated to remove the Partnership for Athletic Environmentalism as a committee in the SGA Code annotated.
- **Section 3**: AMENDATORY: The Undergraduate Student Congress Code Annotated Chapter IX-4 will be amended as follows, with strikethrough indicating a removed section, and underline indicating added sections:
 - 1. **Purpose**. The purpose of the Partnership for Athletic Environmentalism is to assist in the communication between OU Athletics Recycling Energy and Sustainability Services and the Student Government Association. The Partnership will meet with the intention of expanding recycling facilities at OU Athletic events.
 - 2. Membership.
 - 1. The Chair of the Partnership shall be the Congress Sustainability Committee Chair
 - 2. Membership for the PAE shall be as follows:
 - 1. The Chair of the Partnership
 - 2. A member of the Congress Sustainability Committee assigned by the Chair of the Partnership
 - 3. The Director of the Interior for the Executive Cabinet
 - 4. The Director of OU's Energy and Sustainability Services or their assigned proxy.
 - 5. The Supervisor of Refuse and Recycling or their assigned proxy.
 - 6. The OU Athletics Director of Event Management or their assigned proxy.
 - 3. Meetings. Meetings of the PAE shall be subject to the Oklahoma Open Meetings Act. The Partnership shall meet at least once per month throughout the academic year. Meeting dates and times shall be decided upon by a consensus of the Partnership's members.
- **Section 4:** This act shall become effective when passed in accordance with the SGA Constitution.
