# Committee Reports-

- O Campus Outreach, Safety, and Concerns: Hello everybody! I hope you're having a great day. My name is Ben Keupen, and I am the Chair of the Campus Outreach, Safety, and Concerns Committee, or COSCO for short. I am a Junior with a major in Political Science and a minor in German. I am from Norman, so I have been a lifelong Sooner. I joined Congress because I wanted to help make a difference on campus and serve my community. COSCO uses the Student Congress' resources to resolve all problems regarding university infrastructure, student experience, and all other student problems that the Student Congress can reasonably respond to. We met officially where we discussed future project ideas, non-traditional student neglect, international student housing concerns, and the turnover vs. open seats problem.
- O Congressional Administration: Hi my name is Noah Coats. I am the Vice Chair of the Congressional Administration Committee. The chair is Maddy Cantrell. What Congressional Administration does, is basically we are the internal affairs members of Congress we deal with the bylaws, code annotated, basically all of the governing documents and we deal with the management of Congress. We conducted interviews this last Saturday, which as mentioned we had over 70 applicants in that. We have filled all but two representative seats.

- O **Human Diversity:** Hello everyone, I am so glad to see so many people here. My name is Aniketh, I am the committee chair of the cool kids club aka Human Diversity. Our committee addresses what is says in the name diversity issues on this campus, we met unofficially Friday and discussed some of the projects we are doing this semester. Including some voter registration drives in corporation with some big student organizations and we can definitely use a lot more members on our committee to really work on these that are really meaningful to impacting real students lives. We are addressing some policy things and

So, as you guys know we had interviews Sunday where we saw over 70 people. A number of you have been selected as either associates or representatives and for the sake of time I am not going to

read off the associates, but I will read off the list of Representatives. So, we have Kristen Mitei, Business District, Himani Prajapati, Business District, Lauren Stubbs, Communication District, Mecca Fisher, Engineering District, Harley Combest, Engineering District, Andy Wang, Finance and Accounting District, Lauren Carter, Fine Arts District, Jael Finley, Humanities District, Nicole Estrada, Life Science District, Bridget Lapp, University College District. I just want to go over our process for interviews. So myself, the Chair, the Vice Chair, and the Secretary, met up around 9 am in the union and we conducted our interviews. We asked the interviewees a couple questions, one being their goals, something about themselves and then we asked them a committee-based question. This is our process for determining how well fit that person is for their position. We ranked them on a score-based system, we added them all to the excel file and we went through the interviews one by one. Later that night we deliberated and decided our votes on who would be in and that's how we decided our new representatives and new associates. I think I can speak for myself as the exec team all of these members are highly qualified for their positions and if you have any questions I yielded 6:12 remaining for questions

- Aslam- Would you accept a friendly amendment correcting the spelling of Daniel Shamsee's last name?
  - o That is a scripter's error.
- **Kathuria** What qualities are you specifically looking for when appointing representatives and associates?
  - We have three main categories that we are looking for. Our first was personality we want someone who can mesh very well with a lot of people. This is a non-partisan organization. We want someone who is passionate about this university and about Oklahoma as a whole. And someone who we believe has that personality that makes good representatives. But, we found that in all of the people we interviewed really great people who had a passion for what we were doing. The second is goals, we wanted someone driven and ambitious. Someone who wanted to make change actively. So we heard a number of issues that people had a personal interest that they wanted to fix and be apart of. So that was a big thing for us was seeing how driven all our applicants were. The third and final was committees how well they meshed with the committees they preferenced on their forms and we saw some people who weren't quite on the right idea, but most were right for the committee that they selected
  - Rhodes- Would you be open to a friendly amendment adding these people as associates, Bri Lemaster, Ria Sachdev, Landon Mowdy, and Jasmine Samuel?
    - Yes
  - O **Duncan** Are you aware that Michael Fisher's name is under both associate and representative?
    - That is a scripter's error.
  - o Gilson-Bond- Before interviews, was there bias training taken?
    - Everyone has had bias training, yes.
  - **Kathuria** What advice do you have for the soon to be newly appointed associates and representatives?
    - The best piece of advice is to put as much as work as you can. It is something that is commonly said, but honestly you get effort back what you put in. So however, much effort you put out in general, not just this body, will be what you get in return. Effort in is effort out, if you have a passion that you are and driven and you want to see change will happen put effort

into it and change will happen, it might not be the change you want, but change will happen and you will be rewarded for your efforts.

- o **Schonfield** Is Bridget Lapp supposed to be listed as university college district?
  - Yes Bridget is supposed to be listed as a University college representative. While we are not going to have university college representatives within the redistricting we still have that seat to fill until next election cycle occurs.
- **Keupen**: Would you accept a friendly amendment to Section 3 adding the name Brocke Graham?
  - Yes
- o Koneru- Were there any candidates who were rejected from being given an associate or representative position?
  - Yes, there were a number of people who applied who that we did not accept, just for the sake of privacy I wont necessarily go into that, but basically they exhibited qualities that we didn't see as representatives or associates. We didn't see a passion or a drive through some of their actions to warrant this decision. This is a lustrous position of sorts and we wanted the highest quality of applicants.

## **Authors Explanation:**

Hello everyone, Ellie will be presenting this bill when it is actually seen before the body in items to be considered, but for right now I was in the interviews as well as Caden our president as well as the Vice President Cyrus. None of them could be here right now because of class, but basically, we are hoping to appoint an election commissioner tonight. I'll let the nominee introduce himself, but some of the things we saw, we all took bias training as well, but something we saw within Baylor's application and interview was just that he was very passionate and there is a lot of great people who applied for this position, but they didn't quite have the experience, most of them were first-year students to the university so they haven't gotten a chance to see an election before. But Baylor is very passionate. He obviously looked into the election commissioner role, and I am going to let him introduce himself. Hey everyone, my name is Baylor Savage, for those of you that don't know me I have had some involvement with the Student Government Association before. I was a co-chair of the Crimson Leadership Association, some of you guys might not know what that is either, but that basically is a first-year introduction to all thing's student government. We served under the Vice President as our advisor in the executive branch of the student government association. I am also a pre-law scholar, I am an econ and accounting major double major, junior through the college. I am in business and also the campus liaison for the Price School of Business. 6:47 remaining for questions

- **Kathuria** Do you have any associations or relationships with any potential student body president candidates?
  - Yes, so I think a blessing and a curse to be involved in student government through my time in CLA also I was part of the CAC (Campus Activities Council) is that you are going to meet people who are aspiring to do positions. So yes, I do have connections with people through this role. I think it is almost inevitable whether it be to president like you said or also through something smaller like representative. I am going to have connections, and it is going to be up to me and the commission to

really be neutral on that and separate our professional relationship from our personal relationship.

- **Kathuria** How do you believe that personal decision or inexperience of has helped prepare you for this role?
  - o With Crimson Leadership Association, something very important is that with freshman students they are very impressionable very early on. So, something I was very passionate about was not talking about my own beliefs, but last year we let both presidential candidates speak, get their platforms. We also took all the candidates for their word and all of our students did the forum as well, and really just that experience of neutrality really has helped me to keep my mouth shut honestly. I keep my views to myself; my views are not exactly the views of the student body. Just separating my job and my position from my personal beliefs and what I think about.
- **Kathuria** How do you plan on making sure no rules are being bypassed such as requiring a second financial report after the election?
  - O Just keeping on top of things really just doing our due diligence, doing our investigations, making sure to start those hitting the ground running with those first meetings I have to host. Making sure that everyone knows what they have to do and making sure they have reminders of things coming up. Really, just keeping up with them and keeping up with it throughout the entire process. I think with letting it go too long or when communication slips that is when those issues start coming.
- Cantrell- Do you have any experience with holding office hours?
  - Yes, as CLA co-chair, I actually had office hours already last year. I do not have an office anymore and I am going to miss that. I do still have the love of the office space. I love the energy in there. I love seeing everyone. Honestly I kind of live in there already now. I don't see office hours being any issue at all.
- **Kathuria** What are the dangers of having an election commissioner that fails to enforce the election rules and fails to make sure the election is fair?
  - O I think that biggest danger is really the confidence of both the candidates and the people selected and in the democratic process. I think it is a two-way street that is why I love the democracy on campus and people being able to elect our own people for these positions. Number one the student body feels involved, they feel strengthened by having a say in what's going and use their voice. On the other side of things, the candidates, you guys all of my representatives here tonight who were elected you have that knowledge of things. People are backing you people chose you for this role. I need to do right by them that is some confidence and some trust. So, when you lose that trust by unfair elections, I think that is really bad for the system.
- **Finley** What exactly does the election commissioner do?
  - o I like to think of the job as election commissioner as kind of facilitating the entire election process. So one of the first things we do is we have some interest meetings, which gather people to say hey you should do this as well as mandatory meetings, like hey you are filing here is what's next, here are the steps, here is what you need to do. Then throughout the process we have a couple of other things you have to do, you have to make sure you get reports done and things like that and also if there are any breaking of rules or alleged rule breaking it is sent to the commissioner and the commission, it is not just one person on campus, we investigate it, give them time to respond and then we make a decision. Different infractions have different points,

that is all in the code annotated which has been opened on my browser for about two weeks now. But yeah after I approve the report I send it to the superior court and they validate the elections.

- Koneru- Have you taken bias training in the past?
  - O After when we were going through the appointment process for the new co-chairs for the CLA, we myself, my co-chair, and vice-president Mortazavi, we all thought it would be ideal for us to go through the entire bias training, so I have done it.

On a motion to extend time for questions by 5 minutes Gilson-Bond seconded Coats, Noah

- Koneru- Have you already selected members for the election commission?
  - o I have not without being appointed and all of that I am unable to look at those applications at the moment.
- **Kathuria** When you are selecting people for the election commission what type of qualities are you looking for?
  - o I am looking for a diverse set of experiences across campus. I am looking for people with different viewpoints. But also, people who just want to do that work to make the best decisions with infractions. Get in there and are passionate about our student government association.
- **Gilson-Bond** Were there anybody else that was in your thoughts of being appointed whenever you were choosing an election commissioner?
  - O Yes, we had about 5 applications. We had one member pull an application because they are a member of Congress, and they wanted to remain in Congress. We also had 4 people we interviewed, those other people while great candidates were all first-year students here and so they have not had the opportunity to see student government elections. But Baylor was a very qualified applicant who has seen elections, and we thought he would be right for the job.
- **Kathuria** Are you aware about the fact that anybody who is interested in running for the Student Body President can start collecting signatures on the 1<sup>st</sup> day of the start of this semester?
  - O Absolutely, so like you said they could already start doing the signatures, however they cannot start actually campaigning or putting themself out there until the day.
- **Beabout** How many people will serve on the election commission and are the rulings on infractions a simple majority?
  - O So, I am actually not sure, I am planning to have a meeting with George if I am appointed to discuss more about the nitty gritty of that kind of stuff. I don't believe there is a set number, it is just about what we feel is the best fit. We don't want to oversaturate it, but we also need to get done what we need to get done in terms of investigations and all of the things that happen during the election.
- **Cantrell** Are you aware that there is a member of Congressional Administration that serves as an ex-officio member of the election commission and because of that the election commissioner must have a relationship with the Congressional Administration Committee?
  - I was not aware of that but thank you. I feel like I have a fairly good relationship with student government, so I feel like I do have a good relationship with the ConAd chair and the ConAd vice chair as well.
- **Combest** What exactly do you believe differentiates you from somebody else for this position?

O I think something that has happened in the past is that the position has been given to someone who hasn't had super strong relationships or experience with SGA before. At least my understanding of it was people just haven't had that connection, I think that I do, and I do have that passion already. I will do everything in my power to make sure that everything goes well. And something else about me is that I live on my email. So, I will always be responding timely.

On a motion to extend time for questions by 5 minutes Kathuria seconded by Coats, Noah

- **Kathuria** What are you hoping to get out of the experience of hopefully being the next election commissioner?
  - O So, there are a couple different parts on that. On the personal development side of that I am a pre-law student as I said, so on the side of reading and interpreting, I really, I think the code annotated is a great way to do that. While also staying in contact with the student government side, which I have grown to love already, so just hitting those marks at the same time. On the other hand, something I really want to do is leave a legacy of people coming out of elections even if they didn't win, not feeling bad about the election process. Feel like they have the opportunity to run again and not feel that there is something against them outside of their control.
- **Kathuria** What type of law do you want to practice?
  - Obviously, something that has crossed my mind is corporate law. However, I have several family members who have worked in the medical field, so I am really looking into medical malpractice law and stuff like that as well.

- Gilson-Bond- Can you explain the different sections?
  - O Program, events and activities are things like food for general body meetings, decorations for events that you have, those sorts of things. Captial investments are things that are going to stay in the organization for years to come, office and general expenses is stuff like pens and marketing materials.
- Gilson-Bond- Did you see the last time the OU Men's Lacrosse club purchased nets?
  - O Yes, we looked though their request history, and they hadn't gotten funding for that in the past.
- **Kathuria** Could you explain how student organizations can get a request for funding and how the Ways and Means committee determines how much money will be allocated to each organization?

- When it comes to auxiliary funding and primary funding, RSO's can apply for their funds from SGA through Engage. There is a link I can send out that will walk you through the entire process if you want that. I will send it through GroupMe after this. A big factor is fiscal history, whenever an RSO asks for money from us, we are able to see how much money we have given in the past and how much that they spent. The money we are giving out comes from the student activity fee which is a fee that every student at OU pays. We want to make sure that these funds are actually being used by the RSO's and making sure that they are being used in a way that affects the communities here at OU and allows the students here to experience more things. So, we want to prioritize giving funds to the orgs that actually spend the money, so we look for a good fiscal history which is when we give RSO's fund they spend a vast majority of their funds. One of the bigger factors is how long they have been on campus, what they are actually doing, and how big are the events, how many people are going and things of that nature.
- **Hallum** What does an organization do with excess funding if they don't spend all of their cash?
  - o If an RSO gets more funds than they are able to spend that funding goes away at the end of the year May 2<sup>nd.</sup> If any funds that are received by an RSO don't get spent by them then they will be considered a reversion which means it goes into auxiliary funding for the following year.
- **Koneru-** Does auxiliary funding happen twice a year, once in the fall semester and once in the spring?
  - O Generally, yes, that has been the case in the past to be clear about the way that the process works. Primary funding opens in the Spring the WAM committee will review the requests we receive near the end of the year and then RSO's will know how much money they got in primary funding before the year ends. Essentially primary funding is meant to be all of the money your RSO will need the following year. Auxiliary funding is essentially just emergency funds that are happenstance, that is not supposed to be there per say and this year we actually have less money to give out than usual so there is a strong chance we won't be able to open up auxiliary funding in the Spring this year.
- **Gilson-Bond** Is one of the considerations the number of members that are actually registered on Engage?
  - O Yes and no. Engage is not something that most of our orgs are good about making sure that all of their members are registered on there, so there are a lot of orgs that we know who have over 400 members who come to events but only have 20 people on the engage page. - Combest- What exactly should people ask for with funding?

It is something that is cheap, goes to a lot of students, a lot of people benefit from it, so the committee is generally more likely to fund that over things like travel which benefits a very select group of students and is very expensive.

- Gilson-Bond- What is the Student Bar association requesting \$9000 for?
- I will say that they usually request and receive \$15,000 and everything that she requested was very reasonable. They are requesting funding for are the OULAW party and food non-

- alcoholic beverages, OULAW party events spaces/venue rentals, and LAW week, it was \$3000, for the first, \$5000 for the second, and \$1000 for the last event.
- Koneru- How does primary funding and auxiliary funding work for the application process?
  - O You are not eligible for primary funding unless you have been registered for a full year. But, you are able to receive auxiliary funding a week after you are registered, which the normal range that an organization could expect to receive is something between 700-900\$ depending on what they are asking for.
- **Gilson-Bond-** With the Bar Assocation do they have documentation to show how many people have been going to their events in the past because on Engage they have nine members?
  - O There is no way for us to know for a fact, but based on Maddy's character that she wouldn't lie terribly. The \$5000 request that she had there are usually 200-250 people who go to those events and law week is roughly \$200 a day for them to run that event.
- Cantrell- Is the Student Bar Association tied to the College of Law?
  - o Yes, they are considered the College of Law branch of SGA.
