• CB-CXII-02 "September 2024 Superior Court Act." (CONAD, Rec of no Rec) (Wolthuis/Glasscock/ Mortazavi/ Grace)

## **Author's Explanation:**

Sorry, everyone for the almost delay I was running from my night class. I am very excited to present our nominee for the final vacancy in the Superior Court today. Ms. Ella Dreese is a pre-law scholar, she is extremely qualified as you will see here in a second, but for full transparency we interviewed candidates last spring for Superior Court and Ella was our first alternate. We were originally going to appoint someone else who was already a law student because as you know the Superior Court tries to find either law students or pre-law students, it is not required, but it is a nice thing to do. We found someone in law school, unfortunately she was not very communicative, so we were not able to go through with her appointment. Ella, while she is an undergraduate student, is a pre-law scholar, very qualified, so we asked if she would be interested in being appointed this fall, she jumped on it within 30 seconds and said absolutely, yes please and I will let Ella introduce herself. Hi guys my name is Ella Dresse, I am a junior. I am an entrepreneurship pre-law student I am on the pre-law track. I am also a pre-law scholar in the honors college, which essentially what that means is I do have early admission into OU Law school, and I am really hoping to continue on that and going to OU Law School starting my senior year. I am very excited to have the opportunity to possibly serve on the Superior Court and continue my love and passion for law. 6:28 remaining for questions

- Kathuria- What do you think it would mean to you personally if you were nominated to the Superior Court?
  - O Ultimately, I think the goal of the Superior Court is to uphold the excellence of the University while also making sure that the students are protected within the Constitution and the Code Annotated as outlined by SGA. I think that being a part of the Superior Court would not only give me the ability to work with others around me to learn how to best suit the student body, but also to uphold to excellence of the University itself in making sure that things are going as they should be and everything is in line in comparison to the Constitution.
- Kathuria- If you were to be confirmed, do you plan on staying publicly neutral about the upcoming election and the potential candidates who might be running for Congress or President?
  - Yes, I do. I understand as part of the superior court it is incredibly important to stay unbiased and impartial in all elections and also in the issues that are brought up. I do know that within the Code Annotated it does say that we are required as justices to recuse our stance on something, if we do think that it is impossible to become impartial. However, I do know that it is something incredibly important and I fully look to stand on that throughout my time serving as a Superior Court justice.
- Kathuria- Can you define what you mean by being very strict in terms of interpretating the Constitution and the Code Annotated?

- O I think that the reason that we have the SGA Constitution and the SGA Code Annotated is that we can follow the guidelines that we have put out for the students here at the University. I do think that those are there for a reason and that they should be followed strictly because they are here to give us those guidelines to make sure that we are protecting the rights of the students here at OU and also make sure that they are given the ability to act freely as students here. I think ultimately with upholding those as strict; they are ever-changing documents as we continue to look forward into the upcoming future here at OU. However, I think that they are guidelines for us to strictly abide by and as the student rapport that is what you are supposed to be doing, abiding by those guidelines making sure that you are being held liable in comparison to those guidelines.
- Kathuria- How do you plan on making sure that you are not allowing other justices to influence how you might rule on a certain case?
  - o I think ultimately something that I am incredibly excited about is to get to be a part of is learning from the people around me. I think that being part of an organization with so many different viewpoints and different individuals is incredibly important. I think learning from people in those places is incredibly important. I am actually a tour guide here at the University as well as in Crimson club, so I have the opportunity to surround myself with individuals with very different viewpoints then I do and from very different places on campus and people that don't necessarily think the same way that I do and I have been able to hold my own opinions on things while also having healthy conversations with the individuals around me and continue to be a good representative of the University itself and the excellence of it.
- Kathuria- How do you plan on ensuring that you are being fully transparent with all bodies of the Student Government Association?
  - I think that transparency in itself is incredibly important especially when dealing with something as a strict interpretation of the SGA Constitution and Code Annotated. I think that with that transparency is where you get the trust and the upholding of integrity within the student body so that is something that I think through communication not only within the Superior Court, but within the other branches of SGA as well is incredibly important and will continue to be upheld, whether that be communication with everyone about what's going on and different activities. Just making sure that the communication channel always stays consistently open because that is how we are able to uphold the integrity of the university itself.
- Kathuria- Do you have any prior experiences with the legal system or the judiciary system and could you describe those experiences?
  - Oklahoma. Specifically, the Mcgurty v Oklahoma Supreme Court Ruiling, that is something that I did post an abstract and submitted for application for an editorial. So, I have had some examples and some ability to be involved in the State itself. I also am a pre-law scholar; with that we do have different organizational meetings where we get together and talk about things that are going on, especially in the law sector. I also am looking forward to taking an LSAT again, I just recently took one, so I do have examples to exposure to the law side of things and I hope to continue that as I go forward in my educational experience.

- Kathuria- What sector of law are you interested in practicing after your graduate from law school?
  - o I am really interested in practicing family law. I was adopted and so was my brother and I am really interested in child advocacy, and I really want to help give a voice to children that don't necessarily have one, especially in difficult family situations.
- Gilson-Bond- During this round was there anyone else that you looked at or was the first option Ella?
  - O As I mentioned, these interviews were actually held last spring. So the superior court justices that are now serving on the court that y'all appointed those are obviously from that same interview pool. I believe that there were two others that did not make the cut, we would not have even put them as alternates. We all agreed Ella should any of the nominees fall through, Ella was most definitely going to be the person that we look towards and if Ella rejected that offering of the position, then we were going to have to reopen the GenApp for it. We promise that it was not a last-minute scramble, Ella was our alternate should anything go wrong, something did go wrong luckily Ella agreed to the position
