Officer Reports -

- **Chair's Report:** Hi everyone, thank you all for joining us on Zoom. I know it's not the most ideal situation, but I really appreciate all of you guys being here. I am going to try to make this as efficient as possible. When you guys make motions or have a question, please use the hand sharing emoji so you just pop up to the top of the zoom and so that there's really not confusion with voices. Election filing is open now. It closes on Friday at 5pm so if you or somebody you know, wants to run for representative seat, now is the time. As a reminder, if you are appointed to a seat in the fall, your seat will expire at the end of this election. So if you would like to remain a representative, you do have to rerun for the spring seat in hopes to get a seat.
- Vice Chair's Report: Good evening, y'all! I put this presentation together for you because, well... I might have a bit of a Canva addiction right now. But don't worry, it's got some useful information to help clarify a few things! First things first, I have a QR code for my feedback form. Since I don't send out many emails, this is an easy way to reach me. Just take a picture of it, and you'll have access whenever you need it. The form doesn't track your information, no emails, no names, so you can actually submit feedback multiple times. This is great because maybe one interaction with me meets your expectations, but another time I fall way below what you expect from a Vice Chair. So please, help me help you! Next up is the Constituent Service Point QR code. This links to the same form that Hope sent in the

GroupMe. If you already submitted an opportunity through that, no need to resubmit the same one! I've gotten quite a few questions about what a CSP is and what counts, so let me clarify. A CSP is any activity, event, meeting, or training where you engage with the OU community. Every member is required to earn at least one CSP point per month while Student Congress holds general meetings. If you don't submit one, you'll get an unexcused absence for that month. A quick note, General Body or committee meetings don't count if you're a part of that committee. Now, to boost engagement, here's something new: After you submit your first CSP for an organization you're NOT a part of, you can continue submitting points for organizations you ARE a part of to help increase committee engagement on campus! I know this can be a bit confusing since it's a newer process, so if you have any questions, just let me know! But without further ado... let's see which committee is leading in engagement! So Virtual drum roll, please! The Ways and Means Committee! We still have plenty of time left in the month, and there are lots of opportunities around campus, so it's still anyone's game! That's all I've got for you. Thank you!

• Secretary's Report: Hi everyone, I hope you are all staying warm! Just wanted to let everyone know that I have new candy in my office, but I am not going to tell you guys what it is because you will have to come to my office hours to find out...

Committee Reports-

- Campus Outreach, Safety, and Concerns: Hey everyone! COSCO met officially this Sunday. We had a great meeting with a guest speaker, and we also saw some legislation. Speaking of which, we gave CB-113-12 a recommendation of due pass. I also wanted to remind everyone that COSCO's light walk will be held this upcoming Sunday on February 23rd at 7:30PM. I will be sending out a reminder and posting the sign-up sheet in the GroupMe.
- **Congressional Administration:** ConAd met unofficially this weekend, so not much to report on except that we were able to go over projects and assign people projects who needed projects. Lastly, I would like to announce that Nicole Estrada is our new Vice Chair of ConAd!
- **External Affairs:** Hi everyone EA, met officially this past Sunday. We did see a piece of legislation, the Goddard survey Act, which we'll see later tonight. We gave that a recommendation of due pass. We talked a little bit about our unhoused project in Norman. We had a conversation about some contacts that we talked to in Norman about the project, which was really exciting, so we got kind of a little bit of development on that. Then we also discussed our spring Q and A forum, which we want to invite people out to center around having a discussion around the minimum wage in Oklahoma. This is still pretty early in its planning, but right now we're thinking of planning that out for early April. Then we also talked about the Higher Education Day rescheduling and what our plans would be for that which I can go into further detail, probably at a later meeting. And then we also just discussed continuing our bar safety project around campus corner.
- **Human Diversity:** HD officially met on Zoom for Sunday's meeting, and we passed the Black History Month resolution which we will be seeing in Congress. Other than that, we've just been following up on projects Language requirements, DEI policies, Involvement Festival, etc and welcomed back some older members of the committee.
- Sustainability: Hello everyone. SUSTY met unofficially on Sunday. We discussed
 implementing our new project tracking system, our vice chair vacancy, and the upcoming
 trash walk this upcoming Sunday on February 23rd at 2:30pm which will take place around
 the residence halls. We will meet at the parking lot of Sarkeys Fit & Rec. We also had Chair
 of COSCO, Syed, join us to present about his ideas for a recently submitted student concern

regarding updating our parking passes to be more informative and less wasteful. So, a few members of SUSTY will be working with him on that.

- **University Policy:** Hello, all! UPOL met officially this weekend and discussed a new project idea relating to the procurement of new resources for students to use primarily digital resources such as newspaper subscriptions and access to digital journals for research. Our other projects are going as anticipated for the most part some are now awaiting emails while we have one waiting on an open records request. We will hopefully be seeing legislation this weekend to put out a survey to collect information on student wages. Also, our Vice Chair application is currently open and will close on Thursday at 5:00 p.m.
- **Ways and Means:** Hey everyone! This week WAM met officially and made some progress on our Video Project, our updates to the Finance section of the Code Annotated, and ran some of our new members through what Primary Funding will look like. We also had two workshops over the past two weeks. • CB-113-11 "OU Goddard Health Care Feedback Survey Act of 2025." (Carter) (Rec of Due Pass)

Authors Explanation:

So this bill just is establishing the ability for a survey over Goddard to go in the OUMM. The survey goes over, it's hard to see in the bill admittedly, but structure wise, you have page one, which goes over just the format and everything of the bill and all that. Page two goes over just basic demographics, no name because it is anonymous, but if they're a student, if they're a faculty member, what kind of faculty member, etc. And then part three, they can click which services they've used, and then it'll, based on that, give them questions to answer. • CB-113-12 "Bizzell Memorial Library Hours Survey Act of 2025." (Fontanilla) (Rec of Due Pass)

Authors Explanation:

This was just our suggestion as a committee to survey the OU undergrad and just general student populace to see what proportion of students would want the 24 hours during finals week to either be extended to dead week or replacing dead week with finals week, because we felt that more students utilize the library more during dead week, especially if they only have early finals or project based finals that happen on, say, Monday and Tuesday, because then the Wednesday, Thursday, Friday, 24 hours during finals week turns out to be relatively useless for them. We also put in a question on this to see how many students would like extended hours, just in case the library says that we absolutely can't do any 24 hours on both weeks, although we have done some research and realized that they did do it in the past, right before COVID. So we're just seeing how many students want this 24 hours during dead week, in order to use that sort of survey as leverage for negotiations with any of the library staff to see if we can bring it back

- **Kathuria** Why do you think this survey is important to assess the academic needs of OU students?
 - Before talking to any of the library staff or those in charge of making the decisions for hours, we want to be able to show them proof that we did some research on this.

This isn't just us speaking on behalf of COSCO or SGA, it's us speaking on behalf of most of the OU population. And if this survey turns out to show that most students are okay as is, then we know not to bring that up to the staff, because we do realize that it is a hassle on their part because of staffing issues. So, we could realize how pressing the need is for students, and if it is a pressing need, we could be able to demonstrate that to the staff in charge of those hours.

- Kathuria- How do you plan on promoting the survey to the entirety of the student body?
 - The main way would likely be email but we could probably also put up flyers, put it in any newsletter we have, or just generally how else we promote surveys on campus. But I feel like this survey may be more answered than some of the longer surveys, because this is only five questions, which doesn't take a lot of time to answer, and it's something that I know personally a lot of students have complained about and might want to see change.

CONGRESSIONAL BILL CB-113-11

AS INTRODUCED

A Congressional Act authorizing a survey of the student body on behalf of the Undergraduate Student Congress; providing for specific questions; and providing for distribution.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION UNDERGRADUATE STUDENT CONGRESS:

- Section 1: Title: This act shall be known and may be cited as the, "OU Goddard Health Care Feedback Survey Act of 2025."
- **Section 2:** Purpose: The purpose of this act shall be to establish a survey under the Student Government Association.

The SGA Undergraduate Student Congress shall survey undergraduate and graduate students, as well as all staff and faculty affiliated with OU, to better understand how effectively Goddard's healthcare services support those who utilize it's services. The goal of this survey is to better understand how SGA can support and improve Goddard for OU's faculty and student body.

CONGRESSIONAL RESOLUTION CR-113-02 SENATE RESOLUTION GSXX-XX/GFXX-XX

AS INTRODUCED

A Congressional Resolution Recognizing the month of February as Black History Month; and providing for distribution.

Whereas:	Black History month is celebrated in the month of February; and
Whereas:	Black History Month was federally established through Congress in 1986 in Public Law1; and
Whereas:	The month of February was chosen to honor the birthdays of Fredrick Douglas and Abraham Lincoln ² ; and
Whereas:	Black History Month is also used to educate the American public on the challenges of Black/African American/ Members of the African Diaspora people have faced throughout history and today; and
Whereas:	Black History month is used to promote the identity culture, and the contributions of Black/African American/members of the African diaspora people have faced throughout history and today; and
Whereas:	In the Fall of 2024 1,692 students or 5.5% of The University of Oklahoma's student body who was enrolled identified as Black and African American students ³ ; and

Whereas:	The University of Oklahoma also promotes Inclusion, meaning that, "all have a sense of belonging in our environment of cultivated respect and care"; and
Whereas:	Celebrating Black/African American/Members of the African Diaspora students and their history recognize the contributions these students have given to The University of Oklahoma and ensuring they are not overlooked; and
Whereas:	The recognition of Black History Month brings awareness and discussion on the history of Black/African-American/Members of the African Diaspora Americans, not only at The University of Oklahoma, but also across the nation; and
Whereas:	Accurate stories and discussion of Black history and cultures help to reduce stigma, giving the opportunity for more inclusive environments; and
Whereas:	Recognizing Black History Month also gives way to recognizing the Black/African- American/Members of the African Diaspora faculty and staff that serve as role models for the community at The University of Oklahoma; therefore

BE IT RESOLVED BY THE UNIVERSITY OF OKLAHOMA UNDERGRADUATE STUDENT CONGRESS THAT:

Section 1:	Title: This resolution shall be known and may be cited as the "Black History Month Resolution of 2025"

CONGRESSIONAL BILL CB-113-12

AS INTRODUCED

A Congressional Act authorizing a survey of the student body on behalf of the Undergraduate Student Congress; providing for specific questions; and providing for distribution.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION UNDERGRADUATE STUDENT CONGRESS:

- Section 1: Title: This act shall be known and may be cited as the "Bizzell Memorial Library Hours Survey Act of 2025."
- Section 2: Purpose: The purpose of this act shall be to establish a survey on behalf of the Student Government Association. The SGA Undergraduate Congress shall survey undergraduate students to discover the attitudes of students towards the current hours of the Bizzell Memorial Library during dead week and finals week, as well as their receptiveness to proposed changes to these hours.

Section 3: The following questions shall be administered via Qualtrics.
