Items to Be Considered

CB-105-29 Congressional Member List Oversight Act of 2021 (Tucker) (ConAd, Do Pass)

Representative Broadbent seconded by Representative Halsey Kraus

Tucker: I wrote this bill because the Secretary needs to provide more oversight and record keeping. It is currently a Google sheets and once a membership changes for someone I update it, this just makes a better process. The report will be verified by the Executive Committee by the end of every month.

Taylor: Accept FA co-sponsor?

Tucker: Yes.

Halsey Kraus: Accept FA co-sponsor?

Tucker: Yes.

Hale: Accept FA co-sponsor?

Tucker: Yes.

Broadbent: How often does the Secretary update this anyway?

Tucker: The list is updated when there is a change in membership, there is not a set date. This bill would create a date and would make the report reviewed by the Executive Committee.

CB-105-30 Constituent Recommended Initiative & Student Petition Act of 2021 (South) (ConAd, Do Pass)

Representative Broadbent seconded by Representative May

South: Pet project of mine for student petitions. Very few students use the right to petition. I believe this is because current guidelines are inaccessible and most petitions are more informal, like change.org. I want to increase student involvement in the democratic process. First, legislation moves guidelines from title 1.3 to title 7 and refers constitutional amendments to title 7. Reconciles those two areas of the code so you can read straight through it. Makes director of interior responsible for the creation of a guide on how to submit petitions. Talked to Angelora about what that would look like. This is to increase accessibility so people don't have to decipher legalese.

President, on 500 signatures, would have to make a statement about the issue, mirroring the Obama Administration's program. I believe it will allow students to hold leadership accountable. Bill allows petitioners to submit general petitions, rather than turning it to some kind of law. Turns it electronic as well. Makes it more secure and limits it to OU students so members of the SGA only participate.

Broadbent: What issues facing the student body did you see inspiring you to write this bill?

South: Pass/no pass. Massive petition with several hundred signatures requesting pass/no pass and led us to work on negotiations there. But it was change.org petition, so it was unverified and made it worrisome for validity as a tool of democracy. I want to institute this so we have a verified

petitioning platform to say we've certified everyone is a constituent and are in support of the issue, so we have solid data.

AB-105-07 Auxiliary Allocation 14 Act of 2021 (Patton) (WAM, Do Pass)

Representative Broadbent seconded by Representative Lynskey

Patton: Aux 14, last aux, closed apps on March 30th and these were the only 2 orgs.

Representative Broadbent seconded by Representative May

AB-105-05 Primary Funding Act of 2021 for Registered Student Organizations (Patton) (WAM, Do Pass)

Representative Broadbent seconded by Representative Carmona Casado

Patton: This is for RSOs. These are all the student organizations. Look at fiscal, quality of budget, how well it goes to mission of org, scope of org. Seen by my committee over two separate weekends. It was given full approval by my committee. There are budget constraints. I'm looking for actionable plans to make sure we receive a higher percentage of Student Activity Fee. Our budget is too high for the number of orgs. We don't have as much money as we'd like for organizations right now.

Sertovic: Can you explain why the United World got the amount they did?

Patton: United World got 1500. They had bad fiscal in the past, so this is a decrease from when they were having bad fiscal. Some goes to cultural night, some goes to food. Decrease from them having 2 years of bad fiscal, number we thought was more manageable.

Broadbent: How many people are in each of the multicultural orgs that got defunded? Which multicultural organizations got less funding?

Patton: AASA 6500 this year.

Extend time for questions by 10 minutes

Representative Broadbent seconded by Representative Poupore

Patton: BSA technically gets a decrease from 2 years ago, capped them at 30k for primary, rest in aux to begin with. Specific orgs that would help.

Broadbent: Last fiscal year including aux funding for AASA, AISA, BSA, HASA, and IAC?

Patton: 19-20 full fiscal, 20-21 number we don't have finished number. AASA 19-20 6750, 20-21 9850, this year 6500. AISA, 19-20 9000, 20-21 11849, this year 11500. BSA 19-20 28372, 20-21 30,000, suggested 30k again. Columbian Student Association 19-20 7750, 20-21 9k, 9k again suggested. HASA 19-20 7100, 20-21 9k, suggested 9k again. International Advisory Committee 19-20 26142.15, 20-21 30,195.75, suggested 27500.

South: Iranian Student Association?

Patton: Iranian 19-20 11785, 12k, suggested 14500.

Flaggert: 4 multicultural orgs receiving proportional decreases. Budget how they've done fiscal in the past. How have they all done on fiscal?

Patton: None large decreases. IAC largest, 2000 decrease. AASA spent 100 of 4k, 80 of 7400, 100 of 6764, last spring legislation meaning we couldn't count negative fiscal, only positive. Said medium good continuation. AASA medium. 9850 aux this year, unaware of number spent. BSA 100 of 10k, 100 of 2613, 88 of 30925, 100 of 28372 for covid year. Colombian, 90 of 4600, 40 of 6800, 90 of, 100 of covid year. HASA, 96 of 6150, 100 of 6100, 79 of, fiscal covid not applicable, got 9k wanted to keep them at 9k to see if they could spend it well.

Abdi: Rugby Club, only team won Red River Conference twice. We've been world champions. Funding decreased because of COVID. Applied for funding, transportation, other things. We do important things for the school and the gap won't cover it.

Patton: Rugby has good fiscal, but we can't reconsider, we funded all of food and rugby balls. We don't fund personal items like jerseys and practice gear, they're clothing we don't fund.

Abdi: The jerseys don't belong to the members, we return them afterwards. We don't keep them except for the polos.

Patton: That wasn't clear on the application, quality of budget. That might be resolved during aux applications. We were unaware and sounded as if it was for individual purposes. Please apply, and if you complete your budget explaining they're not for personal use, we can work with that.

**Extend time by 10 minutes and then extend to the end of the list and close the list
Representative Poupore seconded Representative Sertovic**

Liu: Earlier in the last bill, CAC 4 percent decrease was unfair, so why is it fair for AASA to get a 4k or 34 percent decrease?

Patton: First, I clarified when you asked the question, 4 percent wasn't what was unfair. AASA not getting decrease of 4k, I gave 3 numbers. We don't have finished fiscal for this year since we receive reimbursements through May. Can't take any numbers there as concrete. We have fiscal for other years. AASA received 6750, decrease of \$250. I wish we could give you that much money again. 10k is what AASA deserves, they should supplement through aux. We want them to get that money. I will be advocating that we get more of the Student Activity Fee. I don't like that we can't give more money.

Liu: Why has AASA always received less money?

Patton: Some other multicultural orgs have good fiscal and get bigger increase. BSA, we took them up multiple thousand dollars. Consistent fiscal that was good. WAM made that decision this spring for AASA, gave them 10k in aux. Giving 10k is not the same as knowing you spent 10k. We're going to increase AASA to the same height as well as other multicultural orgs.

Juarez: HASA funding. Curious about the number we were given this year. Student population not taken into account. Latino population has increased. 15-20, Hispanic population went up. This number doesn't take into account the scope we have on campus.

Patton: It's lower than 2 years ago. Increased, spent 79 percent. COVID year not counted against you. Want to increase, but 9k is more than you spent a couple years ago, but in line with your good fiscal. We want to see if you spend it before further increases.

South: Is org size taken into account?

Patton: It is. Number put into application not sometimes representative of student population. Scope is a factor which is why we didn't decrease with 79 percent. We haven't seen them spend 9k for two years now. We keep them there and see if they spend it before an increase.

Yanez: Confused as to why certain multicultural orgs have increased faster than AASA since numbers of RSOs is taken into account and they're one of the largest on campus.

Patton: That is taken into account. We don't have fiscal for the COVID year, it's a lapse. Can't speak for why they haven't received more money, maybe they didn't ask for as much money. We want to give them more money, we can't put that in primary right now. As far as the past, I don't know. Oversight we saw and tried to reconcile this year.

Hillis: Before appt apps are read by ConAd, implicit bias training. Did you take implicit bias?

Patton: I do take them every year. I encourage my members to do so. We discuss it during orientation, not a requirement as of now.

Broadbent: How will the budgetary constraints negatively affect your organization next year?

Liu: Our org has increased through the past couple years. Trying to do more Asian American activism on campus with the rise in anti-Asian hate crimes. With funding decrease, we can't do a lot of our events. If we get the same money but more people, we can't put on as many events. We won't be as recognized as much as other multicultural organizations.

Juarez: OU's Hispanic population has risen in the past couple years. We've lost a lot of events. Our funding may not take into account the actual population, this is a community growing. It's necessary to have more funding to accommodate our population to make a safe space at the university.

Taylor: What percent of SAF do we get currently?

South: SAF gets about 4.5 million. Allocations for upcoming year, a lot goes to university programs and services, student affairs, counseling services at Goddard, staffing pay for GEC. SGA discretionary funding was a bit over 700k, same amount as last year. No other funding we can allocate to specific orgs. Orgs can do their own fundraising, not something we can absorb and reallocate.

Broadbent: President of AISA, will you elaborate on how budget constraints will affect AISA negatively?

Burrow: We had to cancel several events due to COVID, but we have a pow-wow every year, and budget constraints might affect where we can hold it and how many people can come.

South: Chair Patton, any input?

Patton: Budget constraints, but AISA got an increase from fiscal we have.

Liu: Anyone in your committee identify with any of the multicultural communities on campus?

Patton: Not aware if they are members of organizations or communities, but we talk about issues in general discussion.

Lange: Are the orgs that have received decreases still going to be able to fund programs through auxiliary budgets, or not?

Patton: Yes. Every organization can do aux. AASA has received entirety of budget this year through aux since they didn't fill things out last year. More open money in aux than primary. I have all the money in aux, but limited in primary.

Alfaro Sandi: Some orgs judged for deficit they have or money they didn't use. Basing judgement on how they're using resources is a good judgement. It makes me think that it's not a good idea keeping in mind that orgs use other resources as they wish.

Patton: Fiscal is important is a good point. We regard how they spend money the same as fiscal. All of it is money spent, as long as it's allowable and approved, it contributes. We don't look at the merit of the org, just if they're doing what they're setting out to do. Fiscal is important because if we give an org 5k and they only spend 2k, that could go to other organizations. When we're fiscally confined, we want to give the money to people we know will spend it.

Morse: AASA, could you please tell Congress how much they spent 20-21?

Patton: It's not concrete. We don't look at this year's fiscal because they have until May to spend their money. They received 9800 roughly this year, and as of now, they've spent 1000 of that. We don't look at fiscal because they could spend all of that 8000 next week. A lot of orgs have end of the year spring events.

Liu: Earlier, we talked about how asking other orgs to apply for aux is unfair, but why do multicultural orgs have to apply every year?

Patton: I don't think it's unfair. Continuing to decrease CAC is unfair because they've unfairly received decreases in the past due to their fiscal. Every org has to apply for aux if they want more money, unfairness with CAC was substantial decrease.

Debate

Representative Broadbent

Recess for 12 minutes for the purpose of caucusing
Representative May seconded by Representative Broadbent

Morse: I feel that a lot of the conversation has been about decreases, most of the organizations talked about tonight have either received identical money to primary last year or nominal decreases. If these orgs apply aux next year, they'll receive 500 as a default. Most will likely get substantial increases after that. They're getting less because due to COVID we haven't been able to judge how these orgs are spending their money. Most are not receiving cuts and will next year receive increases most likely. I encourage a yes vote.

Yanez: I want to stress that there has been stagnancy and slight decreases. Stagnancy is the issue. Some orgs have increased by thousands of dollars, but others like AASA have remained stagnant. AASA is one of the largest on campus. Population of the RSO is important in determining funds. 34 percent decrease in funding is ridiculous. Aspects of funding need to change and we need to change them now. It's obvious something isn't working.

Papahronis: Raising points. First, we want everyone to receive money. It comes down to budget. Biggest issue right now is if we give people more money, we'd have to take money from somewhere else. A cut of 300 seems like a lot, but a new org might have 300 be all of their budget. There's a limited constraint of money. We use numerical data. We don't come up with these numbers on a whim. We look at the percentages and say if they haven't spent all their budget, they'll receive the same or lower. It's a formula. Third, there are numerous opportunities for more funds like aux funding. This isn't the last funding. Through aux we can be more generous, less restraints.

Broadbent: I speak in opposition. As a rep, it's my job to vote in the interest of those I represent. SGA promises to uplift multicultural communities. That includes monetarily. You've been told tonight it's due to budget constraints. We've increased our own budget this year. I can't justify for myself or my constituents valuing governmental interests over theirs. It's about time we start putting our money where our mouth is. I've sat through countless meetings talking about SGA's goals to support AASA, AISA, BSA, and HASA. This tonight is our chance to prove to them that those words have not been hollow. I will always vote for my constituents by voting no tonight. The organizations are prepared to release a statement on this this week as well.

Shaffer: I want to remind everyone that WAM is not always able to give orgs all the money they ask for. Orgs can get money in aux. Decrease in AASA is only 250 dollars. I urge everyone to vote yes.

Chenevey: I'm an Asian American. I feel like sitting through this meeting, Chair Patton has said she wishes she could fund all the orgs she can but the budget is an issue now. She said you can apply for aux. To call into question her committee's nationality and ethnic makeup is really disingenuous and only creates more division in this body.

Bryant: It's my duty to stand up for my constituents. Multiple people reached out to me about this. We as a body it's important to do better by them. We owe it to them to prove we can be better.

Patton: I urge you to vote yes. I understand there's been stagnancy. I don't want that. But it's not a matter of if we don't want to give the money, it's because we don't have the money to give.

Aruguing about CAC needing a decrease is biased. Trying to remain unbiased, CAC has a larger scope and better fiscal. It's not that I don't want to get the other orgs more money. Arguing for certain orgs to increase more money, that insinuates that other orgs deserve less money. Aux is first come, first serve. Important for these orgs to apply for aux. There's no thought that if we fund an org for aux, then another one might not get the money like primary. We know these orgs deserve money. I'm going to look into how we can receive more of SAF. I don't think that certain things funded by SAF should be, but that's a separate issue. It was the best we could do to keep them

stagnant. The decreases are a matter of 200 because we had to fit into a certain amount of money. I urge you to vote yes on this legislation.

AB-105-06 Primary Funding Act of 2021 for Governmental Organizations (Patton) (WAM, Do Pass)

Representative Lynskey seconded by Representative Morse

Patton: This is primary for government organizations, falls under SGA branch. We fund them separately for internal proceedings. Any questions, please ask. Reminder that we look at fiscal, scope, uniqueness, and quality of budget and quality of what they're asking for if it goes to mission of the organization.

Broadbent: Can you explain why we had more money this year than last year? CAC increase?

Patton: More money overall, about the same last year, asked and received for the same amount. Last year CAC had a decrease, but we wanted to return them more to what we were seeing all along. Closer to amount they should be getting.

South: GSS received more funding for grants?

Patton: Two separate things. Grant money is different than GSS operations. GSS itself got less money than last year. 1250 last year, 1200 this year. Tiny decrease.

Yanez: AASA got less than the other student orgs?

South: That's the next bill.

Esmeraldo: Does the salary portion include next paid positions?

Patton: That's not the potential or hypothetical increases, just already passed what we have to pay people every year.

Liu: CAC got a decrease in budget, but they're increasing this year?

Patton: In 2017-18 they got 160k, but we took from the government first at that time, decreasing them unfairly to 136k. Last year more budget restraints, decreasing more to make sure we're still giving to other orgs 132k. We're increasing to 137k, so it's not genuinely an increase, less than what they should have been getting since they never spent more than 100 percent.

Liu: To clarify, when you said they got an unfair decrease, you called that unfair and a large decrease? That's only a 4 percent and large and unfair?

Patton: Already received decrease earlier. Initial decrease was more unfair. Percentage itself wasn't why it was unfair, it was in context of 160k to 136k to 132k.

Broadbent: In between last and this fiscal year, did CAC get an increase?

Patton: Yes. Last fiscal year includes aux funding, which increased them from 132k.

Representative Grebe sec Representative Halsey-Kraus

Patton: 2019-20, 136k flat. 2020-21, this year, primary and aux, 136k 2.69.

Broadbent: Is it true that CAC is aware of how to apply for aux?

Patton: They know how to apply for aux, but I don't think they should get a decrease.

An Act of Legislation amending the Code Annotated to reform and reorganize petitioning procedures and Regulations; amending Executive Branch responsibilities

with regard to petitions; providing for short title, providing for codification, and providing for an effective date.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION:

Section 1: Title: This act shall be known and may be cited as the “Constituent Recommended Initiative & Student Petition Act of 2021.”

Section 2: Purpose: The purpose of this act shall be to reorganize and reform petitioning procedures and regulations within the SGA Code Annotated, to allow the submission of general petitions, establish a verified petitioning platform, and alter responsibilities within the Executive Branch with regard to petition procedures and response.

Section 3: AMENDATORY: Remove all text from the Code Annotated § Title I, Chapter 3, Section 11, Subsections D to I.

Section 4: AMENDATORY: The Code Annotated § Title I, Chapter 3, Section 11, Subsection C is amended as follows. For the purposes of this bill, all deletions are marked by a ~~strike~~through and all additions are marked with an underline.

C. Amendment Proposed by Initiative

The SGA Constitution may be amended by a majority vote of those students voting on the proposed amendment, provided that the amendment has been proposed to the voters in compliance with petitioning procedures explained in Title VII of the SGA Code Annotated. ~~by a petition bearing the signatures of SGA members equivalent to fifteen percent (15%) of the total number voting in the last election for Student President.~~

Section 5: AMENDATORY: The Code Annotated § Title III, Chapter 5, Section 24, Subsection A is amended as follows. For the purposes of this bill, all deletions are marked by a ~~strike~~through and all additions are marked with an underline.

a. The Department of the Interior

i. Department Purpose

The Department of the Interior shall advocate for the position of the SGA as it pertains to internal university affairs. SGA policy shall be defined by a Joint or Concurring Resolution passed by the Legislative Branch, or by the SGA President in the absence of such a resolution. The Department shall address on-campus issues including, but not limited to, student parking, student health and wellness, and on-campus sustainability issues.

ii. Department Director

The Department Director shall be appointed by the President with the advice and consent of the Legislature. The Director shall be responsible for ensuring that the purpose of the Department of the Interior is carried out, and for ensuring the creation and upkeep of a guide to petitioning.

1. Guide to Petitioning

Such a guide shall include instructions for accessing the petitioning platform, creating and formatting petitions on the petitioning platform, properly exporting petition signatures, and submission to the General Counsel’s Office. Such a guide should direct petitioners to compliance with all appropriate

regulations and be as easy to understand as practicable. This guide shall be published and made available to students through the SGA website.

Section 6: AMENDATORY: A new subsection shall be added to the Code Annotated § Title III, Chapter 2, Section 7 of the Student Government Association Code Annotated as follows.

g. Responding to Petitions

The SGA President shall be responsible for drafting and publishing responses to general petitions. Upon notification of certification of a general petition by five-hundred (500) students, the SGA President shall produce and distribute a response to the petition. Such a response must be posted on the SGA Website no more than five (5) academic days after notification of validation from the General Counsel.

Section 7: AMENDATORY: Remove all text from all sections of the Code Annotated § Title VII, Chapter 1.

Section 8: AMENDATORY: The Code Annotated § Title VII, Chapter 1, Section 24, Subsection A is amended as follows. For the purposes of this bill, all deletions are marked by a ~~strike through~~ and all additions are marked with an underline.

1. Definitions

- a. Initiative Petition – A petition that seeks to place legislation (i.e., a bill or resolution) on the ballot for the student body to vote upon. An initiative petition may also place SGA constitutional amendments on the ballot for the student body to ratify or reject. Any member of the SGA may initiate legislation provided that the proposed legislation bears the valid signatures of members of the SGA equal to fifteen percent (15%) of the number of students voting in the last general election. Such legislation shall be brought before the Legislative Branch for a vote. If rejected by the Legislative Branch, it shall as soon as practicable be put before a vote of the SGA and a majority shall be required for its passage.
- b. Recall Petition – A petition that seeks to place an elected SGA official on the ballot for retention before their term of office has expired. The members of the SGA may recall any elected SGA official if the petition providing for recall election shall be signed by the number of members of the SGA equal to twenty-five (25%) of the total voters in district in the last general election. The text of the petition shall be in the format: “We, the undersigned, petition for the recall of the following official: (name).” The question to be placed on the ballot shall be “Shall (name) be retained as (name of office)?”
- c. Petition for a Presidential General Meeting – A petition that calls for a Presidential General Session of the SGA. Such a petition must contain the valid of ten percent (10%) of the members of the SGA. The text of the petition shall be in the format: “We, the undersigned, petition for a Presidential General Meeting of the SGA.” Upon certification, the SGA President must call and preside over a general meeting of the SGA.
- d. General Petition – A petition that seeks to determine the position of SGA leadership or request action be taken. General Petitions may not be considered initiative petitions but should be used to call for action from the SGA on an issue specified within the petition. General Petitions must not be placed on any ballot for the student body to vote upon and are solely to be used to determine positions of or request action from SGA leadership. The text of the petition

- shall be in the format: “We, the undersigned, formally petition for a response from SGA regarding the following issue: (insert up to 200-word description here).” Upon certification of such a petition by 500 students, the Executive Branch of SGA shall produce and distribute a response to the petition. Such a response must be posted on the SGA Website no more than five (5) academic days after notification of certification from the General Counsel.
- e. Proposition – A constitutional amendment, legislation, or recall language the Petitioner seeks to place on the ballot for the student body to vote upon.
 - f. Summary of the Proposition – The substance, essence, or action, in summary, of the effect of the Proposition. The Summary of the Proposition accurately reflects the Proposition, much as an abstract reflects its larger article. The Summary of the Proposition shall serve as the ballot question, and;
 - i. Must not exceed two hundred (200) words;
 - ii. Must explain in common language, which can be easily found in dictionaries of general usage, the effect of the Proposition;
 - iii. Must not contain any words that have a special meaning for a particular profession or trade not commonly known to the OU student body;
 - iv. Must not reflect partiality in its composition or contain any argument for or against the Proposition;
 - v. Must contain language which clearly states that a “yes” vote is a vote in favor of the Proposition and a “no” vote is a vote against the Proposition;
 - vi. Must not contain language whereby a “yes” vote is a vote against the Proposition and a “no” vote is a vote in favor of the Proposition.
 - g. Petitioner – An enrolled student at the University of Oklahoma Norman Campus who uses the initiative petition or recall petition process as provided for in Article VII of the SGA Constitution.
 - h. Petition Circulation Period – A period of time beginning on the date that the first signature is collected and ending ninety (90) days, when class is in session, later.
 - i. Petition Summary – An automatically generated report from the Petitioning Platform, containing the names and OU ID numbers of all signatories, in compliance with the guide to petitioning produced by the Department of the Interior.
 - j. Petitioning Platform – The accessible internet platform on which signatures must be collected. Engage shall serve as the petitioning platform.
 - k. Signature – In order for a signature to be considered valid, it must contain the name of the signatory as well as their OU ID number and an affirmation that their submission is freely produced.
 - l. Petition Certification – A determination of the SGA General Counsel that a sufficient number of signatures required for initiative petitions or recall petitions as provided for in Article VII of the SGA Constitution have been submitted by the Petitioner.
 - m. Academic Day – A day which classes are in session.
2. Procedures for Petitioning
- a. Initiative Petition Procedure
 - i. Petitioners must submit the following to the SGA General Counsel, hereinafter referred to as General Counsel, prior to collecting signatures:
 - 1. A true and exact copy of the Proposition
 - 2. A true and exact copy of the Summary of the Proposition.

- ii. The General Counsel shall have five (5) academic days to review the proposed Summary of the Proposition and determine whether it complies with this Title.
 - iii. The General Counsel shall have the authority to modify or rewrite completely the Summary of the Proposition to ensure that it complies with all regulations.
 - iv. The General Counsel shall not have authority to modify, in any way, the Proposition itself.
 - v. The Petitioner may withdraw their petition at any time until Certification.
 - vi. Upon initial submission and review, the General Counsel shall post the final Summary of the Proposition as well as a true and exact copy of the Proposition in a conspicuous place inside the SGA Offices and shall transmit a copy of the same to the Petitioner, SGA President, Chair of the Undergraduate Student Congress, Chair of the Graduate Student Senate, and editor of the primary campus newspaper.
 - vii. Upon posting of the aforementioned Summary of the Proposition and the Proposition, any member of SGA who is dissatisfied with the wording of the Summary of the Proposition statement may, within seven (7) academic days, appeal to the Superior Court. After such an appeal is filed, the Court shall uphold the sufficiency of the proposed Summary of the Proposition statement, make corrections to the Summary of the Proposition statement, or draft a new Summary of the Proposition statement. Should there be no appeal within the seven (7) academic days allotted for such an appeal or once the Court has ruled, there shall be no further challenge to the petition on the basis of the Summary of the Proposition statement.
 - viii. After the posting requirements mentioned in vi. and vii. are met, the General Counsel must notify the petitioner of the posting and inform them that signature collection may begin.
 - ix. The Summary of the Proposition shall appear at the beginning of the electronic form on the Petitioning Platform.
 - x. Petitioners may utilize up to the entire Petition Circulation Period to collect signatures but must not exceed it.
 - xi. Petitioners must submit a Petition Summary to the SGA General Counsel no later than five (5) academic days after the conclusion of the Petition Circulation Period.
- b. Recall Petition, General Petition, and Petition for a Presidential General Meeting
- i. Petitioners shall not need to submit any materials prior to collecting signatures.
 - ii. Prior to collecting signatures, Petitioners may request a review from the General Counsel to ensure compliance with all relevant regulations.
 - iii. The General Counsel shall have five (5) academic days to review all submitted materials and determine whether they comply with relevant regulations, then notify the petitioner of the determination.
 - iv. Should the Petitioner request a review from the General Counsel, they must not collect signatures until the General Counsel notifies them of a determination.
 - v. The full text of the petition shall appear at the beginning of the form through which signatures are collected on the petitioning platform.

- vi. Petitioners may utilize up to the entire Petition Circulation Period to collect signatures but must not exceed it.
 - vii. Petitioners must submit a Petition Summary to the SGA General Counsel no later than five (5) academic days after the conclusion of the Petition Circulation Period.
 - c. Certification of Collection of Signatures – Every Petition Summary must be submitted along with the following statement:
“I, (name), hereby attest: That I am a currently enrolled student at the University of Oklahoma Norman Campus and that the signatories to this petition have correctly and validly submitted their name and OU ID number, and that each signatory is a legal voter of the SGA.”
 - d. Submissions – Submission of all materials must be in the form of PDF or Word Documents emailed to the General Counsel.
 - e. Petition Circulation Period Regulations
 - i. If the Petitioner does not submit the Petition Summary to the General Counsel within five (5) academic days following the end of the Petition Circulation Period, then the signatures the Petitioner has collected shall be null and void.
 - ii. The Petitioner, at any time before the final submission of signatures, may withdraw their petition upon written notification to the General Counsel.
 - iii. A Petitioner may terminate the circulation period early at any time during Petition Circulation Period by properly submitting the Petition Summary along with the signed statement.
3. Certification Process
- a. Upon proper receipt of the Petition Summary and signed statement, the General Counsel shall begin the certification process. The General Counsel must make or cause to be made a count of the number of signatures on the Petition Packets submitted by the Petitioner. The General Counsel shall ensure that the count is conducted within a reasonable amount of time. In making such count, the General Counsel shall not include:
 - i. Signatures of non-students
 - ii. Duplicate signatures
 - iii. Submissions not meeting the definition of a signature as defined in this Title.
 - iv. Signatures for which the name and OU ID number do not match.
 - v. Signatures which the General Counsel has reason to believe were submitted by any person other than the listed signatory.
 - b. The General Counsel must notify, in writing, the SGA President, Chair of the Undergraduate Student Congress, the Chair of the Graduate Student Senate, and the Chair of the Campus Activities Council of any and all violations of this Title of which they have knowledge.
 - c. If the General Counsel certifies an Initiative petition or Recall Petition, then the General Counsel shall post the Proposition in a conspicuous place in the SGA Offices and notify the Legislative Branch. All campaigning regarding referendums, initiatives, recalls, or constitutional amendments shall be subject to the guidelines set forth elsewhere in the SGA Code Annotated. If the General Counsel rejects a submitted Initiative Petition or Recall Petition as invalid, then the General Counsel shall submit a written report or make a personal appearance at the next regularly scheduled meetings of the Undergraduate Student Congress and Graduate Student Senate explaining grounds for the rejection. The decision of the General Counsel may be appealed

by the Petitioner or the Legislative Branch, via concurring resolution, to the SGA Superior Court.

4. Referendum

Any bill being considered for passage by the Legislative Branch may, by a majority vote of the Legislative Branch, be referred to the members of the SGA for their approval. In such case, the Legislative Branch shall provide for the publication of such bill and its general dissemination among the members of the SGA at least one week prior to such election. For such bill to be enacted, it must receive a majority of the votes cast unless more stringent requirements are set by the Legislative Branch and fifteen percent (15%) of the total number of eligible voters shall have participated in such election. Balloting on such bill shall take place at such time and in such manner as provided by Congress, and the result of such an election shall be binding upon the Legislative Branch.

- a. Content of Referendum Proposal: A referendum proposal must specifically state the purpose of sending the legislation or Constitutional Amendment to the SGA members for a referendum vote.
- b. Ballot Explanation: The SGA General Counsel may write an explanation to appear on a referendum ballot.

5. Constitutional Amendment

The SGA Constitution may be amended by a majority vote of those students voting on the proposed amendment provided that the amendment shall have been presented to them by two-thirds (2/3) majority vote of each House of the Legislative Branch at least three weeks prior to the election at which the amendment is to be voted upon. A single Act of Legislation shall be used by the Legislature in a manner consistent with Article X, Sec. 1 of the SGA Constitution to (1) propose an amendment to the SGA Constitution and (2) establish a referendum presenting said amendment. Such an Act of Legislation must pass with a two-thirds (2/3) vote of each house. Such an Act of Legislation may be used to place said referendum on the ballot of a general election, to establish a special election, or to add said referendum to the ballot of an established special election, as shall be specified in said Act of Legislation. Each amendment shall be proposed by its own Act of Legislation. If the SGA President vetoes such an Act of Legislation, it shall be considered passed over any such veto.

Section 9: This act shall become effective when passed in accordance with the SGA Constitution.

AS INTRODUCED

An act relating to appropriations; providing for short title; stating purpose; appropriating Primary Funding for the 2020-2021 process; stating appropriation guidelines; establishing expiration deadline; directing transfer of unused funds by deadline; and providing an effective date.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION:

Section 1: This act shall be known and may be cited as the “Primary Funding Act of 2021 for Registered Student Organizations”

Section 2: PURPOSE. The purpose of this act is to appropriate the funds of the University of Oklahoma Student Government Association to the organizations mentioned within.
