Please be mindful of their time, keep your reports brief committee chairs. Be polite with our guests. We have some folks who this is their first meeting, make a good impression. I won't tolerate calling into question the motives of any member. Please follow the rules of decorum in the Bylaws. I will gavel you down. The new members will need to take the oath of office so they can vote, so we'll see CB-105-05 first after Committee of the Whole followed by a recess for swearing in. We've appointed two new committee chairs, from Loayza, Roberts, Smail, Mojekwu, and Saldana have resigned. We thank them for their service to Congress and the university. February 16 and after, once reservations have opened, Congress can have hybrid meetings again. I made a recurring reservation until March 2nd, at the Physical Science Center, Room 201, COVID capacity of 45. Allocating those spots available later. I don't have that now, because I made the reservation right before the meeting. If you can't make it to the space you'll be able to participate online.

Vice Chair's Report – Hello everyone, I'm Alexis, she/her. First I have access to CongressVC@ou.edu now, I'll send out my office hours to you all. If you're an associate and haven't joined the groupme, scan the QR code now. Associate or rep who didn't go to orientation last semester, you'll have to go this semester. February 14th. Old members aren't required to go, but if you think you need a reminder on anything, you can come where you need a refresher. PR application opens up today. I want to make it more structured, if you want to do graphic design, social media, PR research. Gaylord professor will say how to write a press release. Application is on ENGAGE closing this Friday at 5:30pm. Big 12 on the Hill is on February 22-24. Usually it's in DC, but it's online this time hosted by OSU. We want to open up opportunities, so I'll send out a survey for volunteering for research, making lists of RSOs, etc, like the OU Pantry for the issue of Food Insecurity. o CB-105-04 An Act Appointing the Spring 2021 SGA Election Commissioner (Farzaneh)

Representative Lynskey seconded by Representative Griffin

Farzaneh: We decided to appoint Joy Nath to be the election commissioner. 4 applicants for the position. Clarification, the election commissioner position runs the academic year. Past one resigned last semester. Opened the application, had 4 applicants. We reviewed the applications and decided to appoint Nath due to his experience with ConAd and election commission in the past. He had really great ideas. We forgoed interviews because it was clear he was the most qualified candidate.

Patton: Can you explain the interview process?

Farzaneh: There wasn't an interview process.

Merchant: You said that the new commissioner usually comes in at the beginning of academic year, when does this expire?

Farzaneh: End of the semester, we'd go through the process again.

Garg: What ideas specifically did Nath have?

Farzaneh: I can pull up the application.

Nath: I'm here. I'm Joy Nath, he/him. Election commissioner designate. I highlighted how my main goal was trying to the election online coherently. Last election, there were issues with the election report, with ENGAGE there was a minor problem. True Democracy NOW sorted out candidate information. Also, supporting candidates to make them feel like they're trying to run for something as opposed to just getting votes.

Broadbent: Would you not agree that normally when appointing election commissioner they should see Congressional Administration committee first?

Farzaneh: Yes, that does happen, and we did that.

South: This didn't go to ConAd officially because of timing. I put it on our agenda for COTW since it needs to see committee first.

Patton: Can you speak to your ConAd experience like legislation and attendance?

Nath: My legislation, I presented some last semester with Chair Hillis for OrgSync. Title 12 legislation and Title 9 legislation I'm working on currently. Attendance, I believe I had perfect attendance mostly.

Grebe: Can we assume moving forward that you'll pick those based on most experience? Farzaneh: Yes, I think experience is most important.

Broadbent seconded by Poupore

Farzaneh: Experience is huge in appointing any position, as well as who's the best for any particular position.

Poupore: You said that Nath was so qualified that he didn't warrant an interview, but you couldn't remember his qualifications. Why?

Farzaneh: I don't have the best memory and I'm not feeling the greatest today.

Gray: We knew going over the applications blindly that this person was the person for the job. Broadbent: VP Gray, you went over the applications blindly? How?

Gray: Going over the 4 election applications, we didn't see the names, just the responses to the questions.

Flaggert: Mentioned experience is only thing taking into account for your appointees. Why wasn't there interview processes if experience isn't the only thing you're taking into account? Farzaneh: Experience for this position is important, and it depends on what the position is. It was the most important factor here.

Patton: Did other members of the election commission apply?

Farzaneh: I don't know if that's sensitive information to share.

Patton: Were there others with distinct experience with SGA?

Farzaneh: Yes.

Halsey-Kraus: ConAd does have to complete a selection bias training before interviews. Did you do that?

Farzaneh: No.

Broadbent: Do you not feel it imperative to send it back to ConAd so they can review the application more thoroughly?

Farzaneh: No, because it's the president's appointment ultimately.

Poupore: As you said, you went through apps blindly. I feel with apps there are unique qualifications that make it obvious on who it is. Could you tell who was who from those qualifications?

Farzaneh: Not sure about the ethical piece of answering this question. Yes, there are times where it can be clear who it is, but there are times where it's not clear. With appointments, it's something we are able to decide on.

Broadbent: Would you not agree that there are checks and balances in the Constitution and the Code that give reasons for our processes?

Farzaneh: I'm not the most well versed on that. It's our discretion to do it that way and I did the best I could.

South: If there was any mess up on the way it was handled, that's on me. It was requested that this be seen as soon as possible.

Griffin: Is there any reason you wanted this to be seen so quickly?

Farzaneh: Yes, there's a vacancy in the position and with the upcoming election, we desperately need a commissioner.

Patton: Did any of the other election commission staff apply?

Farzaneh: I don't feel comfortable answering that.

Broadbent: Would you prefer this go back to ConAd or we see a rec of do fail?

Gray: Preferably we'd see it pass.

o CB-105-06 Chief of Staff Appointment Adjustment Act of 2021 (Hillis)

Representative Griffin seconded by Representative Sertovic

Hillis: This is a simple bill, it changes the way the Chief of Staff is appointed. Usually, the Chief of Staff is already known by the Presidential ticket, and having them go through a longer process takes time.

Merchant: Is the appointment process of Chief of Staff why Mx. Kaya is currently interim? Hillis: They all already knew Cricket would get Chief of Staff, so she has interim position. We have interim UPol and COSCO chairs.

Tesfaselassie: What process replaces the old one for appointment of Chief of Staff?

Farzaneh: The past administrations didn't follow the code and appointed the Chief of Staff. It's a high office, you have to open applications with applicants. It's not fair and doesn't make sense, since most tickets already know. It allows the executive branch to appoint their CoS while still following and respecting the Code.

Hillis: Though they forgo the competitive application process, the Chief of Staff still goes through legislative appointment process. This just takes away application process.

Representative Lynskey seconded by Representative Merchant

South: This bill appoints new chairs for UPol and COSCO. Last week, we opened apps Tuesday to Friday. Three applications, each one got an interview that asked a number of questions about what they wanted from the committee. Through that process, I decided on the nominees here, Allegra Shaffer and Graeson Lynskey for COSCO and UPol respectively.

Student Concerns

Beltz: Someone from Ultimate Frisbee asked if they could chalk the sidewalk.

South: Chalking request form somewhere.

Kerr: Online process, George dropped the link.

Garg: Biz closes at 11pm, not good for anyone who wants to pull an all-nighter. It'd be helpful to expand hours for studying.

South: We contacted the Biz last semester asking if it was feasible, and they said it wasn't monetarily, they don't have funding and there isn't demand to keep it open. COSCO is working on a list of study spaces across campus. Union is also open 24 hours a day.

Grebe: I'm an RA in Adams. This building is falling apart. There are floods everywhere. Lights don't turn on sometimes. Our office has lost heating and AC many times. We have a mouse problem. We've taken our concern to housing many times. Is there anything we can do. Please.

South: Good thing for COSCO and UPol to look at, for safety issues and policy issues on how they're approached.

Yanez: A lot of people have been complaining about students not wearing masks on campus. Professor in Gaylord class in particular.

South: Talked to provost about professors not wearing masks and she told me she'd look into it. For students, I encourage all of you to encourage your friends to wear their masks. UPol could do another masking resolution.

Sertovic: Joint student concern. Coffee trucks, the website says they're open till 6pm, but they're gone by 3pm. Only place to get coffee with points. I'd like to have it till 6 or even later.

South: I think they're privately owned, but I'll get with George and email Frank Henry. We'll ask.

Kerr: Coffee truck related. Lucid Bean, the person wanted to use meal swipes, but the owner hasn't been able to receive the money from the meal swipes, so she hasn't wanted to allow meal swipes.

Ahmadi: If a business is not using swipes, that's an option they give private businesses. The business doesn't have to do swipes. If there are multiple questions about coffee trucks, we could compile the questions together in one email. Forward your questions to me.

Poupore: Topic of food services, last semester at Cate, they used to have free drinks. Drinks are no longer free this semester. It doesn't make sense, because we can go to the caf for a free drink with our meal swipes. I have a lot of people asking about that.

Ahmadi: We can ask Frank about that as well.

Garg: Goddard. I wanted to get my second dose of the COVID-19 vaccine, but Goddard doesn't have that organized yet. Cleveland County Health Department is giving the second dose already. I'd love to work with the committee assigned to it to organize the process and prioritize second doses.

Harman: COVID testing, they've stopped COVID testing at Cate, accessible for towers residents. Goddard is only one available, could we bring it back to Cate for easier access?

South: Limited funding project there, but is IMMY labs still open?

Harman: It should be receiving funding.

Old Business

Items to Be Considered

CB-105-05 Spring Appointment Act of 2021 (Hillis) (ConAd, Do Pass)

Representative Broadbent seconded by Representative Lynskey

Hillis: Thank you for still being active in the body, appreciate your patience. Spring appointment bill. Some members on the appointment bill interviewed last semester and we couldn't see their bill then. 23 interviews. Last time was 84 and I had COVID. All of my members completed selection bias training. Excited to welcome new members. Moving rep to associate because that seat was already filled.

Broadbent: Reemphasize how many interviews we did and who got the interviews? How many turned down?

Hillis: Congress gets automatic interview. You're more than what's on your application. Some people can talk in an interview much better than on their application, or vice versa. 8 in November and 23 now. Don't know how many we turned down last time, but this time we denied 6 people but 2 didn't complete an interview.

Broadbent: FA striking Life Sciences Seat Elizabeth Worrell and Kate Cruickshank.

Hillis: Yes, two Life Sciences seats were filled when our clerical error said they were open. Also, clerical error for legal name to preferred name.

CB-105-06 Chief of Staff Appointment Adjustment Act of 2020 (Hillis)

Representative Griffin seconded by Representative de Medeiros Cartaxo Esmeraldo Hillis: Just saw this.

Ahmadi: Question that I don't think this addresses open application process. Second, where is it interpreted that Chief of Staff has to go through advice and consent process?

Hillis: Finance question, I'll take a look. Second question, it's still listed as a high office. It says they don't have to go through the competitive process.

Ahmadi: I don't see a section that says high offices have to go through advice and consent. Chief of Staff hasn't gone through that process. I want to do this fully.

Gray: Cricket had to step away. Chief of Staff with this would be an appointed position like the executive cabinet.

Hillis: I think another bill can address this.

Broadbent: If we pass this bill tonight, the President and VP appoint a Chief of Staff that we provide advice and consent on, right?

Hillis: I believe so.

Gray: In the past, the position is an appointed position. The president knows who their Chief of Staff is going to be because it's usually their campaign manager. We wanted to get an amendment to change the code so we can follow the code in future administrations. The position is still in the same process as our other appointed positions. We just want it to follow the Code by process.

Hillis: ConAd is looking at the way that SGA allows people to apply and interview. Everyone should have a fair process.

Broadbent: Is this the only paid High Office that we're not doing advice and consent? South: It's not getting rid of advice and consent, just the application process so they can immediately appoint someone.

Gray: Yes.
