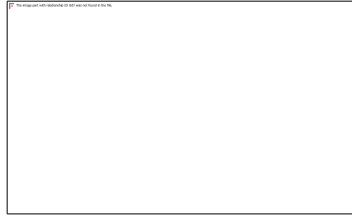

We're looking into more LGBTQ+ resources with HD. Looking at tutoring programs. Continuing on other projects too with a lot of progress on them. Ask me about any of them.

Harman: Letting you know, HD is not putting on Friendsgiving this year. Out of the safety of everyone involved, we won't be putting it on. We also have the newsletter coming up in February. There will be book suggestions, so I'll send a form.

Hillis: SGA General Application closes the 19th, this Thursday. If you didn't run, you're not a representative. Share it with friends. Also, our SGA Administrative Assistant, thank you, we love you.

Broadbent: Talking about why we passed this resolution. We want to establish better relationships to our elected officials. It's easier to lobby those things we care about if they know we're proud of them. I'll send them out to you all. My sorority is the Native American sorority on campus. Missing and Murdered Indigenous Women. Selling t-shirts going to that charity. All our events are virtual the rest of the week.

Friday, we ask you all wear red to raise awareness for missing and murdered indigenous women. Oklahoma has some of the highest rates in the country. I'll send the graphics in the GroupMe and the t shirt link.

Few: Not SGA related, but a few years ago, a friend got assaulted, and she's doing a documentary on consent awareness. They're raising funds for that, so I'll send the link to the trailer to share it.

Lange: Met unofficially for Sustainability. The biggest project was with the gameday traffic equipment. We thought about this semester but now we want to do it at the Red and White Game next semester. Be on the lookout for that. You're welcome to join. Otherwise, thanks to Faith Thompson for her ideas and initiative, welcome to Susty. Also, if anyone is or knows someone interested in TreeFest where we plant trees, let me know. We're doing it outside Congress.

Merchant: Gender and Equality Center hosting a transgender day of remembrance at 7pm in Andrews Park. Come out to recognize those individuals. If you or anyone you know is a survivor of gender based violence, OU Advocates. Please call them if you're in those situations, the number is on your student ID.

South: Update on UPol, we talked about ideas for future projects. Policy audit. Looking at Regents' policy manual and weeding out old or bad policy. Also, if you want to talk to me about what you want to see in a Congress chair, please contact me.

Patterson: I'm really glad we made quorum today. It's stressful times, but you meeting in person really means a lot. Hopefully seeing how big the space is makes you more comfortable. AS INTRODUCED

An act relating to appropriations; providing for short title; stating purpose; appropriating Auxiliary Funding for the 2020-2021 process; stating appropriation guidelines; establishing expiration deadline; directing transfer of unused funds by deadline; and providing an effective date.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION:

Section 1: This act shall be known and may be cited as the “Auxiliary Allocation 9 Act of 2020-2021”

Section 2: PURPOSE. The purpose of this act is to appropriate the funds of the University of Oklahoma Student Government Association to the organizations mentioned within.

Section 3: APPROPRIATION. The following amounts are hereby allocated to
