AS INTRODUCED

A Concurring Resolution Commending the Response of
Several Entities for 2013 disaster relief; and directing distribution

WHEREAS: The People of the Great State of Oklahoma have and shall always respond with resilience to the destruction of severe weather; and

WHEREAS: Scores of Faculty, Staff, and Students were directly or indirectly affected by the May 2013 tornadoes; and

WHEREAS: The May 2013 tornadoes impacted thousands of individuals in the area; and

WHEREAS: The May 2013 tornadoes caused substantial physical and monetary devastation in the central Oklahoma area; and

WHEREAS: Disaster response requires significant effort in ensuring the safety and provision of those impacted and understanding of the civic duty of all to each other; and

WHEREAS: Countless groups and individuals took immediate action by providing aid through acts such as: bring about awareness prior to and during the storm, providing support for those directly impacted afterward.
