Chair's Report- I'm Lauren Aragon. I'm usually in my office in the Conoco Mondays, Wednesdays, and Fridays all day. My email address is congress@ou.edu. Welcome to our new members and thanks to old for coming back. We only have one open seat out of 48. Coming up we have Higher Ed. Day on February 10th at the State Capitol. It's a really great opportunity to meet state representatives and advocate for more funding for higher education in the state.

Vice Chair's Report- I'm Connor Bourland. Whatever you need, I'm here. Come talk to me about writing legislation or questions about what you are working on. Sunday is orientation. You are required to attend. It starts at 2:30. We will have seminars and food! This is MANDATORY. If you won't be there, email Emily to let her know. Only good reasons will be excused, otherwise it is an absence. My email is congressvc@ou.edu. Liaison Reports

Special Orders

SGA President Kunal Naik:

Naik: I'm President of the Executive Branch. You may have seen the various articles in the *OUDaily*. Over the break on December 27th I made a mistake and was arrested for public intoxication. It's been very difficult personally, but I also let down the students. I made an oath, and it's new for me to not have a separation between my personal and professional life. I'm very sorry. You in Congress hold me accountable, and I have not done as well as I should have. I know that I have been a distraction to our efforts here, but this isn't what SGA is about. My VP and COS have done a great job handling it, and that Exec has been moving forward without impact. I promise that only good stuff will come from my personal life from now on.

Echols: Who were you with on the night of the incident?

Naik: Just a few friends in OKC.

Echols: Specify please?

Naik: I don't think that's my place. I don't want to bring their private lives into this public setting. Crisp: Is it true that you had a leadership role in Pi Kappa Phi, and what responsibilities did that position entail?

Naik: I was the Vice President of Pi Kappa Phi. Some of my duties included overseeing the directors of social events, public relations, and recruitment.

Crisp: Is it true that your fraternity had an alcohol related incident, specifically with your recruitment events? Naik: Yes, we were one of several fraternities that got caught up in that scandal on July 18th I think. We went to judicial trial, were sentenced with a \$500 fine, and we were restricted access to the database containing potential rushes.

Bourland: I have many constituents who were asking if we are going to impeach you and why you have not resigned yet as they think that is the appropriate course of action. Are you going to and why would you not? Naik: I've thought about it. OU staff has advised me, at my request, about what I should do. I don't want to leave a job I just started to the people I ran with and who we selected for departmental positions. We told them we wanted to enable them to serve their fellow students. I still think that I am capable of that and am comfortable with staying in this role.

Aragon: What kind of feedback have you received from administered?

Naik: Nothing negative. Everything I have heard has been really supportive coming from deans, administrators, and professors. They have been very sympathetic and supportive which has meant the world to me

Skelton: What projects are you working on in the Executive branch?

Naik: We are really pushing for Higher Ed Day, which we think has the potential to be a political Soonerthon. We will follow that vision as much as we can; we want it as big as it can be. We have some plans we are starting to work on such as video series like fireside chats to promote SGA, our EngageOU plan, which is a platform to help students become involved, SafeRide Reform, our soon to be titled Department of Diversity will meet with Unheard to see what we can do, and none of these have been impacted by this incident. Benjamin: Do you think your arrest will overshadow your accomplishments?

Naik: I have really thought about it. I'm darn sure I'm going to try to keep it from overshadowing our projects. Apologies are great, but action is worth so much more. We are going to try to do as much as possible so that when I get out of office, people won't talk about my arrest, but what we have accomplished. Bourland: Is there anything in addition to today's article and what you have said to us today, is there anything else you want to say about how to move forward, such as if we can trust you?

Naik: How do we move forward? Well tell everyone to come talk to me. I want to work with everyone who has a concern individually; I want to hear it. On Thursday, after the article, my phone was going nuts. I had lots of calls, texts, emails, and all really supportive. OU Unheard raised a concern that our OU family was not as strong as we thought. When I was going through these things, and hearing people asking me if I was okay, I mean, it was an amazing feeling to be a part of that family.

Arlan: In light of these events, what are the plans for your Good Neighbor Initiative?

Naik: It takes on a whole new context for me especially lol. It is honestly cruel irony that the whole situation turned out this way. It seems more important to me now. The initiative is to provide PR and advertising for students that we share this city with members of the community and encouraging them to connect with them and create community with citizens beyond this campus. An example would be bringing chocolates to your neighbors to encourage that community. That is the broad outline; but I haven't been able to work as hard on this project as much.

Bourland: Did you take your neighbors chocolates?

Naik: No, I just came up with it.

Pae: Is it possible that the embarrassment of an impeachment trial is worth it instead of resigning?

Naik: When this comes to me, and how I react to this, I can't let down the people who voted for me. This is the very beginning of my term, and we are just getting into our huge projects. I wouldn't feel right just stepping down and abandoning it. With all the support I have received from the administrators, I feel like I should stay.

Mills: Since you are the face of SGA and these events have impacted how you are received, could you step down and be Vice President, and instead let Alex represent the face of SGA as President.

Naik: I don't know how those rules work. I will refer the answer to Chair Aragon.

Aragon: If he stepped down, it would automatically make Alex President, and open applications for Vice President for Alex to select. The Vice President selection would then be under advice and consent of Congress. He could be selected by Alex to be Vice President, but Congress could vote no, and he then wouldn't be.

Crisp: What do you think constitutes an official SGA communication?

Naik: An event is 3 or 4 or more members of community for Pi Kap. I would assume similarly for us here. Bellafiore: What is the appropriate way to hold you accountable?

Naik: The prisoner just became jury. I don't know; I will have to think about it more. The answer I would love to give is that it is whatever you pick. You are the representative body, and whatever you decide is what I will determine reflects what the students want.

Watts: You are also a representative; 1,273 people elected you as a representative. Do you feel you still represent those people who voted and the whole student body?

Naik: Based on what I have received in response from people who know me, I still feel that I am able to represent our students very well.

Watts: A lot of people close to you are encouraging you to keep going, so how insulated are you, because I have heard very different responses from students.

Naik: I try to reach out to diverse groups of students. Most of the feedback I have received has been positive and supportive from administrators and students.

Echols: Would you say you have failed to represent the SGA?

Naik: In that instant, I didn't represent myself well, least of all the student body. I made a mistake and error in judgment.

Echols: Does your student life impact your life as SGA President?

Naik: I would say that life as SGA President has impacted my life as a student. Being a student is going to class, getting my degree, talking to my parents weekly. All these things impact my presidential role; it makes me more prepared for that. It prepares me to enter my office and do work every day.

Balangue: You keep saying this incident hasn't impact Exec. Has it impacted anything other than your reputation?

Naik: I haven't seen anything yet, except for my public image, and disrupting Congress to answer all these questions. You can corroborate this by talking to any member of Exec.

Naberhaus: Has Clarke Stroud responded?

Naik: Clarke told me to go for it, and measure people's reactions, and to keep moving forward.

Hasan: What do you think the people will say about you, Kunal?

Naik: So far, the responses I have heard are that I have been a disappointment and that there has been a lot of sympathy, not for my role as president, but for my role as a student.

Watts: If there has been no big effect, what are you sorry for?

Naik: I'm sorry to put everyone in this position and to have made a mistake, and made SGA look bad, and to have cast doubt on SGA's abilities. That in that moment I didn't represent students like I should have, nor since the story broke because I have been dealing with the press. I still think I am very capable to do the job I hope to do.

Watts: A student actually sent in to the *OUDaily*, "This is so embarrassing to me as a student of OU, and should be to everyone. This is what happens when student government becomes so disconnected from the student body that self-serving frat boys are able to achieve a position where they should be representing the university, not selfishly building a resume. If he is not impeached, it will simply be another indicator of the tragic apathy that defines the OU student body's relationship with student government." If they were here, what would you say to them?

Naik: I don't appreciate the "drunk, frat boy" characterization, but I want to talk to them and work to move forward without scarring the reputation of SGA and our administration.

Marhanka: I know you are asking us to trust you, but what evidence of change can you give us to ensure it won't happen again?

Naik: My personal life has already changed, and I can guarantee my personal life won't be on front page again.

Arlan: Regarding SafeRide, do you think you are now personally motivated to make big differences in the program?

Naik: SafeRide Reform and the Good Neighbor Initiative are the two big projects that have become the biggest issues as a result of this incidence. The Department of Interior is working to find a more reliable service to take over the contract.

Motion to generate a list and extend time for questions to the end of the list Bourland, sec Cramm.

Crisp: Did you or have you used any SGA resources to in any way try to cover up allegations about the incident, for example to keep this from going into the newspaper, which I heard from a source?

Naik: I have no knowledge of that occurring, but we can talk after the meeting about it because I would love to settle that question.

Park: Have you received any advice from David Boren?

Naik: We haven't spoken about this issue.

Echols: To what extent, and on what occasions does your image represent the SGA?

Naik: I've learned from this experience that everything I do always represents SGA.

Hudson: Will you be attending Beverages after Congress?

Naik: If you want me to drive, I'll give you my number so I can give you a ride.

Balangue: How accurate was the OUDaily report? You just went to wrong home because you thought it was yours?

Naik: It is very accurate. Not being able to enter your own home because you are that far gone is very bad. I was given a chance to give a response twice, once in the initial story, and again when the *OUDaily* was gracious enough to run a longer apology today.

Hawi: What can we expect from you as SGA President next semester?

Naik: We are still trying to reach all our platform points we got elected on. We are committed to these goals. That is what we are going to do.

SGA Vice President Alex Byron:

Byron: I'm the Vice President. I started as a freshman as an associate in Congress; look where I am now! Congress is a great body to be involved in and to make change on campus. You have great leaders, they know a lot, and have been here forever. SGA does great things in all aspects. We have the four branches-legislative, executive, judicial, and CAC. All of our branches are trying to make OU better. We are looking forward to working closely with Congress; a lot of you seem familiar, and I encourage you to rise up through the ranks and share your ideas. Matt and Sarah did great job to move forward with greater cooperation together, and

we want to continue increasing communication between all the branches. We want committees talking to departments. For Higher Ed Day, all should go! There will be free lunch, you can talk to cool people, and network at the capitol. EA is talking to the Department of the Exterior; we are working together on that, and we have plans for PR to work with the Department of Communication, and others. We will be here next week, along with all the department directors. We may not have enough seats, make us stand, you guys should get here early to grab seats. Nathan Thompson, the legislative assistant can tell you about what we about to see. Feel free to talk to us anytime; we have food in our offices.

CONGRESSIONAL BILL NO. 930101

As Introduced

An act of procedure Expelling Members of Congressional Session 93 for excessive absences; providing for a short title; stating purpose; and providing an effective date.

Section 1:	Title. This act shall be known as "An Act Expelling Representatives."
Section 2:	Purpose. The purpose of this act shall be to expel a member for excessive absences. Because Benjamin Bevilacqua and Matthew Hoover have accrued excessive unexcused absences and have failed to petition the Executive Committee for an attendance waiver, and as a result have failed to represent their constituents, the membership of the aforementioned is pending expulsion.
Section 3:	In accordance with the Section 3.3 subsection 2 of the SGA Undergraduate Student Congress Bylaws, "Upon accruing a fourth absence, the Student Congress Secretary shall prepare an act of procedure to expel any member or committee officer who has accrued excessive unexcused absences."

Section 4:	This act is hereby enacted.
Section 5:	This act shall become effective when passed in accordance with the SGA Constitution.
