930304 A Resolution Censuring the SGA President (Cramm/Sample) (No Rec-ConAd)

Skelton, sec Johnson

Cramm: This was tabled last week condemning the acts of SGA President Kunal Naik. I request a friendly amendment to remove the third and fourth whereas clauses to remove inaccuracies.

Crisp: Was it tabled to research incorrect information or was nothing found?

Cramm: Was tabled because we already knew there was inaccurate info

Crisp: Explain

Cramm: We didn't have to do any research about whether or not it was inaccurate because we already knew that one of the whereas clauses was incorrect, specifically the one regarding the *OU Daily* poll.

Bourland: Would you be willing to accept a friendly amendment removing the third and fourth whereas clauses

930104 An Act Codifying Surveys (Aragon/Sample/Bourland) (Do Pass-ConAd)

Bourland Sec Johnson

Bourland: We had a lot of survey interest and we wanted to clarify it. It is really well written out. You write it and it goes to the committee that it pertains too. Then goes to ConAd, and they will collect it and combine all the surveys and send them to the floor in one piece of legislation to be passed through senate and congress. It is not amendable in the general meetings

Crisp: In the addition of section c., it states that Li does not move into the general body, why don't we ever get to see it?

Aragon: It goes from whatever committee directly to ConAd. For example, from P&P to ConAd directly, and then four weeks before the election they will send a piece of legislation to the floor with all the surveys in them.

Ahmadi: You put it in Title VII, which is the election section. Will it have a heading?

Sample: We put it there because it will pertain to elections, we will need a new heading for the section we are generating.

Witt: Will you accept a friendly amendment making a title called surveys?

Sample: Yes

Ahmadi: If I was a member of GSS and I wanted to start a survey, where does it go?

Aragon: It goes to their internal committee, before heading to our ConAd.

Bourland: Will any senator even write one?

Aragon: One wanted to last semester, which was why we needed to codify.

Ahmadi: This will apply to GSS as well, and they have to follow this process?

Aragon: That is why it is in the Code Annotated

Crisp: Has GSS been contacted, what is their opinion?

Aragon: We reached out to Carrie, the Chair, and she seemed to be in favor.

Bourland: We have a bicameral legislature so we can have our own opinion and so can they. When they see it, we can find out how they feel

Aragon: They can also amend it and then the two bodies can work together to ensure it passes

930105 An Act Amending the Standing Rules (Skelton) (Do Pass-ConAd)

Crisp, sec Johnson

Skelton: The lack of knowledge regarding our governing documents has made our meetings much longer than they needed to be. The Bylaws state that they will expedite the process, and the Chair or their approved agent is in charge of the Standing Rules, and their entire point is to make the process more efficient and if you don't know them you aren't doing your job as a rep. You should already be aware of these documents

Witt: Do you believe it is an incoming rep or associate's job to understand the rules and procedure before coming to the meeting?

Skelton: Not at all, I think there should be some leeway for some questions, so long as it doesn't interrupt with our process

Witt: What do you do if they need to ask several in order to understand what is happening?

Skelton: Bring the Bylaws with them and look at them

Bourland: Does this infringe on a fundamental right to ask questions?

Skelton: Yes, but they can still ask questions

Bourland: Do you consider yourself an expert?

Skelton: No, but I always pull it up to answer those questions

Crisp: Do you think we would be wasting time to keep track of the number of questions that are being asked as well as determining if they apply to those documents?

Skelton: I think someone should keep track

Crisp: Will this waste time?

Skelton: No

Bourland: Who would keep track?

Skelton: I suppose the secretary

Bourland: So she will have to remember and detail and take time to determine that?

Skelton: It will be in the minutes

Aragon: On information they are not in the minutes so they would need to be added

Witt: Would there be any punishment or repercussions if the secretary doesn't notice?

Skelton: We just wouldn't answer

Witt: What if the secretary does not realize there have been three?

Skelton: If it were an issue, we would notice, and if we didn't notice, there would be no repercussion.

Watts: To the best of your recollection, how many times have you seen this happen by asking more than three?

Skelton: Once a month when we have a really long meeting

Watts: Do you think it really adds that much time?

Skelton: Yes

Watts: Would this waste more time than questions we try to stop?

Skelton: No

Crisp: How will this affect those who are just learning the English language and they may not understand?

Skelton: They have the ability to ask whenever they can outside the meeting, and they do have them available to them in order to read them. I would always have information to be prepared.

Crisp: What if they really cannot understand, then what would prohibit their ability to join Congress?

Skelton: They wouldn't be able to read the application, if it were as bad as you make it out to sound

Crisp: What about someone dyslexic, how would three questions affect their handicap disability?

Skelton: If they had a disability to the point of prohibiting their abilities, I think that would be very rare and that they will have a way to cope.

Tran: How would this solve the issue if they can keep asking after we ignore them?

Skelton: We can remove them from the meeting if it becomes an issue

Hueffed: Would this only address the symptoms and could we do better to verse them in the rules rather than punishing them for that lack of knowledge?

Skelton: It isn't a punishment, it just tries to prevent it from slowing down our process

Pae: Why did you write this?

Skelton: There have been times when asking these questions have extended our meetings, even to the point of having thirty minutes of just questions.

CONGRESSIONAL BILL NO. 930106

AS INTRODUCED

An act of procedure Expelling Members
of Congressional Session 93 for excessive
absences; providing for a short title;
stating purpose; and providing an effective date.

Section 1: Title. This act shall be known as “An Act Expelling More Representatives.”

Section 2: Purpose. The purpose of this act shall be to expel a member for excessive absences. Because Kennedie Akinwande have accrued excessive unexcused absences and have failed to petition the Executive Committee for an attendance waiver, and as a result have failed to represent their constituents, the membership of the aforementioned is pending expulsion.

Section 3: In accordance with the Section 3.3 subsection 2 of the SGA Undergraduate Student Congress Bylaws, “*Upon accruing a fourth absence, the Student Congress Secretary shall prepare an act of procedure to expel any member or committee officer who has accrued excessive unexcused absences.*”

Section 4: This act is hereby enacted.

Section 5: This act shall become effective when passed in accordance with the SGA Constitution.

CONGRESSIONAL RESOLUTION NO. 930304

AS INTRODUCED

A Resolution delivering a formal admonition to SGA President Kunal Naik for his inappropriate actions over the Winter Break; and providing for distribution.

- Whereas: Student Government Association President Kunal Naik was arrested for Public Intoxication on the December 27th, 2014; and
- Whereas: There is no evidence that Naik has violated the capacities of his office, nor has he abused the powers of his office; and
- Whereas: Due to the lack of this evidence, this would be an impeachment without grounds; and
- Whereas: The University of Oklahoma student body when polled by the *OU Daily* expressed that the majority opinion was entirely his business and secondly that a statement of censure would seem more appropriate than impeachment; and
- Whereas: The Undergraduate Student Congress does not support the actions of Kunal Naik during Winter Break and does not believe it is appropriate behavior from an elected official;

NOW, THEREFORE, BE IT RESOLVED BY THE UNDERGRADUATE STUDENT CONGRESS THAT:

Section 1: The Undergraduate Student Congress does censure and condemn the actions of Kunal Naik that resulted in his arrest and brought into question the actions of the University of Oklahoma Student Government Association and the integrity of all elected representatives.

CONGRESSIONAL BILL NO. 930104
SENATE BILL NO. GF15-XX

AS INTRODUCED

An SGA Code Annotated amendment establishing a procedure for Survey Legislation; providing for codification;
providing for a short title; and providing an effective date.

BE IT ENACTED BY THE STUDENT GOVERNMENT ASSOCIATION:

Section 1: TITLE: This Amendment shall be known and may be cited as the “Survey Codification Act.”

Section 2: Title VII, Chapter 1, Section 7 of the SGACA shall be created and amended to read as follows:

- a) A member shall author an Act Establishing a Survey, which shall be referred to the appropriate committee based on the subject matter of the survey by the Chair of the body in which it originates.
- b) The bill shall be seen in its appropriate committee, at which point amendments may be made on the piece of legislation as well as a recommendation provided.
- c) So long as the bill does not receive a recommendation of Do Fail in committee, the bill shall then move to the Congressional Administration Committee without reaching the general body or being placed on the General Meeting Agenda, regardless of which body initiates the bill.
- d) Congressional Administration shall see the bill, make any necessary amendments, and will either approve or send the bill back to its originating committee to rework.
- e) After its approval in Congressional Administration, Congressional Administration shall hold the survey until they can combine several surveys into one piece of legislation to be voted on four weeks before elections. The surveys shall take place at the time of the election. This bill shall receive a recommendation from the Congressional Administration Committee and head to the General Meeting Agenda.
- f) This “Act Establishing Surveys for the Election” shall not be amendable in the General Meeting excluding scrivener’s errors. Upon passage, the legislation will be directed to the Graduate Student Senate. Should the legislation fail, the Congressional Administration shall return it to committee in order to revise the legislation so that it shall pass, and shall return the revised version to the General Meeting Agenda.
- g) Should the legislation pass through both bodies, the Election Chair shall ensure all surveys included in the piece of legislation will be conducted at the time of elections for that semester.

Section 3: This act shall become effective, while in accordance with the SGACA, immediately following passage and approval.

CONGRESSIONAL BILL NO. 930105

AS INTRODUCED

A congressional act amending the Standing Rules of Order, providing for a short title, providing for codification, and providing an effective date.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT ASSOCIATION:

Section 1: Title: This act shall be known and may be cited as the “On Information Fixation.”

Section 2: Purpose: The purpose of this act shall be to adjust the rules regarding the definition and use of “On Information” during general meetings in order to assist the Undergraduate Student Congress Bylaws and Standing Rules of Order in fulfilling their purpose to expedite the communication process of general meetings, while also giving further incentive for representatives.

Section 3: AMENDATORY. The following parts are to be amended to Standing Rules of Order, Rule 1, Section 4: For the purpose of the SGA Undergraduate Student Congress meetings, the following definitions shall be regarded as the official definitions for the following items:

...

- On information: Generally a question to the chair, which can be redirected to the appropriate person to answer. “On information” questions regarding the Undergraduate Student Congress Bylaws, Standing Rules of Order, and/or Code Annotated may be limited to a maximum of three questions per member per meeting. Other questions unrelated to the previously stated documents may not be limited.

Section 4: This act shall become effective when passed in accordance with the UOSA Constitution.

BE IT ENACTED BY THE UNIVERSITY OF OKLAHOMA STUDENT GOVERNMENT ASSOCIATION:

Section 1: This act shall be known and may be cited as the “Emergency Allocation Act #2” Act of 2014.

Section 6: All unspent money remaining in the accounts listed in Section 3 shall revert to the SGA General Account after May 4, 2015, and the remaining appropriations shall be canceled.

Section 7: This act shall become effective when passed in accordance with the SGA Constitution.
